# TEXT OF CONSTITUTION OF AMERICAN DENTAL ASSOCIATION

#### Article I Name

- The name of this organization shall be the American Dental Association, hereinafter
- 2 referred to as "the Association" or "this Association."

## Article II Object

- The object of this Association shall be to encourage the improvement of the health of
- 4 the public and to promote the art and science of dentistry.

## Article III Organization

- 5 Section 10. Incorporation: This Association is a non-profit corporation organized
- under the laws of the State of Illinois. If this corporation shall be dissolved at any time, no part of its funds or property shall be distributed to, or among, its members but, after pay-
- ment of all indebtedness of the corporation, its surplus funds and properties shall be used for
- dental education and dental research in such manner as the then governing body of the
- Association may determine.
- Section 20. Central Office: The registered office of this Association shall be known
- as the Central Office and shall be located in the City of Chicago, County of Cook, State of
- 13 Illinois.
- 14 Section 30. Branch Offices: Branch offices of this Association may be established
- in any city of the United States by a majority vote of the House of Delegates.
- Section 40. Membership: The membership of this Association shall consist of dentists
- 17 and other persons whose qualifications and classifications shall be as established in Chapter
- 18 I of the Bylaws.

## **COMPARISON WITH TEXT** OF PRESENT CONSTITUTION

Name

The name of this organization shall be the American Dental Association.

Object

To improve oral and dental health services to the public by cultivating and promoting the art and science of dentistry; by encouraging and providing for dental research; by disseminating among the profession advanced scientific knowledge; by elevating and sustaining the education of dentists in formal institutions of learning, and by establishing devices that provide opportunities for continuing education after graduation; by promoting in the several states the enactment and enforcement of just dental laws, designed to serve the health interests of the people; by enlightening public opinion with respect to the prevention of oral diseases and the care of oral health, as it relates to general health; by directing the procedures and energies of the members of the profession in the interests of public health and welfare. The Association shall have power to acquire property by purchases, deed, gift, bequest or otherwise, to hold and administer the same; and to publish journals, reports and treatises.

Membership

The membership of this Association shall consist of two classes, as follows:

- A. Corporate Membership.-The regularly elected and qualified members of the House of Delegates, as described, constituted and provided for in these bylaws, shall constitute the membership of this Association in its corporate capacity.
- B. General Membership.-The general membership of this Association shall consist of the members of the constituent societies and such members of the Army Dental Corps, of the Navy Dental Corps, of the Public Health Service, of the Veterans Administration, and others as may be elected or appointed in accordance with the Administrative bylaws as hereinafter provided.

The General Membership may be divided into subclasses as provided in Chapter I of the Administrative bylaws.

When the word "member" or "membership" is used in either the Constitutional or Administrative bylaws, there shall be meant the "general membership" of the Association unless it is otherwise specifically stated.

- 19 Section 50. Constituent Societies: Constituent societies of this Association shall be
- 20 those dental societies or dental associations chartered as such in conformity with Chapter II
- 21 of the Bylaws.

- 22 Section 60. Component Societies: Component societies of this Association shall be
- 23 those dental societies or dental associations organized as such in conformity with Chapter III
- 24 of the Bylaws of this Association and in conformity with the bylaws of their respective
- 25 constituent societies.
- 26 Section 70. Trustee Districts: The constituent societies of this Association and the
- 27 federal government dental corps shall be grouped into thirteen (13) trustee districts, as
- 28 provided in Chapter IV of the Bylaws.

#### Article IV Government

- 29 Section 10. Legislative Body: The legislative and governing body of this Association
- 30 shall be the House of Delegates, which may be referred to as "the House" or "this House,"
- 31 as provided in Chapter V of the Bylaws.

#### BYLAWS 11

#### Constituent Societies

Section 1. State and Territorial Societies which have, or which hereafter may become organized in conformity with the general plan of the American Dental Association shall be recognized as constituent societies, upon a majority vote of the Board of Trustees.

The plan of organization of the American Dental Association stipulates that an active member of the American Dental Association must be a member of the constituent society and of the component society if such exists, and cannot be an active member of the constituent society without being a member of the American Dental Association.

- SEC. 2. The term "State Society" shall be understood to mean the representative dental organization of any one of the states which have been received into the Union, and whose active membership is restricted to legal practitioners practicing within the legal borders of such state. The term "Territorial Society" shall apply in similar manner to the representative dental organization of any of the territorial possessions of the United States; provided, however, that the term "Territorial Society" shall be held to include the societies of the District of Columbia, of the Canal Zone, and of the insular possessions of the United States.
- SEC. 3. "All constituent Societies of the American Dental Association shall operate under Constitutions and bylaws that are in harmony with the Constitution and bylaws of the American Dental Association."
- SEC. 4. All state and territorial societies which may be regularly recognized and admitted constituent societies of the National Dental Association, heretofore existing and incorporated under the Laws of the District of Columbia, on the day said former Association may transfer its activities and membership to this Association, shall upon such transfer becoming effective, become and be constituent societies of this Association, with the same rank and standing as that held by them, respectively, on said date in said former Association.

#### Trustee Districts

SEC. 3. One member of the Board of Trustees shall be elected from each of the thirteen districts into which the constituent societies shall be grouped for this purpose as provided for in Chapter VII, Section 2, of the Administrative bylaws.

#### Government

Section 1. There shall be a business body known as the House of Delegates of the American Dental Association. It shall consist of delegates elected by the constituent societies, and by the other dental bodies named in Section 2 of this article. The House of Delegates shall represent the delegated powers of the members of the American Dental Association, and shall be the national representative body of the constituent societies. The legislative powers of the Association reside in the House of Delegates. It shall transact all the business of the Association, public, professional and scientific, not otherwise provided for by these bylaws; and elect the general officers of the Association and thirteen Trustees. The thirteen Trustees elected as such by the House of Delegates and former presidents shall be members of the House of Delegates without the right to yote.

- 32 Section 20. Administrative Body: This Association shall be administered by a Board
- 33 of Trustees which may be referred to as "the Board" or "this Board," as provided in
- 34 Chapter VI of the Bylaws.

## Article V Officers

- 35 Section 10. Elective Officers: The elective officers of this Association shall be a Presi-
- 36 dent, a President-Elect, a First Vice-President, a Second Vice-President, a Third Vice-
- 37 President and a Speaker of the House of Delegates, each of whom shall be elected by the
- 38 House of Delegates as provided in Chapter XII of the Bylaws.
- 39 Section 20. Appointive Officers: The appointive officers of this Association shall be a
- 40 Secretary, a Treasurer and an Editor, each of whom shall be appointed by the Board of
- 41 Trustees as provided in Chapter VIII of the Bylaws.

#### Article VI Sessions

- 42 Section 10. Scientific Sessions: Scientific sessions of this Association shall be conducted
- 43 by the members of the Association as provided in Chapter XIII of the Bylaws.
- 44 Section 20. Business Sessions: Business sessions of this Association shall be conducted
- 45 by the members of the House of Delegates as provided in Chapter V of the Bylaws.

#### Article VII Code of Ethics

- 46 The Code of Ethics of this Association and the codes of ethics of the constituent and
- 47 component societies which are not in conflict with the Code of Ethics of this Association,
- 48 shall govern the professional conduct of all members.

## Article VIII Amendments

- This Constitution may be amended by a two-thirds (2/3) affirmative vote of the members of the House of Delegates, provided that the proposed amendments have been presented
- 51 in writing at any previous session of the House of Delegates.
- This Constitution also may be amended at any session of the House of Delegates by a
- 53 unanimous vote, provided the proposed amendments have been presented in writing at a
- 54 previous meeting of said session.

#### BYLAWS

Administrative Body

SECTION 1. The Board of Trustees shall have charge of the property and of the financial affairs of the Association, including the publication of the dental journal, subject to the approval of a majority vote of the House of Delegates.

#### Officers

SECTION 1. The General Officers of the Association shall be a President, President-Elect, First, Second and Third Vice-President, a general Secretary and a Treasurer.

SEC. 2. The officers with the exception of the General Secretary, shall be elected annually, by the House of Delegates to serve for one year or until their successors shall have been elected and installed. The General Secretary shall be nominated by the Board of Trustees for a specified term and elected by the House of Delegates.

#### Sessions

The American Dental Association shall hold an annual meeting at the time and place chosen by the House of Delegates. The time and place for the meeting, however, may be changed by a two-thirds vote of the Board of Trustees, but not later than sixty days prior to the time selected for the meeting.

#### **Amendments**

The House of Delegates may amend or alter these Constitutional bylaws at any annual meeting, due notice having been given at a previous session of said annual meeting, provided unanimous consent is obtained. Otherwise, all amendments must lie on the table until the annual meeting next following their introduction, at which time a two-third vote will be required for their adoption. In the latter procedure due notice of the proposed changes, in substance or, if not too lengthy, in the exact wording, must be sent to each member of the House of Delegates with the regular notice of the annual meeting.

# TEXT OF REVISED BYLAWS OF THE AMERICAN DENTAL ASSOCIATION

## Chapter I Membership

- 55 Section 10. Classification: The members of this Association shall be classified as follows:
- 56 Active members
- 57 Life members
- 58 Affiliate members
- 59 Student members
- 60 Honorary members
- 61 Associate members
- 62 Section 20. Qualifications:
- 63 A. Active Member. Any dentist licensed to practice in any one of the states, districts,
- 64 territories or dependencies of the United States who is a member in good standing of this
- 65 Association and a member in good standing of one of its constituent societies and a com-
- 66 ponent thereof if such exists, or any dentist who is a member in good standing of this
- 67 Association and who is licensed to practice in a territory or a dependency of the United
- 68 States in which no constituent society has been chartered, or any dentist who is a member
- 69 in good standing of this Association and who is a member of a federal government dental
- 70 corps, shall be classified as an active member of this Association.
- 71 B. Life Member. A dentist who has been an active member of this Association in good
- 2 standing for thirty-five (35) years, having attained the age of sixty-five (65) years, may be
- 3 classified as a life member of this Association. Recommendations for life membership shall
- 14 be made by the Board of Trustees and acted upon by the House of Delegates. A member
- 5 who is elected a life member of this Association must pay dues and fees to his constituent
- 76 or component society unless such dues or fees are waived.

# COMPARISON WITH TEXT OF PRESENT BYLAWS OF AMERICAN DENTAL ASSOCIATION

Active Member

SECTION 1. Active Members.—The presentation of a properly certified roster of members in good standing of a constituent society, together with the annual dues, shall establish the full membership of each member thereof as a member of this Association.

SEC. 2. Citizens of the United States residing in and practicing dentistry in foreign countries may become active members of this Association with the approval of the Board of Trustees and the House of Delegates.

Life Member

SEC. 12. A member of the American Dental Association who is made an honorary or life member of his constituent society or is connected with his constituent society in an equivalent manner, whereby he is relieved from the payment of dues or fees, on the request of his constituent society may be made a life member of the American Dental Association by a majority vote of the House of Delegates of this Association. No life member of a constituent society shall be eligible for election as a life member until he shall have attained the age of 65 years and shall have paid dues in the American Dental Association for 25 years. A life member shall have all the rights and privileges of an active member. He shall not be required to pay dues in the American Dental Association.

#### Affiliate Member

SEC. 8. Pan-American Membership.—There shall be established in the American Dental Association a membership known as Pan-American membership. All dentists practicing in the countries of the Americas, exclusive of the United States, its territorial and insular possessions, providing they are members in good standing in their respective national dental societies, may be eligible to membership.

Application for such membership shall be accompanied by certification from the secretary of the national dental organization in which the applicant holds membership, together with dues of \$5.00.

These members shall receive a Pan-American membership card and the Journal of the American Dental Association, also a copy of the Annual Meeting Program and the privilege of attending the scientific sessions.

<sup>77</sup> C. Affiliate Member. An ethical dentist practicing in any country other than the United
78 States who is a member of a recognized dental organization in such country may file with
79 the Council on Membership of this Association an application for affiliate membership,
80 which shall be referred with the Council's recommendation to the House of Delegates for
81 action. If elected, on payment of dues as provided in Chapter XV of these By-Laws, he
82 shall be classified as an affiliate member of this Association.

- 83 D. Student Member. Any undergraduate of a dental school accredited by this Association,
- 84 who has been recommended by the dean of such dental school or by his appointed representa-
- 85 tive, or any graduate who, immediately after graduation, takes up an internship, residency or
- 86 graduate work, on the payment of dues as provided in Chapter XV of these Bylaws, shall be
- 87 classified as a student member of this Association. In order to become an active member of this
- 88 Association, a student member must make application to a constituent or component society.

- 89 E. Honorary Member. Any individual who has contributed materially to the advancement 90 of the art and science of dentistry and who has been elected by the House of Delegates
- 91 on the nomination of the Board of Trustees, shall be classified as an honorary member of
- 92 this Association.

93 F. Associate Member. Any member of an allied profession who contributes to the advance 94 ment of dentistry may be classified as an associate member. Recommendations for associate
 95 membership shall be made by the Board of Trustees and acted upon by the House of Delegates.

#### BYLAWS

#### Undergraduate Member

SEC. 7. Junior Members.—There shall be established in the American Dental Association a membership known as "Junior Membership." This membership shall in no way conflict with the executive or scientific privileges of the American Dental Association and shall carry with it no voting power. Students of reputable dental colleges or dental departments of universities, members of the sophomore, junior and senior classes, shall be eligible for Junior Membership under the following conditions: They shall be of good moral character and have a satisfactory scholastic standing; they shall be selected by the faculty council or executive committee of the faculty from an eligibility list recommended by the Dean of their respective dental schools.

The Secretary of the American Dental Association shall request annually the Deans of the various dental colleges to report the names of those who are Junior Members in their institutions as well as the names of those students who have been newly elected to Junior Membership. The Secretary shall record these names and addresses as part of the official records in the central office of the American Dental Association.

The Secretary of the American Dental Association shall request the several constituent and component societies to extend the privileges of their meetings and furnish Journals to Junior Members when requested.

DUES—The annual dues for Junior Membership shall be three dollars (\$3.00). Two and one-half dollars (\$2.50) of which shall be allocated to the Journal Fund of the American Dental Association, the balance to the General Treasury. The fiscal year for Junior Members shall run from October 1st to September 30th.

PRIVILEGES—Each member shall receive a Junior Membership card, the Journal of the American Dental Association, a copy of the annual events program, and shall be privileged to attend the meetings of the American Dental Association.

ORGANIZATION.—The membership of each college or dental department in any university shall be entitled to form from among its membership, an associate organization, known as an Associate Junior Society.

The Associate Junior Society will take its name from the college or dental department of the university with which the Junior Society is associated.

Associate Junior Societies shall have the privilege of adopting bylaws for the government of their individual activities not in conflict with the bylaws of the American Dental Association and such bylaws must have the approval of the Board of Trustees.

## Honorary Member

SEC. 5. Honorary Members.—Dentists who have arisen to preeminence in foreign countries shall be eligible to honorary membership. Honorary members may also be elected from among those who have risen to preeminence in the practice of or research in professions kindred to dentistry or in other branches of science, or from those who through their benefactions have contributed toward the promotion of dental practice or oral health. They may be elected by the House of Delegates on nomination by a section or the Board of Trustees, but not more than three shall be elected to Honorary Membership in any one year.

#### Associate Member

Sec. 6. Associate Members.—Associate membership may be granted by the House of Delegates to distinguished visitors. Such membership accords all privileges for one year, including subscription to The Journal of the American Dental Association.

- Section 30. In Good Standing: Any member of this Association who is not under final sen-

- shall be considered a member in good standing.

#### 101 Section 40. Privileges:

- 102 A. Active Member, a. An active member in good standing shall receive annually a certificate of
- membership and The Journal of the American Dental Association, the subscription price of
- which shall be included in the annual dues. He shall be entitled also to admission to any scien-
- tific session of this Association and to such other services as are provided by the Association. 105
- b. An active member in good standing shall be eligible for election as a delegate or

- 109 B. Life Member. A life member in good standing shall receive a certificate of life member-

- Affiliate Member. An affiliate member in good standing shall receive annually a certifi-

- admission to any scientific session of this Association and to such other services as are
- provided by the Association.
- 117 D. Student Member. A student member in good standing shall receive annually a member-

- 120 E. Honorary Member. An honorary member shall receive a certificate of honorary mem-

- 124 Associate Member. An associate member in good standing shall receive annually a

- 129 G. Right of Hearing. Any member who is charged (1) with having been found guilty of a

- H. Right of Appeal. An accused member shall have the right to appeal from a decision
- of his component society to the constituent society by filing an appeal in affidavit form

- society concerned, shall have the right to appeal from a decision of a constituent society
- to the Judicial Council of this Association by filing an appeal in affidavit form with the
- chairman of the Judicial Council. An accused member, the constituent society concerned
- or the component society concerned shall have the right to appeal from a decision of the
- 141 Judicial Council of this Association to the House of Delegates by filing an appeal in affidavit
- 142 form with the Secretary of the House of Delegates.
- An appeal from any decision shall not be valid unless filed within thirty (30) days
- after such decision has been rendered. No decision shall become final while an appeal 144
- 145 therefrom is pending.

#### Right of Hearing and Appeal

If a member of the American Dental Association shall have been accused of a violation of the Bylaws, transgression of the Code of Ethics, or any coduct deemed unprofessional, and if he has been adjudged guilty by his local society and the penalty imposed shall impair his membership in the American Dental Society, he may then file an appeal with the constituent state society of which his local society is an affiliate, provided such appeal in affidavit is filed with the secretary of the state society within thirty days after the accused member has been found guilty and has received official notice of the decision and the penalty imposed. If the constituent state society shall concur in the findings of the local society and shall affirm the penalty imposed and the member feels that justice has not been done him, he shall have recourse by an appeal to the Judicial Council of the American Dental Association, provided such an appeal in affidavit form is filed with the Chairman of the Judicial Council within thirty days after the accused member has been notified of the action taken by the constituent state society. If upon an appeal of a member of a local society to the state society, the decision of the local society shall be reversed, then the local society shall be privileged to appeal to the Judicial Council.

If either of the parties to the above action is dissatisfied with the decision of the Judicial Council, they or either one of them may appeal to the House of Delegates, provided such appeal is filed, in affidavit form, with the Secretary of the American Dental Association within thirty days after having received official notice of the decision of the Judicial Council.

No penalty impairing the membership of a member of the American Dental Association shall become effective until all means of appeal, as herein provided, shall have been exhausted.

The term "Territorial Society" shall apply in similar manner to the representative dental organization of any of the territorial possessions of the United States; provided, however, that the term "Territorial Society" shall be held to include the societies of the District of Columbia, of the Canal Zone, and of the insular possessions of the United States.
- SEC. 3. "All constituent Societies of the American Dental Association shall operate under Constitutions and Bylaws that are in harmony with the Constitution and Bylaws of the American Dental Association."
- SEC. 4. All state and territorial societies which may be regularly recognized and admitted constituent societies of the National Dental Association, heretofore existing and incorporated under the Laws of the District of Columbia, on the day said former Association may transfer its activities and membership to this Association, shall upon such transfer becoming effective, become and be constituent societies of this Association, with the same rank and standing as that held by them, respectively, on said date in said former Association.

191 Section 90. Privilege of Representation: Each constituent society shall have the privilege of representation in the House of Delegates of this Association by one or more fully-192 privileged members of such society who are selected to serve as officially certified delegates 194 according to the following formula: one (1) delegate for twenty-five (25) through ninetynine (99) members classified as active or life members of this Association, one (1) additional 195 delegate for the next two hundred (200) such members or fraction thereof; one (1) addi-196 tional delegate for each additional two hundred (200) such members. 197 Each constituent society may select from among its fully-privileged members the same 199 number of alternate delegates as delegates. An alternate delegate may act in the absence of a delegate at any meeting of the House of Delegates. Each constituent society shall have the privilege of determining the alternate delegate who shall be substituted for an absent delegate from that constituent society. Section 100. Chartered Constituent Societies: The Secretary of the Association is authorized to issue a charter, in a form approved by the Board of Trustees, to each con-205 stituent society denoting its name and territorial jurisdiction. ## Chapter III Component Societies

Section 10. Organization: Component societies may be organized in conformity with a plan approved by the constituent society of which they shall be recognized entities provided, however, that the fully-privileged members of each component society shall consist of dentists who are members in good standing of their respective constituent societies and of this Association. Each component society shall adopt and maintain a constitution and Bylaws, which shall not be in conflict with the Constitution and Bylaws of this Association, and shall file a copy thereof and any changes which may be made thereafter with the Secretary of this Association.

## Section 20. Powers and Duties:

- 269 A. A component society shall have the power to elect its members and to elect its fully-
- 270 privileged members as fully-privileged members of the constituent society, within the limits
- 271 imposed by Chapter II, Section 40, of these Bylaws.
- 272 B. It shall have the power to make laws, rules and regulations, not in conflict with the Bylaws

- 276 C. It shall have the power to discipline any of its members by censure, probation, suspension
- 277 or expulsion for having been found guilty of a felony; for having been found guilty of
- 278 violating the dental practice act of a state, district, territory or dependency; for violating
- 79 these Bylaws or the Code of Ethics of this Association subject to the provisions in Chapter I,
- 280 Section 40, G and H, of these Bylaws.
- 281 D. It shall be its duty to collect membership dues for this Association in conformity with
- 282 Chapter XV, Section 10, of these Bylaws.

## Chapter V House of Delegates

Utah State Dental Association

Section 10. Composition: The House of Delegates shall be composed of the officially certified delegates of each constituent society and one (1) officially certified delegate from each of the federal government dental corps which is not organized into a constituent society of this Association. The elective officers, the voting members of the Board of Trustees and the past-presidents of this Association shall be ex officio members of the House of Delegates without the power to vote unless duly selected as delegates of their respective constituent societies or federal government dental corps.

Section 20. Certification of Delegates and Alternate Delegates: The secretary of each constituent society and the ranking administrative dental officer of each federal government dental corps shall file with the Secretary of this Association, at least sixty (60) days prior to the first day of the annual session of the House of Delegates, the names of delegates and alternate delegates duly selected by his society or corps. The Secretary of this

House of Delegates

Section 1. There shall be a business body known as the House of Delegates of the American Dental Association. It shall consist of delegates elected by the constituent societies, and by the other dental bodies named in Section 2 of this article. The House of Delegates shall represent the delegated powers of the members of the American Dental Association, and shall be the national representative body of the constituent societies. The legislative powers of the Association reside in the House of Delegates. It shall transact all the business of the Association, public, professional and scientific, not otherwise provided for by these Bylaws; and elect the general officers of the Association and thirteen Trustees. The thirteen Trustees elected as such by the House of Delegates and former presidents shall be members of the House of Delegates without the right to vote, providing that officers, trustees and former Presidents, when elected delegates by their constituent societies, shall enjoy the full privileges and rights as delegates from such constituent societies.

SEC. 2. The total voting membership in the House of Delegates, exclusive of the Board of Trustees, shall be as follows: One delegate each shall be allowed from the Army Dental Corps,

- 371 D. It shall have the power to enact, amend and repeal the Constitution and Bylaws of the

- 373 E. It shall have the power to adopt and amend the Code of Ethics for governing the
- 374 professional conduct of the members of this Association.
- 375 F. It shall have the power to grant, amend or revoke charters of constituent societies.
- 376 G. It shall have the power to elect life, affiliate, honorary and associate members of the
- 377 Association.
- 178 H. It shall have the power to create special committees of the Association.
- 379 I. It shall have the power to establish branch offices of the Association.
- 380 J. It shall have the power to approve all memorials, resolutions or opinions in the name
- 381 of the American Dental Association.
- Section 40. Duties: It shall be the duty of the House of Delegates:
- 383 A. To elect the elective officers.
- 384 B. To elect the members of the Board of Trustees.
- 85 C. To elect the members of the Association's councils and advisory committees.
- 386 D. To select the place for the annual session of the House of Delegates and the annual
- 387 scientific session
- 388 E. To adopt an annual budget.
- 389 F. To serve as the court of appeal from a decision of the Judicial Council on any dis-
- 390 ciplinary action taken against any member of this Association.
- 391 Section 50. Transfer of Powers and Duties of the House of Delegates: The powers
- 392 and duties of the House of Delegates referred to in Sections 30 and 40 of this Chapter,
- 393 except the power to amend, enact and repeal the Constitution and Bylaws of this Association
- 394 and the duty of electing the elective officers and the members of the Board, may be trans-
- 395 ferred to, and assumed by, the Board of Trustees of this Association in time of extraordinary
- 396 emergency. The existence of a time of extraordinary emergency shall be determined by
- 397 mail vote of the last House of Delegates on recommendation of at least five (5) of the
- 398 elective and appointive officers. A mail vote to be valid shall consist of ballots received from
- not less than one-fourth (1/4) of the members of said House of Delegates. A majority of the
- 400 votes cast within thirty (30) days after the posting of the ballot shall decide such vote.

from the Navy Dental Corps, from the Public Health Service, from the Veterans Administration, and one from each constituent society. Each constituent society shall be entitled to one additional delegate if one hundred of its members become regularly enrolled as members of the American Dental Association; and to one more delegate for each additional two hundred members enrolled.

Explanatory: Regardless of enrollment in the American Dental Association each constituent society would have one delegate.

- With 100 members in the American, two delegates.
- With 300 members in the American, three delegates.
- With 500 members in the American, four delegates.
- With 700 members in the American, five delegates.
- With 900 members in the American, six delegates.
- With 1,100 members in the American, seven delegates.
- With 1,300 members in the American, eight delegates.
- With 1,500 members in the American, nine delegates.

In case any state does not affiliate, all members of the American Dental Association residing in such state may meet together at the first session of any meeting of this Association, and elect one delegate to represent them in the House of Delegates.

SEC. 3. In those states or territories in which more than one society is recognized as a constituent, the total number of delegates from such state or territory shall be computed on the total number of members enrolled in the American Dental Association from such state or territory, or District of Columbia, and the number of delegates from each constituent society in such state or territory shall be in proportion to the membership in each.

SECTION 1. No one shall serve as a member of the House of Delegates who is not a member of this Association.

- SEC. 2. Delegates and Alternates from the Army Dental Corps, the Navy Dental Corps, the Public Health Service, and the Veterans Administration shall be elected according to Rules which are to be formulated by the members of these services.
- SEC. 3. The number of delegates to which each constituent society may be entitled shall be based on the number of members from whom dues for the current year shall have been received by the General Secretary of this Association at least thirty days prior to the first day of the annual meeting of this Association.
- SEC. 4. In the cases of those constituent societies which do not hold meetings of the current year at least forty-five days prior to the annual meeting of this Association, the number of delegates shall be estimated on the dues for the previous year received by the General Secretary of this Association.
- SEC. 5. To be represented in the House of Delegates the officers of each constituent society shall file with the General Secretary of this Association, at least thirty days prior to the first day of the annual meeting, a list of the names of its delegates and alternates.
- SEC. 6. Previous to the annual meeting, the General Secretary of this Association shall prepare and have printed a list of the delegates and alternates elected by the various constituent societies; also the number of paid members of each. In case any society has elected more delegates than the number to which its paid membership shows it to be entitled, the General Secretary, in preparing the list, shall drop one or more names from the list of such society, beginning at the bottom of the list, until the proper number of names remain.
- SEC. 7. At any election of delegates, the body electing may at the same time elect as many alternates as delegates, and the alternate of each delegate may act in the absence of the regular delegate from any annual meeting, except as provided in Section 9 of this chapter.
- SEC. 8. Every delegate must present his credentials and be duly registered by the general secretary, or other designated officer or committee before taking part in the business of the House of Delegates. Credentials shall include a certificate duly signed by the proper officials of the body

- Section 60. Annual Sessions: The House of Delegates shall convene annually. Whenever
- annual scientific sessions are to be held, such annual session of the House of Delegates
- shall convene not less than one (1) day nor more than three (3) days, as determined by
- the Board of Trustees, preceding the opening of, and in the same city as, the annual
- scientific session of this Association. The House shall meet each day thereafter until
- adjournment sine die, except that recesses may be taken for not longer than a forty-eight

The credentials of a delegate having been accepted and his name placed on the roll of the House of Delegates, he shall remain the duly accredited delegate of the body which he represents until final adjournment of the meeting, provided that when an accredited delegate finds it impossible to continue his service, his regularly selected alternate shall be entitled to be seated. In the absence of the regular alternate, such vacancy shall be filled by the delegates from such state, from the alternates present.

Sec. 10. If at the second session of the House of Delegates it be found that there are not enough regular and alternate delegates to fill the quota of any constituent society the members of such society may meet and elect from members in attendance a sufficient number to represent them in the House of Delegates until such time as other regular or alternate delegates may arrive.

#### Annual Sessions

Section 1. The House of Delegates shall meet annually on the day preceding the opening of, and at the same place as the annual meeting of the Association.

#### Special Sessions

SEC. 2. Special meetings of the House of Delegates shall be called by the President, on written request of a sufficient number of delegates to represent a majority of the constituent societies, by a written or printed notice mailed to the last known address of each delegate, at least twentyfive days before such special meeting is to be held, in which shall be specified the time and place of meeting and in general terms the objects of such special meeting, and no other business shall be transacted thereat. The time and place for the special meeting must be given in the requests signed by the delegates.

Resolved: That the President may appoint a Speaker of the House of Delegates to be approved by the House of Delegates. The Speaker shall perform such duties as are assigned to the office by Parliamentary Law, not otherwise conflicting with the Constitutional and Administrative Bylaws.

#### 136 B. Duties:

- 537 Section 10. Composition: The Board of Trustees shall consist of one (1) trustee from
- 538 each of the thirteen (13) trustee districts. Such thirteen (13) trustees shall constitute the
- 539 voting membership of the Board. In addition, the elective and appointive officers of the
- 540 Association except as otherwise provided in these Bylaws shall be ex officio members with-
- 541 out the right to vote.
- 542 Section 20. Qualifications: A trustee must be an active or life member, in good standing,
- 543 of this Association and a fully-privileged member of one of the constituent societies which
- 544 compose the trustee district he is elected to represent. Should the status of any trustee change
- 545 in regard to the preceding qualifications during his term of office, that office shall be declared
- 546 vacant and the President shall proceed to fill such vacancy as provided in Chapter VI,
- 547 Section 70, of these Bylaws.
- 548 Section 30. Term of Office: The Trustees shall be divided into three groups of four (4),
- 549 four (4) and five (5) respectively, each group to serve for a period of three (3) years.
- 550 One group shall be elected annually.
- 551 Section 40. Nomination: At each annual session of the House of Delegates, the delegates
- 552 from the constituent societies in each trustee district in which the term of office of the trustee
- 553 is about to expire shall hold a caucus for the purpose of selecting a nominee or nominees
- 554 for the office of trustee. Such caucus, in each case, shall be called by the trustee whose term
- 555 is about to expire, or by some delegate from the district appointed by the President of the
- 556 Association if such trustee is absent. The notice of the time and place of such caucus shall
- 557 be reported to the secretary of the House who shall announce same to the House at a
- 558 convenient time.
  - At such caucus, the delegates shall nominate one (1) or more candidates for the office of trustee, whose name or names shall be presented to the House at the proper time. Such
- 561 nominations shall be made on the morning of the second day in accordance with the follow-
- 562 ing rules:
- 563 A. A person receiving the unanimous vote of the delegates present and voting shall be the
- only nominee of the district, and the name of such nominee shall be presented to the House
- as the only nominee of that district.
- In the event that one (1) candidate receives a majority vote, one (1) or more of the
- delegates voting in the minority may select other nominees and the names of such nominees
- 568 shall be presented to the House as the nominees of that district.
- In all cases, the number of votes received by each nominee in the caucus shall be reported to the House.
- 571 B. A nominating speech of two minutes shall be allowed in the House in behalf of each
- 572 nominee. Seconding speeches for any nominees shall be limited to one (1) minute in length
- 573 and two (2) in number.

## Composition

In addition to the thirteen elected members of the Board of Trustees, the President, President-Elect, General Secretary and Treasurer, shall be ex-officio members of the Board of Trustees without the right to vote except in case of tie, the President shall have the deciding vote. They shall hold the same position in the Board as in the Association.

#### Term of Office

SEC. 2. The Trustees shall be divided into three groups of four, four, and five respectively, each group to serve for a period of three years. One group shall be elected annually.

## Nomination and Election

At such meeting the delegates shall nominate one or more candidates for the office of trustee, whose name or names shall be presented to the House of Delegates. Nominations shall be made under the following rules: In case one member receives the unanimous vote of the delegates of the district for the particular office, the one name only shall be presented to the House of Delegates as the nominee of the district. In case one member receives a majority vote, the minority delegates may select a second nominee. In case no one member receives a majority vote, after two ballots have been cast, the members receiving the highest, next highest and third highest vote shall be the nominees from such district. The names of the nominees shall be handed to the General Secretary, together with the vote which each nominee received, and both the names and the vote shall be announced to the House of Delegates by the General Secretary.

A nominating speech of two minutes may be allowed in behalf of each nominee.

SEC. 3. All elections shall be by ballot (except as hereinafter provided), and a majority of the votes cast shall be necessary to elect. In case no nominee receives a majority of the votes on the first ballot the nominee receiving the least number of votes shall be dropped and a new ballot held. This procedure shall be continued until one of the nominees receives a majority of all votes cast, when he shall be declared elected; however, if there be only one nominee the House of Delegates may empower one vote to be cast for the election of the nominee.

- 574 Section 50. Election: The trustee shall be elected by the House according to the follow-
- 575 ing rules
- 576 A. If there is only one (1) nominee from a trustee district, the chairman shall declare such
- 577 nominee elected.
- 578 B. If there is more than one (1) nominee from a trustee district, the election shall be by
- 579 ballot in accordance with Chapter XII, Section 10. The person receiving the largest number
- 580 of votes cast shall be declared elected.
- 581 Section 60. Installation: The trustees shall be installed by the President or someone
- 582 delegated by him at the time scheduled in the order of business.
- 583 Section 70. Vacancy: In the event of a vacancy in the office of a trustee, the President
- 584 shall appoint a qualified member of the constituent society in the trustee district in which
- 585 the vacancy occurs to fill such office until a successor is elected by the next House of Delegates
- 586 for the remainder of the unexpired term.
- 587 Section 80. Powers:
- 588 A. The Board shall be the managing body of the Association, vested with full power to
- 589 conduct all business of the Association, subject to the laws of the State of Illinois, the
- 590 Articles of Incorporation, the Constitution and Bylaws and the mandates of the House of
- 591 Delegates.
- 592 B. It shall have the power to establish rules and regulations not inconsistent with these
- 593 Bylaws to govern its organization, procedure and conduct.
- 594 C. It shall have the power to direct the President to call a special session of the House of
- 595 Delegates as provided in Chapter V, Section 70, of the Bylaws.
- 596 D. It shall have the power to nominate to the House of Delegates candidates for honorary
- 597 membership or for the honorary award of this Association.
- 598 E. It shall have full discretionary power to cause to be published in, or to be omitted
- 599 from, any official publication of the Association any article in whole or in part, except the
- 600 editorials written or approved by the Editor.
- 601 It shall have the power to establish ad interim policies when the House of Delegates is
- 602 not in session and when such policies are essential to the management of the Association,
- 603 provided, however, that all such policies must be presented for review at the next session of
- 604 the House of Delegates.
- 605 Section 90. Duties. It shall be the duty of the Board of Trustees:
- 606 A. To provide for the maintenance and supervision of the Central Office and all other
- property or offices owned or operated by this Association.
- 608 B. To appoint qualified members of the Association to the offices of Secretary, Treasurer
- 609 and Editor, respectively.
- 610 C. To determine the time for convening each annual session of the House of Delegates
- 611 within the limits set forth in Chapter V, Section 60, of these Bylaws.
- 612 D. To cause to be bonded by a reliable surety company any appointive officer or employee
- 613 of the Association entrusted with Association funds for whatever amount deemed necessary.
- 614 E. To cause to be audited by a reputable auditor all accounts of the Association at least
- 616 F. To prepare a budget for carrying on the activities of the Association for each ensuing
- 618 G. To provide for the publication and distribution of all official publications of the
- 619 Association.620 H. To cause to be distributed to the secretary of each constituent society and component
- 621 thereof all approved plans for increasing the principal of the Relief Fund of this Association

**Powers and Duties** 

SECTION 1. The Board of Trustees shall have charge of all properties and of the financial affairs and all monies receivable by the Association shall be disbursed under the direct supervision of the Board of Trustees of the Association, subject to the approval of a majority vote of the House of Delegates. At the first meeting of the Board after the annual meeting of the Association it shall organize.

SEC. 2. Journal.—It shall be the duty of the Board of Trustees to provide for and superintend the publication of The Journal of the American Dental Association, and of all proceedings, transactions and Memoirs of the Association, and such other publications as may be authorized, subject to the approval of the House of Delegates. It shall have full discretionary power to omit from The Journal of the American Dental Association in part or in whole, any paper that may be referred to it by any of the sections. It shall appoint a business manager and an editor of The Journal, which two positions may be held by one person, and such assistants as may be necessary, and shall determine the terms and conditions of their employment subject to the approval of the House of Delegates.

SEC. 4. Board Reports.—The Board of Trustees shall have the accounts of the Treasurer and of The Journal office audited annually, or oftener if deemed necessary, and shall make an annual report on the same to the House of Delegates, which report shall also specify the character and cost of all publications of the Association during the year and the amount of all property belonging to the Association. The books of the Association shall be closed at the close of business on the 30th day of June of each year, when they shall be audited without delay and the report transmitted to the officers of the Association and the Board of Trustees within thirty days.

- those of the appointive officers of the Association.
- 637 O. To recommend to the House of Delegates suitable places for annual sessions.
- 638 P. To recommend to the House of Delegates nominees for life and associate memberships.
- 639 Q. To perform such other duties as are prescribed by these Bylaws.

#### 640 Section 100. Sessions:

- 641 A. Regular Sessions. There shall be three regular sessions of the Board each year:
  - a. Immediately after the close of each annual session of the House of Delegates.
- b. During the months of January, February or March, as may be determined by the Board.
- c. Immediately before and during each annual session of the House of Delegates. This
- 645 session shall continue until adjournment sine die of the House but may be recessed from
- 646 time to time.

- 647 B. Special Sessions. Special sessions of the Board may be called at any time by the
- 648 President. He shall call such sessions on request of five (5) members of the Board, provided
- that due notice of any such session is given to each member of the Board at least ten (10)
- 650 days in advance of the time scheduled for holding such session. No other business shall be
- 651 considered except that provided in the call unless unanimous consent is obtained from the
- 652 members present and voting.
- 653 Section 110. Quorum: A majority of the voting members of the Board of Trustees shall
- 654 constitute a quorum for the transaction of business at any session.

#### 655 Section 120. Officers:

- 656 A. Number and Title. The officers of the Board of Trustees shall be a chairman and a
- 657 secretary. The President of this Association shall be the chairman, and the Secretary of this
- 658 Association shall be the secretary.
- 659 In the absence of the President, the office of chairman shall be filled by one of the Vice-
- 660 Presidents, and in the event of the absence of all of the Vice-Presidents, a voting member of
- 661 the Board shall be elected to serve as chairman pro tem.
- In the absence of the Secretary, the Chairman shall appoint a secretary pro tem.

## Regular Sessions

- SEC. 7. Regular Meetings of Board.—Regular meetings of the Board of Trustees shall be held immediately after the annual meeting of the Association and at the same place, and on the first Monday in the month of February, of each year, at such place as the Board may select at its first meeting.
- SEC. 3. Sessions During Annual Meetings.—During the annual meetings of the Association, the Board shall hold sessions as often as may be deemed necessary by the President, and all matters referred to it by the House of Delegates shall be reported on within twenty-four hours, if so ordered by the House.

#### Special Sessions

SEC. 8. Special Meetings of Board.—Special meetings of the Board of Trustees may be called at any time by the President or by request of five members of the Board, due notice of which must be given to each member of the Board at least five days in advance of the meeting. The general object of a special meeting must be stated in the notice, and no other business may be transacted.

a. *Chairman*. The chairman shall preside at all meetings of the Board, cast the deciding vote in the case of a tie and perform such other duties as custom and parliamentary usage require.

He may utilize the counsel and advice of a professional parliamentarian when a question of order arises provided, however, that the decision of the chairman shall be final unless an appeal from such decision is made by a member of the Board, in which case final decision shall be by a majority vote of the trustees present and voting.

b. Secretary. The secretary shall serve as the recording officer of the Board and as the custodian of its records. He shall utilize the services of a professional recorder for the purpose of obtaining a stenographic record of the proceedings of the Board and shall cause a factual record of such proceedings to be edited and published as the official transactions of the Board. He shall serve as the reading clerk of the Board but may designate an assistant to perform this duty.

Duties

SECTION 1. President.—The President shall preside at the general session and at the sessions of the House of Delegates and shall perform such duties as custom and parliamentary usage require. On the morning of the first day of the annual meeting following his election he shall deliver an address at the general session not exceeding forty minutes in length.

The President shall make a report to the House of Delegates at the first session of the annual meeting. In the event of the death, resignation, removal from a district or election to another office of a Trustee, the President shall have authority to fill such vacancy by the appointment of a person from the district where the vacancy occurs, to serve until a successor is chosen at the next annual meeting.

- SEC. 2. President-Elect.—The President-Elect shall assist the President and becomes an ex-officio member of such committees as do the President and Secretary. In case of the death, resignation or removal of the President, he shall succeed to this office. At the installation of officers at the next annual meeting following that at which he was elected President-Elect, he shall become and assume the office of President of this Association without other election. He shall make an annual report to the House of Delegates on the pertinent activities of the Board of Trustees that should be brought before the House of Delegates.
- SEC. 3. Vice-Presidents.—The Vice-Presidents shall assist the President. During his absence or at his request, one of them shall officiate in his place. The First Vice-President shall succeed to the office of President in case the offices of President and President-Elect should both be vacated from any cause in the same year.

SEC. 4. General Secretary.—The Secretary shall be the executive head of the Central Office. He shall coordinate all professional activities of the American Dental Association, and implement all public and professional relations.

The Secretary shall give due notice of the time and place of all annual and special meetings of the Association and of the House of Delegates by publishing the same in The Journal of the American Dental Association, and that special meetings of the House of Delegates shall be given notice in conformity with Chapter VI, Section 2. He shall publish in The Journal of the American Dental Association at the earliest possible time prior to the date of the annual meeting all data pertaining to the meeting of interest to the members of this Association. It shall be his duty to verify the credentials of members of the House of Delegates and to provide a registration book for them, in which shall be recorded the name of each delegate in attendance at each session. He shall collect all dues and transmit the same to the Treasurer, as may be directed by the Board of Trustees. He shall keep in separate books the minutes of the general meetings and of the House of Delegates. He shall prepare a roll of the delegates attending each session to facilitate voting by roll call. He shall prepare for publication the official program of each meeting, and shall perform such other duties as may be directed by the Association or by the House of Delegates, and shall receive a salary to be fixed by the Board of Trustees.

SEC. 5. Treasurer.—The Treasurer shall be the custodian of all monies, securities and deeds belonging to the Association, and shall hold the same, subject to the direction of the Board of Trustees. He shall give to the Board of Trustees, a suitable bond, and shall receive a salary to be fixed by the Board of Trustees.

#### Council on Dental Education

- SECTION 3. Council on Dental Education (Successor to The Dental Educational Council of America).—1. The Council on Dental Education shall be a standing committee composed of nine members as follows:
- (a) Three members shall be nominated by the Board of Trustees of the American Dental Association and elected by the House of Delegates, who are not directly or indirectly connected with a dental school or a member of a state examining board.
- (b) Three members shall be elected by the National Association of Dental Examiners from the membership of this body who are not connected directly or indirectly with any dental school.
- (c) Three members of professorial rank shall be elected by the American Association of Dental Schools from the membership of this body who are not members of any state examining board.
- (d) All members of each of these groups shall serve for three years, provided, that at the first election following the adoption of this report one member of each group shall be elected for one year, one for two years, and one for three years.
- (e) When the term of office of a member of any of these three groups expires or terminates for any reason more than ninety days previous to the annual meeting of the organization represented by the retiring member, the president of such organization shall fill the vacancy until the next annual meeting.
- 2. The Council on Dental Education shall have full authority to appoint committees or advisors for any purpose within the jurisdiction of the Council, provided, however, that if such appointments involve the expenditure of funds of the American Dental Association they must be ratified by the Board of Trustees of the American Dental Association.

#### National Board of Dental Examiners

- SEC. 9. National Board of Dental Examiners.—(a) The National Board of Dental Examiners shall consist of twenty-one elected members and four Dental Officers designated by and representing, respectively, the Surgeon General of the United States Army, United States Navy, United States Public Health Service and Medical Director of the United States Veterans Administration.
- (b) The twenty-one elected members of the National Board of Dental Examiners shall consist of three groups:
- 1. Seven members of the National Association of Dental Examiners who are members of the American Dental Association.
- 2. Seven active members of the American Association of Dental Schools of professorial rank, who are members of the American Dental Association.
- 3. Seven active members of the American Dental Association who are not affiliated with any State Board of Dental Examiners or with any Dental College.

Groups 1 and 2 shall be elected by their respective associations.

Group 3 shall be nominated by the Board of Trustees of the American Dental Association and elected by the House of Delegates of the American Dental Association.

824 Section 30. Consultants, Advisers and Additional Personnel:

- 825 A. Consultants and Advisers. In addition to individual council membership as previously
- 826 provided, each council shall have the authority to appoint or employ consultants, advisers
- 827 and additional personnel in conformity with rules and regulations established by the Board
- 828 of Trustees.
- 829 B. Secretaries. Secretaries of councils, in the event they are employees, shall be employed
- 830 by the secretary of the Association from nominations submitted by the councils concerned.
- 831 Section 40. Chairmen: One member of each council shall be appointed annually by the
- 832 Board of Trustees to serve as chairman. The chairman of the Council on Dental Education
- 833 and of the National Board of Dental Examiners shall be appointed from nominations sub-
- mitted by their respective bodies.
- 835 Section 50. Eligibility:
- 836 A. All members of councils must be members in good standing of this Association at the
- 837 time of their nomination and election and must maintain such membership during their
- 838 term of office.
- 839 B. When a member of either the Council on Dental Education or the National Board of
- 840 Dental Examiners shall cease to be a member of the organization which nominated him,
- 841 his membership on either such council shall terminate, and the President of the Association
- 842 shall declare such position vacant.
- 843 Section 60. Term of Office: The term of office for each member of all councils shall be
- 844 three (3) years, and at the end of each term of office a successor shall be elected for a term
- 845 of three (3) years. At the first election after the adoption of these Bylaws there shall be
- 846 elected to the Council on Dental Education and to the National Board of Dental Examiners,
- 847 from each of the three (3) classifications in such councils, one (1) member for one (1)
- 848 year, one (1) member for two (2) years and one (1) member for three (3) years.
- At the first election after the adoption of these Bylaws, there shall be elected to the 850 Council on Dental Health, three (3) members for one (1) year, three (3) members for
- 851 two (2) years, three (3) members for three (3) years.
- At the first election after the adoption of these Bylaws, there shall be elected to all
- 853 councils, except the Council on Dental Education, the Council on Dental Health and the
- 854 National Board of Dental Examiners, one (1) member for one (1) year, two (2) members
- 855 for two (2) years and two (2) members for three (3) years.
- 856 Section 70. Vacancy: In the event of a vacancy in the membership of any council, the

In each group, one member shall be elected for a term of one year, one member for a term of two years, one member for a term of three years, two members for a term of four years, two members for a term of five years, and annually thereafter at the expiration of such terms successors shall be elected for a term of five years. At no time shall there be more than one member from any one State Board of Dental Examiners or more than one member of any Dental Faculty on the National Board of Dental Examiners. When a member of the National Board of Dental Examiners shall cease to be a member of the Group by which he was elected as above specified, his membership on the National Board of Dental Examiners shall terminate at the time of the next annual meeting of the Group by which he was elected, provided that if either groups, one or two, fail to fill any vacancy in their representation, such vacancy may be filled by the American Dental Association as for Group 3, after a lapse of one year. But such nomination and election shall be respective of the required qualifications of the Group in which the vacancy is thus being filled.

- 857 President shall appoint a member of the Association possessing the same qualifications as
- 858 to eligibility as the previous member, to fill such vacancy until a successor is elected by
- 859 the next House of Delegates for the remainder of the unexpired term.
- 860 Section 80. Quorum: A majority of the total number of members of any council shall
- 861 constitute a quorum for the transaction of business
- 862 Section 90. Expenses: The Association shall pay the expenses of each council, provided
- 863 that such expenses are incurred in conformity with rules and regulations established by
- 864 the Board of Trustees, and provided further that the council budget as approved by the
- 865 House of Delegates is sufficient to cover the payment of such expenses.
- 866 Section 100, Duties:
- 867 A. Common Duties of All Councils.
- a. Proposed Budget. Each council shall submit in writing to the Board of Trustees
- a proposed itemized budget of anticipated expenditures for the ensuing fiscal year. Such
- 70 budget shall be submitted at least forty-five (45) days in advance of the final regular
- 871 session of the Board of Trustees as scheduled in Chapter VI, Section 100, of these Bylaws.
- 872 b. Annual Report. Each council shall submit, through the Secretary's office, an annual
- 873 written report to the House of Delegates and a copy thereof to the Board of Trustees.
- 874 B. The Council on Constitution and Bylaws. The Council on Constitution and Bylaws
- 875 shall examine the articles of the Constitution and Bylaws with a view to suggesting changes
- 876 that will advance the administrative efficiency of this Association. This Council shall
- 877 consider all proposed amendments and report its recommendations to the House of
- 878 Delegates and the Board of Trustees.

- 879 C. Council on Dental Education. The Council on Dental Education shall act as the
- 80 agency of this Association in the investigation of dental education and associated subjects
- 881 and make recommendations for means and methods of improving same to the Board of
- 882 Trustees for action in conformity with policies adopted by the House of Delegates. The
- 883 Council on Dental Education shall have authority on behalf of this Association to accredit
- 884 dental schools and schools in related fields of dental education, to approve hospital dental
- 885 departments, internships, residencies and dental specialty boards, in accordance with
- 886 requirements and standards approved by the House of Delegates.

### Committee on Constitution and Bylaws

SEC. 19. Committee on Constitutional and Administrative Bylaws.—There shall be a standing committee on Constitutional and Administrative bylaws consisting of three members nominated by the Board of Trustees and elected by the House of Delegates. One member to be elected for a term of one year, one member for a term of two years, and one member for a term of three years; and one member elected annually thereafter for a term of three years. The Chairmen shall be designated by the Board of Trustees.

The duties of this Commission shall be to receive and consider all proposed amentments to the Constitutional and Administrative bylaws.

#### Council on Dental Education

- 3. The duties of the Council on Dental Education shall be:
- (a) To act as the agency of the American Dental Association in investigating conditions of dental education and associated subjects.
- (b) To suggest to the House of Delegates and Board of Trustees means and methods by which the same may be improved.
- 4. The Council on Dental Education shall have a Secretary to be nominated by the Council and elected by the Trustees of the American Dental Association who shall fix his salary and tenure of office. The Secretary shall be preferably a dentist, and shall be an ex-officio member of the Council without vote. The duties of the Secretary shall be determined by the Council on Dental Education. The office of the Secretary shall be located in the headquarters of the American Dental Association.
- 5. The American Dental Association shall appropriate as necessity arises, and funds permit, sums of money sufficient to cover the administrative expenses of the Council, employ a Secretary, and enable the Council to inspect a limited number of schools each year.

- D. Council on Dental Health. The Council on Dental Health shall be composed of nine (9) members and its duties shall be:
- a. To conduct a study of the oral health needs of the public and of plans to meet such needs; to formulate programs for promoting oral health which shall be submitted to the Board of Trustees for action in conformity with policies adopted by the House of Delegates.
- b. To assist constituent and component societies in the development of dental health policies and programs within their jurisdiction.
- 894 c. To establish and maintain relations with other agencies interested in programs for 895 the improvement of dental health.
  - d. To maintain a comprehensive program of dental health educational services.

- 897 E. Council on Dental Museum and Registry. The duties of the Council on Dental 898 Museum and Registry shall be:
- 899 a. To secure pathological and historical materials for museum exhibits for educa-900 tional and training purposes and to disseminate information thereon.
- b. To maintain a registry of oral and pathological specimen case histories.

#### Council on Dental Health

SEC. 5. Council on Dental Health.—The Council on Dental Health shall be a standing committee and shall consist of nine members nominated by the Board of Trustees and elected by the House of Delegates. Three members shall be elected for a term of one year, three members shall be elected for a term of two years and three members shall be elected for a term of three years. Thereafter, all members shall be elected for a term of three years. The Director of the Bureau of Public Relations shall be an ex-officio member of the Committee.

The Council on Dental Health shall annually elect a chairman from among its members. The Council shall have the power to appoint subcommittees within its membership and adopt such regulations for the government of its actions as may be deemed expedient.

The Council shall have authority to appoint consultants or advisors and recommend for employment such other personnel as is needed from within or without the membership of the American Dental Association for any purpose within its jurisdiction, provided that if such appointments involve expenditures of funds they must be approved by the Board of Trustees.

The Office of the Council shall be in the Headquarters of the A. D. A. The Council shall hold such meetings at the annual session of the A. D. A. and during the year as it deems necessary.

The duties of the Council on Dental Health shall be:

- 1. To study the need, develop plans and programs for the provision of more adequate dental care for the public and to study and make recommendations concerning any other plans or programs developed to promote the dental health of the public.
- 2. To assist constituent and component societies in the development of dental health policies and programs within their jurisdiction.
- 3. To establish and maintain relations with agencies interested in programs for dental health.
- 4. To appoint a committee from its membership and such consultants as may be desirable to coordinate the activities of, and to act in an advisory capacity to, the Bureau of Public Relations.
- 5. To correlate its activities with that of the other standing committees of the A. D. A. when situations of mutual concern are present.

#### Committee on Dental Museum and Registry

SEC. 18. Committee on National Dental Museum and the Dental Registry.—There shall be a Standing Committee on National Dental Museum and the Dental Registry consisting of thirteen members, one from each of the Trustee districts and two ex-officio members. The members from the Trustee Districts shall be nominated by the Board of Trustees and elected by the House of Delegates. The Chairman shall be appointed by the Board of Trustees. The Curator of the Army Medical Museum and the officer of the Dental Corps who is in charge of the Dental Division of the Museum shall be members ex-officio of this committee. The officer of the Dental Corps, above stated, shall be the secretary of the committee.

The committee shall be divided into four groups: 3-3-3-4, respectively. One group shall be elected for one year, one group for two years, one group for three years and one group for four years, and thereafter one group shall be elected at each annual meeting to serve for four years. The Chairman shall appoint four members of the committee to serve with him as an Advisory Council. The Chairman shall appoint a vice-chairman.

The duties of the committee shall be:

- (1) Secure materials for Museum, Exhibits (pathological and historical).
- (2) Maintenance and records of the Registry of Dental-Oral Pathology.
- (3) Create active interest among component societies in the study, use and historical interest of museum exhibits and material. Spread information concerning essential preparation of specimens for the museum and the preparation of case histories for each specimen. Act in an advisory capacity with the Surgeon General in the development of the Dental Section of the Army Medical Museum. It will cooperate with the museum in the selection of suitable materials to be placed in the Dental Section of the museum and all matters concerned therewith.

- F. Council on Dental Research. The duties of the Council on Dental Research shall be:
- a. To formulate plans for encouraging, establishing and supporting programs of research in all fields pertaining to dental materials used in reparative and reconstructive operations in the oral cavity and to submit such plans to the Board of Trustees for action in conformity with policies adopted by the House of Delegates.
  - b. To investigate the causes of diseases and abnormalities of the oral cavity.

#### Council on Dental Research

SEC. 15. Research Commission.—The Research Commission shall be a standing committee of the American Dental Association and shall consist of twenty-five members, who shall be nominated by the Board of Trustees and elected by the House of Delegates.

In addition to the twenty-five members elected by the House of Delegates, the President and the President-Elect shall be ex-officio members.

Not more than three members of this Commission shall be from any one State. They shall serve for five years, five being elected each year. They shall meet annually at the time of the annual session of the American Dental Association and at such other times as shall be designated by their Executive Board.

- 2. The duties of the Commission shall be to raise funds for carrying on exhaustive dental and oral research; to disseminate scientific knowledge; to support, establish, and encourage research; and such other duties as shall pertain to the furthering of this cause.
- 3. The Commission shall organize, shall elect a chairman and secretary, and shall adopt such regulations for the government of its actions, not inconsistent with these bylaws, as it may find expedient from time to time. They shall elect from their number an executive board of five members, which shall, when the Commission is not in session and has not given specific directions, have general control of the administration of the affairs of the Commission and general supervision of all arrangements for administration, research and other matters undertaken or promoted by the Commission. The secretary shall keep a continuous record of its proceedings and report from time to time its recommendations through the General Secretary to the Board of Trustees, and make an annual report to the Board of Trustees.
- 4. The Commission shall receive applications in writing from persons soliciting funds for research for themselves or for others; shall investigate personally or through their agents all applications, and shall require such proofs or verifications as the Commission may deem proper; shall pass on such applications, recommending or disapproving them in whole or in part, and report their recommendations, through the general secretary, to the Board of Trustees, stating the amount of grant recommended, the time or times for payment, and the person or persons to whom it should be made payable.
- 5. Such recommendations shall be promptly brought before the Board of Trustees, and if it is approved by said Board, the usual order for payment out of the proper Research Fund shall be made out by the General Secretary, which if found correct, shall be countersigned by the secretary of the Research Commission, and paid by the Treasurer of the Association.
- 6. The Research Commission may also undertake and superintend research work, under its direct supervision, on the approval of the Board of Trustees.
- 7. The Research Commission shall each year, immediately before the annual meeting, make and submit to the Board of Trustees, through the General Secretary, a budget for the ensuing calendar year, including estimated expenses for research work directly under the supervision of the Commission.
- 8. All disbursements and payments shall be made by vouchers or orders drawn by the General Secretary or business manager countersigned by the secretary of the Research Commission, if within the scope of appropriations already authorized or made, which when so countersigned shall then be paid by the Treasurer of the Association.

#### Council on Dental Therapeutics

SEC. 12. The Council on Dental Therapeutics.—This Council shall be composed of twelve (12) persons, who shall be nominated by the Board of Trustees, and elected by the House of Delegates. Each person shall serve for a term of six (6) years.

Two (2) persons shall be elected each year for a term of six (6) years.

Six (6) members of the Council must be members of the dental profession, one of whom shall

<sup>910</sup> a. To study, evaluate and disseminate information with regard to dental therapeutic 911 agents, their adjuncts and dental cosmetic agents which are offered to the public or to the 912 profession.

b. To formulate plans for encouraging, establishing and supporting programs of research 914 in the field of dental therapeutics and to submit such plans to the Board of Trustees for action in conformity with policies adopted by the House of Delegates.

918 H. Council on Dental Trade and Laboratory Relations. The duties of the Council 919 on Dental Trade and Laboratory Relations shall be:

a. To encourage and develop satisfactory relations with the various organizations 921 representing the dental trade and dental laboratories.

b. To formulate plans for establishing and maintaining the greatest efficiency of the dental trade and dental laboratories in their relation to the dental profession and to submit such plans to the Board of Trustees for action in conformity with policies adopted by the House of Delegates.

- I. Council on Federal Government Dental Corps, The duties of the Council on Federal Government Dental Corps shall be:
  - a. To review and study the specific problems of the various dental corps.
- b. To formulate plans that will increase the efficiency of said corps and to submit such 930 plans to the Board of Trustees for action in conformity with policies adopted by the House 931 of Delegates.

Explanatory Note: The term "federal government dental corps," as used in this Constitution and Bylaws, shall mean the Army Dental Corps, the Naval Dental Corps, the dental officers in the Regular Corps of the United States Public Health Service and the dental officers in the Veterans Administration.

936 J. Council on History. The duties of the Council on History shall be to study, collect 937 and prepare for publication material of historical interest to the dental profession.

serve as chairman to be elected by the Board of Trustees. Six (6) members may be scientists

The Council on Dental Therapeutics shall study and evaluate drugs, devices, cosmetics and other chemical mixtures which are offered to the dental profession or to the public for dental use. The primary object of the Council shall be to inform and to protect the dental profession and the public against fraud, imposition, undesirable secrecy and objectionable advertising in connection with the distribution of dental products. It shall also disseminate information pertaining to dental therapeutics.

The Council on Dental Therapeutics shall designate delegates to represent the American Dental Association at conventions of the United States Pharmacopoeia and, upon request, to other governmental and private agencies which are engaged in activities related to those of the Council.

The Council shall establish such rules as it deems necessary to govern its conduct.

The Council on Dental Therapeutics shall utilize the reports of the Bureau of Chemistry in its evaluation of products which come within its scope. The Secretary of the Council shall serve as the Director of the Bureau of Chemistry.

#### Committee on Prosthetic Dental Service

SEC. 23.—The Prosthetic Dental Service Committee shall consist of five members who shall be nominated by the Board of Trustees and elected by the House of Delegates. One member shall be elected for five years, one for four years, one for three years, one for two years and one for one year. Thereafter one member shall be elected annually to serve for a period of five years.

The chairman shall be named by the Board of Trustees each year.

The duties of this committee shall be: To develop and maintain a mutually helpful relation between the dental profession and the dental laboratories for the best interest of the health and welfare of the public; To issue certificates of accreditation to those laboratories which meet the requirements for such accreditation as set up by the committee; To supervise inspection of dental laboratories for accreditation or for a continuation of accreditation; To cooperate with similar committees of constituent and component societies in carrying out the duties of this committee.

#### Committee on Military Affairs

SEC. 24. Committee on Military Affairs.—There shall be a Standing Committee on Military Affairs composed of five members, three of whom shall be veterans of World War No. 2, nominated by the Board of Trustees and elected by the House of Delegates; one member to be elected for five years, one for four years, one for three years, one for two years and one for one year; and one member elected annually thereafter for a period of five years.

The Chairman shall be appointed annually by the Board of Trustees.

Duties: The Committee shall represent the veterans who served in the Armed Forces of the United States, and those officers who remain in the Services or hereafter to be appointed; and shall interest itself and plan for the future improved status of the various Dental Corps of the Army, Navy, Public Health Service and Veterans Administration.

#### Committee on History

Sec. 17. Committee on History.-There shall be a Committee on History composed of five members nominated by the Board of Trustees and elected by the House of Delegates. One member shall be elected for one year; one member for two years; one member for three years; one member for four years; one member for five years and one member to be elected annually thereafter for a term of five years. The Chairman of this Committee shall be named by the Board of Trustees. The duties of this committee shall be to collect data and material and to investigate such questions regarding the history of dentistry as may be referred to it.

938 K. Council on Insurance. The duties of the Council on Insurance shall be to consider 939 the problem of insuring the members of this Association for their protection in any manner 940 whatsoever and make recommendations regarding such plans to the Board of Trustees for 941 action in conformity with policies adopted by the House of Delegates.

942 L. Council on International Relations. The duties of the Council on International 943 Relations shall be to cooperate with dentists and dental groups in countries other than 944 the United States for the purpose of exchanging dental knowledge and information in 945 conformity with policies adopted by the House of Delegates.

- 946 M. Council on Journalism. The duties of the Council on Journalism shall be to sponsor 947 annual conferences on dental journalism and to develop standard methods and programs 948 for the advancement of dental journalism in accordance with the rules and regulations 949 adopted by the House of Delegates. The Editor of The Journal of the American Dental 950 Association shall be a member ex officio.
- 951 N. Council on Legislation. The duties of the Council on Legislation shall be:
- a. To protect and further the interests of the public and the dental profession in matters of patents, legislation and regulations and to make recommendations of plans and methods to the Board of Trustees in conformity with policies approved by the House of Delegates.
- b. To disseminate information which will assist the constituent and component societies in their problems involving the enactment and enforcement of legislation affecting the dental health of the public or the practice of dentistry.

SEC. 14. Committee on Insurance.-There shall be a standing committee on Insurance, consisting of five members to be nominated by the Board of Trustees and elected by the House of Delegates. One member shall be elected for one year, one for two years, one for three years, one for four years, and one for five years, and thereafter, one member shall be elected each year for five years. It shall organize and elect a Chairman and a Secretary. This committee shall have supervision of all the insurance activities of the American Dental Association. It shall analyze the standing of different insurance companies, and when called upon by the Board of Trustees shall submit to them data relative to these companies. It shall also study and formulate methods of notification of the members in reference to the payments of premiums, the systems of accounting and various other activities connected with the general subject of insurance. The committee shall make a comprehensive report each year to the Board of Trustees and to the House of Delegates. This report shall contain a complete statement of all receipts, disbursements, and other financial operations which have been carried on by those officers or committees having charge of the collection of premiums. The relations of the members of the Association to the insurance company carrying the risks at any time shall be a subject to be studied by this committee so that the membership may be kept informed of any changes in their relation to the insurance carrier. This report shall be printed each year in The Journal of the American Dental Association for the information of the members at large.

#### Committee on International Relations

SEC. 22. International Relations Committee.—There shall be a committee on International Relations consisting of ten members, nominated by the Board of Trustees and elected by the House of Delegates, two members for terms of one, two, three, four and five years respectively, and, thereafter, two each year for a term of five years.

The Committee shall annually elect a chairman and adopt such regulations for the government of its activities as it may deem expedient. The Committee may appoint such subcommittees or deputies as may be found advisable to carry on its work.

The duties and purposes of the International Relations Committee shall be to cooperate with and promote knowledge, information, and activities with the Dental Societies in the Western Hemisphere.

#### Committee on Legislation

SEC. 4. Committee on Legislation.—There shall be a Committee on Legislation consisting of thirteen members, one from each of the Trustee Districts, into which the Constituent Societies have been grouped. The members from each of the Trustee Districts shall be recommended for nomination by the delegates of that district assembled at an annual meeting. This recommendation shall be referred to the Trustees and by them presented to the House of Delegates for election.

The committee shall be divided into four groups: three, three, three, and four respectively. One group shall be elected for one year, one group for two years, one group for three years, and one group for four years, and thereafter one group shall be elected at each annual meeting to serve for four years.

The Chairman shall be named by the Board of Trustees each year. The Chairman shall appoint two but not more than four members of the Committee to serve with him in an executive capacity, and they shall be known as the Executive Committee.

The Executive Committee shall have supervision over the activities of the Committee in order to expedite the work and be able to meet emergencies more properly.

The Chairman shall appoint a vice-chairman to preside over all meetings during the Chair-

man's absence.

The duties of the Committee shall be as follows:

- 1. To protect and further the interest of the dental profession in all matters of Federal Legislation and/or regulation;
- 2. To promote such policies which call for legislative action as may be initiated and carried to the legislative point in other committees where such studies rightfully belong and which have been approved by the Association;
- 3. To oppose or attempt to modify any proposed federal legislation or regulation which is in conflict with existing policies of the Association;
- 4. To take appropriate and prompt action in cases of extreme emergency pending an immediate decision by the Ad Interim Committee;
- 5. To aid and assist the respective constituent societies in their problems of state legislation or regulation, when such aid or assistance may be requested by the accredited officials;
- 6. To initiate and promote studies of legislation in the various states in the development of factual data, to tabulate such data and to make such information available to all the constituent societies for their information and use if it can be applied;
- 7. To advise constituent societies through official bulletins and the profession through the columns of the Journal of the American Dental Association concerning legislation, regulation, litigation or related matters of interest and importance to the profession;
- 8. To include in the annual report to the House of Delegates such recommendations as the Committee considers advisable.

Employees. The Board of Trustees shall assign a suitable person to be Secretary of the Committee whose office shall be located in the Central Office of the American Dental Association. The Board of Trustees shall be empowered, on the recommendation of the committee, to employ such person or persons as may be deemed advisable to carry on the activities of the committee in the following capacities: A legislative representative to represent the Committee and the American Dental Association before the Congress or any state legislature, or in Federal or State Legislative or departmental matters, an assistance secretary and other clerical help.

Deputies. Each member of this committee representing a Trustee District shall appoint a deputy from each state in the district to cooperate in all legislative and regulatory matters pertaining to their respective states.

Duties of individual members. Each member of the Committee on Legislation shall be a representative of the American Dental Association in all legislative activities in his district, and shall keep the Chairman and Secretary of the committee fully informed of those activities. He shall report to and consult with the Trustee of his district on all legislative and regulatory matters and also cooperate with the member of the American Dental Association Committee on Economics from that district. He shall cooperate with the officers and all groups of individuals who are interested in or have charge of legislative and regulatory problems of the state societies in his district. He shall promote such studies and investigations in his district as may assist members of the American Dental Association to secure improved legislation and regulations.

Meetings. The Committee shall meet annually just prior to or during the annual meeting at the same time, place or such other time and place as shall be designated by the Committee.

#### Committee on Membership

SEC. 11. Committee on Membership.—The Committee on Membership shall consist of thirteen members, one from each of the Trustee Districts into which the constituent societies have been grouped.

The members from each of the Trustee Districts shall be recommended for nomination by the delegates of that District assembled at an annual session.

This recommendation shall be referred to the Trustees and by them presented to the House of Delegates for election.

- O. Council on Membership. The duties of the Council on Membership shall be:
- a. To conduct a study of membership problems and formulate plans for maintaining and increasing the membership of this Association. Such plans shall be submitted to the Board of Trustees for action in conformity with policies adopted by the House of Delegates.
- b. To review applications for active membership in this Association from applicants practicing in territories or dependencies of the United States or in federal government dental corps in which no constituent society is chartered, and to make recommendations regarding same to the Board of Trustees.
- c. To review all applications for affiliate membership in the Association and make recommendations regarding same to the House of Delegates

969 P. Council on Relief. The Council on Relief shall formulate plans for increasing the principal of the Relief Fund of this Association and recommend rules and regulations for the granting of financial aid to dentists, their dependents and survivors. It shall submit such plans and recommendations to the Board of Trustees for action in conformity with policies adopted by the House of Delegates.

The Committee shall be divided into five groups, of two, two, three, three, and three, respectively. One group shall be elected for one year, one for two years, one for three years, one for four years, and one for five years; and thereafter, one group at each annual meeting to serve for five years. The Chairman shall be named by the Board of Trustees each year. The Chairman shall select two members of the Committee to act with him in an Executive capacity to expedite the business of the Committee that may need early or immediate attention, one of these to be designated Vice-Chairman who will assume the duties of the Chairman should he be unable to function. The General Secretary of the Amercian Dental Association shall be the Secretary of the Committee.

The Secretary shall keep a permanent record of the proceedings of the Committee and shall conduct all correspondence. The office of the Committee shall be at the headquarters of the Association. The Committee shall hold such meetings during the annual meeting and during the year as it may deem necessary. Three members shall constitute a quorum.

The Committee shall adopt such rules and regulations for the government of its actions as it may deem expedient.

The duties of this Committee shall be:

- (1) To promote and superintend membership contests and determine the classification and status of membership of constituent societies in accordance with plan adopted.
- (2) To submit recommendations to constituent societies of changes considered advisable to strengthen their organization and to make this Association more effective.
- (3) To recommend to the House of Delegates for adoption such plans as may seem expedient to maintain the highest level of membership.
  - (4) The Committee may appoint sub-committees to assist in carrying on its work.

#### Relief Commission

- SEC. 7. A Relief Commission.—(a) There shall be a Relief Commission consisting of six members to be nominated by the Board of Trustees and elected by the House of Delegates, for terms of one, two, three, four, five and six years respectively, and thereafter one each year for a term of six years. The Chairman and the Secretary shall be named by the Board of Trustees. Nothing in this amendment shall change the present members of these committees.
- (b) It shall be the duty of this Commission to formulate and adopt plans for the increase of the A.D.A. Relief Funds and the granting of financial aid to dentists, their widows and dependents, or orphans, and such other emergency grants, recommended by this Commission and approved by the Board of Trustees.
- (c) The Commission shall organize and adopt such regulations for the government of its actions not inconsistent with these bylaws as it may find from time to time expedient. The Secretary shall keep a continuous record of its proceedings and report from time to time its recommendations through the General Secretary to the Board of Trustees, and make an annual report to the Board of Trustees.
- (d) The Commission shall receive applications in writing from persons soliciting grants for themselves or for others; shall investigate personally or through their agents all applications, and shall require such proofs or verifications as the Commission may deem proper; shall pass on such applications, recommending or disapproving them in whole or in part, and report their recommendations, through the General Secretary, to the Board of Trustees, stating the amount of grant recommended, the time or times for payment, and the person or persons to whom it should be made payable.
- (e) Such recommendation shall be promptly brought before the Board of Trustees, and if it is approved by said Board, the usual order for payment out of the proper fund shall be made out by the General Secretary (which, if found correct, shall be countersigned by the Secretary of the Relief Commission), and paid by the Treasurer by check countersigned by the General Secretary of the American Dental Association.
  - (f) No grant shall be made or paid under this section unless an equal amount has been

974 Q. Council on Scientific Session. The Council on Scientific Session shall serve as the general program committee for the annual scientific session of the Association with full power to approve or disapprove the program of any section as submitted by the officers 977 in charge, even to the extent of omitting the program of any section in any year. It shall be its duty (1) to determine the number of general meetings held during each scientific session; (2) to prepare a program for each meeting; (3) to co-ordinate the programs of the several sections; (4) to establish rules and regulations for governing section officers in the performance of their duties, subject to approval by the Board of Trustees,

#### R. Judicial Council. The duties of the Judicial Council shall be:

of this Association and the Secretary of this Association.

- a. To consider proposals for amending the Code of Ethics and to make recommendations regarding same to the House of Delegates and the Board of Trustees.
- b. To provide advisory opinions regarding the interpretation of the Code of Ethics. c. To consider appeals from members of the Association under sentence of censure, probation, suspension or expulsion by a constituent society and to hold hearings and render decisions thereon. In such instance, the accused member shall have transmitted to him a written copy of the charges brought against him together with a notice of the time and place of the hearing, such notice to be sent by registered letter addressed to his last known address and mailed not less than thirty days prior to the day set for the hearing. 992 Every decision which shall result in censure, probation, suspension or expulsion of a member shall be reduced to writing and shall contain a copy of the charges made against the accused member, a recital of the facts, the verdict rendered and the penalty imposed. Within ten days of the day on which the decision is rendered a copy thereof shall be sent by registered mail to the last known address of each of the following parties: the accused member; the secretary of the component society to which he belongs, if any; the secretary of the constituent society to which he belongs, if any; the chairman of the Judicial Council
- 1000 d. To hold a hearing and render a decision in every case in which a member of this Association who is not a member of a constituent society is charged (1) with having been found guilty of a felony, (2) with having been found guilty of violating the dental practice act of a territory, dependency or country, or (3) with violating these Bylaws or the Code of Ethics of this Association.

- 1005 S. National Board of Dental Examiners. The duties of the National Board of Dental Examiners shall be:
- a. To provide and conduct examinations, exclusive of clinical demonstrations, in the art and science of dentistry for the purpose of determining the qualifications of persons who desire to enter dental practice in any state, district, territory or dependency of the

secured or promised to be paid to the same beneficiary by the constituent society to which the applicant belongs.

- (g) The Commission shall select one representative in each state to be known as an associate member whose duties shall be to cooperate in the activities of the Commission in that state.
- (h) The A.D.A. Relief Fund contributed in the name of this relief and collected by this Commission shall be earmarked as a separate fund from the other funds and assets of the American Dental Association, the interest only of which can be expended by this Commission with approval of the Board of Trustees in this service.

Judicial Council

Sec. 2. Judicial Council.—The Judicial Council shall be composed of five members. One member shall be elected each year to serve for a period of five years. It shall organize by electing a chairman.

The Judicial Council shall hold such sessions during the annual meeting and during the year as it may deem necessary.

Three members shall constitute a quorum. To this Council shall be referred all questions, complaints, protests and matters pertaining to ethics.

The Judicial Council shall not initiate or try any first causes. It shall only consider questions on appeal from the decision of a state society on matters which concern an individual's relation with his local or state society.

If a member of the American Dental Association shall have been accused of violation of the bylaws, transgression of the Code of Ethics, or any conduct deemed unprofessional, and if he has been adjudged guilty by his local society and the penalty imposed shall impair his membership in the American Dental Association, he may then file an appeal with the constituent state society of which his local society is an affiliate, provided such appeal in affidavit form is filed with the secretary of the state society within thirty days after the accused member has been found guilty and has received official notice of the decision and the penalty imposed. If the constituent state society shall concur in the findings of the local society and shall affirm the penalty imposed and the member feels that justice has not been done him, he shall have recourse by an appeal to the Judicial Council of the American Dental Association, provided such an appeal in affidavit form is filed with the Chairman of the Judicial Council within thirty days after the accused member has been notified of the action taken by the constituent state society. If upon an appeal of a member of a local society to the state society, the decision of the local society shall be reversed, then the local society shall be privileged to appeal to the Judicial Council.

If either of the parties to the above action is dissatisfied with the decision of the Judicial Council, they or either one of them may appeal to the House of Delegates, provided such appeal is filed, in affidavit form, with the Secretary of the American Dental Association within thirty days after having received official notice of the decision of the Judicial Council.

No penalty impairing the membership of a member of the American Dental Association shall become effective until all means of appeal, as herein provided, shall have been exhausted.

#### National Board of Dental Examiners

(c) The purpose and duty of the National Board of Dental Examiners shall be to provide and conduct examinations in the theory and science of dentistry to determine the qualifications of persons who would enter the practice of dentistry in any state, territory or dependency of the

United States, Licensure to practice is subject to the laws of the states, districts, territories or dependencies, and the right to conduct all practical examinations is reserved to the individual boards of dental examiners in such states, districts, territories or dependencies. b. To make such rules and regulations as may be necessary for the conduct of the previously mentioned examinations and for the issuance of a certificate of qualification to successful candidates. Such certificate may be recognized and accepted by the several boards of dental examiners in lieu of their own examinations.

- Section 110. Privilege. Chairmen and members of Councils who are not members of the House of Delegates shall have the right to present their reports in person to the House of
- 1019 Delegates and to participate in the debate thereon but shall not have the right to vote.

#### Chapter X Special Committees

- Section 10. Special committees of this Association may be created at any session of the House of Delegates to serve until adjournment sine die of the next annual session of the
  - House of Delegates for the purpose of performing any duty not otherwise assigned by
- these Bylaws. The authority for appointing the members of a special committee shall be
- set forth in the action creating such committee.
- Section 20. Privilege. Chairmen and members of special committees who are not members of the House of Delegates shall have the right to present their reports in person to the House of Delegates and to participate in the debate thereon but shall not have the right to vote.

United States, such entrance to practice being subject, however, to the dental laws of the several states; all practical examinations shall be reserved to the several state boards of dental examiners. The National Board of Dental Examiners shall make such rules and regulations as may be necessary for the conduct of said examination and for the issuance of a certificate of qualifications to successful candidates, which certificate may be recognized by the several state boards of dental examiners and accepted by them in lieu of their written examination; provided, however, that nothing in this section shall be mandatory upon any state board of dental examiners.

(d) The Board shall organize, elect a chairman, vice chairman, a secretary and an executive committee, and shall adopt such regulations for the government of its actions not inconsistent with these bylaws as it may deem expedient from time to time.

The executive committee shall be composed of the chairman, the secretary and three other members of the Board, and shall, when the Board is not in session or has not specially provided otherwise, have general control and supervision of the Board's affairs and activities.

The chairman, vice chairman, and secretary shall be elected from members of the Board and shall perform such duties as usually devolve upon such officers. The secretary shall keep a continuous record of the proceedings of the Board and shall submit for the Board an approved comprehensive annual report to the House of Delegates of the American Dental Association, the American Association of Dental Schools, and the National Association of Dental Examiners. The Board may from time to time create within itself other committees under secretaries and directors to carry out and direct certain lines of work under its jurisdiction when the need and expedience shall arise.

(e) The Board shall meet yearly at the time and place of the annual meeting of the American Dental Association and at such other time and place as shall be designated by its executive committee, and/or chairman.

Not later than July 1st the National Board of Dental Examiners through its Secretary, shall furnish in writing to the Secretary of the American Dental Association, a detailed budget containing the estimated expenses and expenditures of this Board in order to carry out its prescribed duties during the ensuing fiscal year of this Association.

All expenditures from any appropriations authorized by the Board of Trustees and approved by the House of Delegates for the National Board of Dental Examiners, shall be made in accordance with the plans, rules and regulations governing like expenditures for officers, committees and commissions as are now or may be established by the Board of Trustees and approved by the House of Delegates.

All receipts of this Board from fees or any other source shall be paid to the Treasurer of the American Dental Association and credited to the general fund. Receipts other than those received from fees may be otherwise disposed of for the benefit of the Board's activities by vote of the Board of Trustees subject to approval of the House of Delegates.

## Chapter XI Bureaus

- Section 10. Number and Name. There shall be four (4) bureaus of this Association:
- A. Bureau of Statistics

- Section 20. Personnel: The personnel of all bureaus shall be employees of the Association.

- 1036 made by the House of Delegates. Members of advisory committees shall be elected by the

- 1134 C. Student Members: The dues of student members shall be six dollars (\$6.00) due

- 1140 E. Associate Members: The dues of associate members shall be ten dollars (\$10.00) due
- 1141 January 1 of each year.
- 1142 F. All members, except life and honorary members, elected after July 1, shall pay one-half
- 1143 (1/2) of the current year's dues.
- 1144 Section 20. Fiscal Year: The fiscal year of this Association shall begin on January 1 of
- 1145 each calendar year and end on December 31 of the same year
- 1146 Section 30. General Fund: The General Fund shall consist of all monies received other
- 1147 than those specifically allocated to other funds by these Bylaws. This fund shall be used
- 1148 for defraying all expenses incurred by this Association not otherwise provided for in these
- 1149 Bylaws.

Dues

SECTION 1. The annual dues of this Association shall be \$6.00, payable January 1 for the ensuing year. Members elected after July 1 shall pay \$3.00 for the year they are elected to membership. Annual dues for junior or other classes of members will be provided for in the Administrative Bylaws.

#### 1150 Section 40. Relief Fund:

- 1151 A. Purpose: This Association shall establish a Relief Fund, fully detached from any
- 1152 other fund of the Association, for the purpose of granting financial aid to dentists, their
- 1153 dependents and survivors in accordance with rules and regulations formulated by the
- 1154 Council on Relief and approved by the Board of Trustees.
- 1155 B. Principal: The principal of this fund shall be invested in the name of the Association
- 1156 in nonspeculative securities and shall be derived from:

- 1160 C. Disbursements: Disbursements shall be made only from earnings and from principal

- 1162 grants-in-aid to dentists, their dependents and survivors.

#### 1163 Section 50. Research Fund:

- 1164 A. Purpose: This Association shall establish a Research Fund for the purpose of
- 1165 promoting and advancing dental research.
- 1166 B. Principal: The principal of this Fund shall be derived from direct contributions
- 1167 and earnings.
- 1168 C. Disbursements: Disbursements may be made from the principal to further the
- 1169 purpose of the Fund.

## Chapter XVI Indemnification of Officers and Trustees

- 1170 The Association shall indemnify and hold harmless each trustee and each officer now
- 1171 or hereafter serving the Association from and against any and all claims and liabilities to
- 1172 which he may be or become subject by reason of his now or hereafter being or having
- 1173 heretofore been a trustee and/or officer of the Association and/or by reason of his alleged
- 1174 acts or omissions as a trustee and/or officer as aforesaid, and shall reimburse each trustee
- 1175 and each officer of the Association for all legal and other expenses reasonably incurred by
- 1176 him in connection with defending against any such claims or liabilities, provided, however,
- 1177 that no trustee or officer shall be indemnified against or be reimbursed for any expenses
- 1178 incurred in defending against any claim or liability arising out of his own negligence or
- 1179 willful misconduct. The foregoing rights of trustees and officers shall not be exclusive of
- 1180 other rights to which they may be entitled lawfully.

## Chapter XVII Amendments

- 1181 These Bylaws may be amended at any session of the House of Delegates by a two-thirds
- 1182 (2/3) majority vote of the members present and voting, provided the proposed amend-
- 1183 ments shall have been presented in writing at a previous session or a previous meeting of
- 1184 same session.

## Chapter XVIII Enactment

- This Constitution and Bylaws, which take the place of and render null and void here-
- 1186 after all previous Constitutions and Bylaws and all standing resolutions which are incon-
- 1187 sistent or in conflict with any provisions of this Constitution and Bylaws, shall go into
- 1188 effect immediately.

Amendments

SEC. 2. These Administrative bylaws may be amended on a two-thirds vote of the House of Delegates, provided that no amendment shall be acted on till the day following that on which it is introduced, except that the Board of Trustees may by unanimous vote make such changes, and such changes only, as may be required to adapt them to the rules and regulations of the United States postal authorities.

Until the first election after the adoption of these Bylaws, the President shall act as the speaker of the House. All officers of committees, commissions and councils shall function until their successors have been elected and installed. All councils, committees, commissions and bureaus shall be subject to all rules and regulations previously adopted by the House of Delegates provided they are not inconsistent or in conflict with these Bylaws.

#### REVISED ARTICLES OF INCORPORATION

- 1. Name. The name of this corporation is AMERICAN DENTAL ASSOCIATION.
- 2. Period of Duration. The period of duration of the corporation is perpetual.
- 3. Purpose and Object. The purpose and object of this corporation is to encourage the improvement of the health of the public and to promote the art and science of dentistry.
- 4. Office. The principal office of the corporation shall be in the City of Chicago, Cook County, Illinois.
- 5. Bylows. The bylaws of the corporation shall be divided into two categories designated, respectively, "Constitution" and "Bylaws," and each category shall be amendable from time to time in the manner and by the method therein set forth, but in case of any conflict between the Constitution and the Bylaws the provisions of the Constitution shall control.
- 6. Membership. The qualifications, the method of election, designation or selection, the privileges and obligations, and the voting rights, if any, of the various classes of members which are established by the Constitution and Bylaws of the corporation from time to time shall be set forth in and governed by such Constitution and Bylaws.
- 7. Exercise of Corporate Powers. Except as otherwise provided by law, the affairs of this corporation shall be governed and the corporate powers of the corporation shall be exercised by a Board of Directors (to be known as the Board of Trustees), House of Delegates, officers, councils, committees, members, agents and employees as set forth in the Constitution and Bylaws and the titles, duties, powers, and method of electing, designating or selecting all of the foregoing shall be as provided therein.
- 8. Voting Rights With Respect to Amendments to Articles of Incorporation. Only those members of the corporation shall have voting rights in respect to amendments to the Articles of Incorporation as shall have a right from time to time to vote on amendments to the Constitution of the corporation.

#### PRESENT ARTICLES OF INCORPORATION

- 1. The name of such corporation is AMERICAN DENTAL ASSOCIATION.
- 2. The object for which it is formed is:

To cultivate and promote the art and science of dentistry, and of its collateral branches; to conduct, direct, encourage, support or provide for exhaustive dental and oral research; to elevate and sustain the professional character and education of Dentists; to promote among them mutual improvement, social intercourse, and good will; to disseminate knowledge of Dentistry and Dental Discoveries; to enlighten and direct public opinion in relation to Oral Hygiene, dental prophylaxis and advanced scientific dental service, and in relation to the advantages and progress of enacting and enforcing proper, just and uniform Dental Laws in the several States; and collectively to represent, have cognizance of and to safeguard the common interests of the members of the Dental Profession; with express powers to acquire property for the purposes of the corporation by purchase, deed, gift, bequest or otherwise, and to hold and administer the same, and to publish Dental Journals, reports and treatises.

3. The management of the aforesaid American Dental Association shall be vested in a board of thirteen directors, to be known as trustees.
