Amendments to Constitution and Bylaws 1969-1970

The following amendments to the <u>Bylaws</u> of the American Dental Association were adopted by the 1969 and 1970 sessions of the House of Delegates.

CHAPTER I · MEMBERSHIP

Section 20. Qualifications: A. Active Member. (lines 80-89) amended to read:

A. Active Member. A dentist shall be classified as an active member of this Association who is licensed to practice in a state, the District of Columbia, the Commonwealth of Puerto Rico or a dependency of the United States, providing he is a member in good standing of this Association, its constituent and component societies, if such exist, or is a member in good standing and licensed to practice in a dependency of the United States wherein a constituent society does not exist, or is a member of a federal dental service.

A retired member of a federal dental service who is serving on a faculty of a dental school, or is receiving compensation as a dental administrator or consultant, or is engaged in any activity for which a license to practice dentistry or dental hygiene is required by the state, the District of Columbia, the Commonwealth of Puerto Rico or a dependency of the United States wherein the activity is conducted shall obtain and maintain membership in this Association through its component and constituent society, if such exist, for the duration of such activity.

Section 30. Definition of "In Good Standing": (lines 141-147) amended to read:

Section 30. Definition of "In Good Standing": A member of this Association whose dues for the current year have been paid shall be in good standing; provided, however, that a member in good standing who is under a disciplinary sentence of suspension shall be designated as a "member in good standing temporarily under suspension" until his disciplinary sentence has terminated and provided further that a member engaged in practice, to remain in good standing, may be required to meet standards of continuing education established within the bylaws of his constituent society....

Section 50. Dues and Reinstatement: A. Active Members. (lines 228-229) amended to read:

A. Active Members. The dues of active members shall be seventy dollars (\$70.00) due on January 1 of each year.

Section 50. Dues and Reinstatement: F. Associate Members. (lines 245-246) amended to read:

F. Associate Members. The dues of associate members shall be twenty dollars (\$20.00) due on January 1 of each year.

Section 40. Membership: B. Removal from One Jurisdiction to Another. (lines 318-338) amended to read:

B. Removal from One Jurisdiction to Another. A member who has changed the location of his practice from the jurisdiction of one constituent society to that of another constituent society may maintain active membership in the constituent society of which he is a member for the calendar year following that of his removal from the jurisdiction of such society. The same privilege shall apply to a member who is separated from a federal dental service and who enters practice in an area under the jurisdiction of a constituent society or a member who is retired from a federal dental service and who is serving on a faculty of a dental school. or is receiving compensation as a dental administrator or consultant, or is engaged in any activity in the area under the jurisdiction of a constituent society for which a license to practice dentistry or dental hygiene is required by the state, the District of Columbia, the Commonwealth of Puerto Rico or a dependency of the United States wherein the activity is conducted. A dentist who retires from active practice and establishes residence in an area outside of the jurisdiction of the constituent society in which he holds membership shall be permitted to continue his membership in such constituent society for the period of his retirement.

A member who is unsuccessful in transferring his membership from one constituent society to another shall be entitled to appeal from a denial of his application for transfer of his membership to the Judicial Council in accordance with the procedures of Chapter XI, Section 20C and D of these Bylaws even though a disciplinary penalty is not involved.

Section 120. Rules of Order: <u>A. Standing Rules and Reports</u>. c. Approval of Annual Budget. (lines 722-729) amended to read:

<u>c. Approval of Annual Budget</u>. The proposed annual budget shall be submitted by the Board of Trustees to the members of the House of Delegates at least fourteen (14) days prior to the opening meeting of the annual session, shall be referred to a special reference committee on budget for hearings at the annual session and then shall be considered for approval as a special order of business at the second meeting of the House of Delegates. In the event the budget as submitted is not approved. all recommendations for changes shall be referred to the Board of Trustees to prepare and present a revised budget. This procedure shall be repeated until a budget for the ensuing fiscal year shall be adopted.
