## **Keep Louisiana Musicians Smiling**

On June 1<sup>st</sup>, Louisiana Governor John Bel Edwards, held a press conference at UMC in New Orleans to announce that enrollment into Medicaid had begun. This was truly music to the ears of the 2500 + patients of the New Orleans Musicians' Clinic (NOMC) for dental care is part of Louisiana Medicaid.

Since 1998 the NOMC team has strived to engage performers in their own self-care. According to the 2009 report from the American Human Development Project entitled "A Portrait of Louisiana," life expectancy for African Americans in New Orleans was 69.3 years, putting them on a par with citizens of North Korea, Colombia, Venezuela and Uzbekistan (Sharps, et. al., 2009). Given these conditions, the poor health indicators for the city as a whole are further compounded for musicians -who often perform in unhealthy work environments with late night hours and low pay. Separations from families while on the road, performance anxiety and other work-related mental health hazards are common. And yet, musicians are the back bone of Louisiana's tourist industry.

The New Orleans Musicians' Clinic, as a federally designated Patient Centered Medical Home, combats these health disparities by providing direct, comprehensive and specialty medical services to more than 2,500 performing artists and culture bearers. In addition to this, we serve thousands of local community members each year through health outreach events (cancer screenings, blood drives, immunization campaigns and heaIth literacy events), wellness advocacy, Emergency Manage- ment, and social services. Our medical clinic is supported by the LSU Health Care Network (which donates the space for the NOMC), family foundations, and donors.

#### Keeping the Music Alive in New Orleans: One musician at a time

New Orleans is the birthplace of American music. Today music is the backbone of Louisiana tourism. It is not if we can afford to care for musicians, it is if we can afford not to? Dedicated on May 2, 1998, the New Orleans Musicians' Clinic (NOMC) became the first such health initiative in the United States, addressing the health care needs of performers, whether they are insured, under insured or uninsured. Not only do they strive, as a federally designated patient centered medical home within the LSUHN system, to affect an agenda of wellness in our musician patient population, they encourage our musicians to become advocates for early detection, prevention, and treatment for others in our community facing the same risks. Today they treat 2500+ local performers, 82% live below the federal poverty line and also are being treated at the NOMC for one or more chronic condition (diabetes, hypertension, depression, asthma, etc).

The New Orleans Musicians' Assistance Foundation (NO-MAF) evolved from the New Orleans Musicians' Clinic in 2005 following the devastating effects of Hurricane Katrina. The 501(c)(3) not-for-profit organization expands the mission of the Musicians' Clinic by providing cost-efficient access to comprehensive wellness education preventive health care, mental health services and social services regardless of the patient's ability to pay.

#### NOVEMBER 1996

Dr. McConnell gains the support of Dr. Mervin Trail, LSUHSC Chancellor and president of the Greater New Orleans Tourist and Convention Commission. A coalition of local musician advocates and LSUHSC physicians form a planning committee to create medical services for the estimated 3,000+ New Orleans' musicians and culture bearers. The Union of New Orleans Musicians AFM Local 174-496; the LSU Dental School; the LSU and Loyola Nursing Schools; and the Tulane School of Medicine. Two of the USA's largest music festivals; The New Orleans Jazz & Heritage Festival and French Quarter Fest, offer support. Joining LSUHSC in providing resources for NOMC patients were the Daughters of Charity of New Orleans, the New Orleans Jazz & Heritage Foundation, and WWOZ, locally, and internationally, the Performing Arts Medicine Association (PAMA)





#### JULY 1996

#### 1997

Musicians' Clinic Task Force announces its concept for the NOMC through a town hall meeting at Galiier Hall and conducts a needs assessment of local performers to establish the clinic's scope of services. Within this time, LSUHSC Edn. becomes NOMC's fiscal agent, and the faculty group practice of the LSU Medical School, LSUHN, becomes the home of the Musicians' Clinic.

#### MAY 2, 1998

The NOMC opens its first physical location on the 5th floor of the LSUHN located at 2020 Gravier Street, within the downtown medical complex. The Mayor of New Orleans, Marc Morial, designates this day as "New Orleans, Marc Morial, designates this day as "New Orleans Musicians' Clinic Day." The clinic was dedicated with an all-day extravaganza: a champagne jazz brunch attended by LSUHSC officials and leaders in the world of music, social welfare and politics, entertainment by local gospel singers and Mardi Gras Indians, a dedication by U.S. Senator John Breaux, and many others. All the local network affiliates – ABC, CBS, and NBC – covered the grand opening. The story also appeared on CNN interactive, AP wire story, the Boston Globe and the LA Times, CBS's 60 MINUTES anchor, Ed Bradley, was in attendance as one of the Musicians' Clinic's first supporters.

## Money Sense Should Entrepreneurs Invest Differently?

If you own your clinic, you are a small business owner and an entrepreneur. Often time, entrepreneur's personal wealth is typically concentrated in a single asset: his company. Business owners devote themselves to assessing and taking risks in order to grow their enterprises. But too often they don't apply that same focus to their personal assets. In fact, some of the attributes that make for a successful entrepreneur can be diametrically opposed to the imperatives of wealth preservation.


Entrepreneurs should begin by considering their personal wealth objectives. Many business owners may want to take an even more disciplined approach to portfolio construction than other types of investors. This is partly because they may have more to lose, but also because many of the elements of a solid financial strategy can require additional care when there are significant assets tied up in a business endeavor. It's important for entrepreneurs to ensure that their portfolio is tailored not only to their particular circumstances but also to the type of business they own.

Understanding your investment personality.

Getting a better handle on your financial tendencies can help you invest in a way that's better aligned with your goals. You may consider yourself a risk taker generally, but risk taking in an investment context isn't the same as it is in business. When you invest cash in your company, your decision is based on careful analysis of a market you know well. However, financial decision making in your portfolio is more in the market's control.

An investment strategy aligned with your investment personality may help you stay invested when the markets zigzag. One way to help address the issue is to engage in an exercise akin to stress-

testing a portfolio against a range of possible scenarios. By somewhat preparing investors for potential market turbulence, stress tests can help guard against counterproductive behavior which can reduce long-term returns.

Prioritizing your goals.

What are your short- and long-term financial and life goals? When do you anticipate retiring, selling your company or turning it over for someone else to run? Consider your personal goals separately from your business objectives. Business owners often reinvest substantial sums in their companies. But if you plan to pay for your children's college education, for instance, and you know what it will take to reach that goal, you can consciously siphon off cash from your monthly income to allocate to a tax-advantaged college savings program.

Creating an investment strategy.

The process often starts with a bit of mental accounting. Conceive of your wealth in terms of two distinct buckets. The first bucket is your entrepreneurial capital—your stake in your businesses. The second is a diversified portfolio that includes assets designed to compensate for the risk inherent in your businesses.

It's important to make sure your portfolio contains enough liquidity to serve as a cushion against recessions, industry down cycles, or any rough business patch. Because that first entrepreneurial bucket is likely highly illiquid (as it's tied up in your company), entrepreneurs may want to build as much as twice the liquidity into their personal portfolios as nonbusiness-owner investors. Suitable liquid assets generally include a combination of cash, intermediate-term bonds and a line of credit that serves as a form of insurance against potential business pitfalls.

It's a good idea to apply for a line of credit before you need it. A credit line can give you the ability to take advantage of opportunities that crop up suddenly. Lastly, business owners shouldn't overlook disability insurance. An inability to work could end up reducing not only your family's income but also the value of your business.

Choosing a retirement plan that serves your goals.

Some tax-qualified plans offer noteworthy benefits for business owners, allowing you to put away considerable sums while also helping retain employees via profit sharing. If your business has 100 or fewer employees, a SIMPLE (savings incentive match plan for employees) IRA is a relatively inexpensive option, offering most of the benefits of a 401(k) while imposing fewer IRS reporting requirements. Because participation is voluntary, employees can choose whether and how much of their pre-tax wages to contribute. Employers are generally required to match up to 3% of annual compensation, which they can deduct as a business expense. Or they can choose to contribute a flat 2% of compensation for all employees, regardless of whether they contribute.

Reviewing and updating your strategies.

Be prepared to connect with your Merrill Lynch Financial Advisor regularly—at least a few times a year—to go over how you're making progress toward your goals. As business conditions change and life goals evolve, entrepreneurs may need to modify their portfolios from time to time in order to stay on course.
