Dr. Douglas earned his Doctor of Dental Surgery degree from the Baltimore College of Dental Surgery, University of Maryland in 1971. He practiced in the U.S. Army Dental Corps at Fort Benning, GA, from 1971 to 1974 and in Stuttgart, West Germany, from 1974 to 1977. Dr. Douglas was in private practice in Atlanta from 1978 through 1982. After the sale of his private practice in 1982, Dr. Douglas began his career in practice transition consulting. He received his Master in Business Administration degree from Brenau College in 1984 and founded ADS, a national organization of dental practice appraisers and brokers, in 1996 and served as its first president. Dr. Douglas is the author of cash flow analysis software used by professional dental practice brokers and lenders for practice acquisitions. Dr. Douglas was awarded the Business Valuator Accredited in Litigation (BVAL) designation from The Institute of Business Appraisers in 2007. Dr. Douglas has lectured at dental schools in the Southeast and to numerous dental study clubs. He has presented at the Hinman Dental Meeting, the Tennessee Dental Association Conference, several New Orleans Dental Association Meetings, the Rossner Memorial Lecture in New Orleans and a two year series of presentations for Dental Economics. He presented to the National Society of Certified Healthcare Business Consultants from 2006 to 2008. Dr. Douglas is also a contributing author for <i>Dental Economics</i> magazine providing articles and columns on dental practice valuation and transitions. Dr. Douglas has been a member of the Practice Valuation Study Group and a presenter to that group since 1986. LocalMed Brings Real-time Online Scheduling to New Orleans Area Dentistry

The New Orleans Dental Association endorses LocalMed, an online scheduling platform aiming to simplify the entire appointment process for patients and practices alike.

LocalMed is the first live online scheduling platform that allows patients to book real-time appointments online, 24/7. By using direct integration with the practice management systems, LocalMed allows patients to compare availabilities and select the most convenient time and date for them.

Customizable filters and blocks allow the practice to remain in complete control of what patients see and the types of appointments they are able to book.

Unlike current processes, once an appointment is selected, it is a confirmed appointment, not an appointment request, requiring no further contact between the patient and provider.

Appointments booked online by patients are automatically updated to the provider's schedule. The patient is then sent reminders to help ensure the information and timeliness of their upcoming appointment.

LocalMed started as an idea at the Louisiana Business & Technology Center's Student Incubator in 2011. LocalMed gained the attention of former State Sen. Marty Chabert and start-up veteran Keith English. Seeing the potential of LocalMed, English took on the role of visionary founder and CEO.

LocalMed gained attention in early 2014 when they formed a partnership with United Concordia dental insurance, who has over 98,700 dentists and over 7 million members. LocalMed's technology now brings convenience to both United Concordia's members and providers.

LocalMed's "Schedule Now" button can now be found on the United Concordia's *Find a Dentist* page, as well as many of their partner sites such as BCBSLA. Dentists who sign up for LocalMed receive a "Schedule Now" button next to their name, and are featured at the top of the search results.

This marks the first time ever that patients will be able to schedule directly from an insurance company. LocalMed gives patients the ability to easily find and book with an in network dentist without ever having to pick up the phone, day or night.

"After learning about LocalMed's capabilities and their focus on convenience for dentists and their patients, we felt this partnership would deliver a practical service using cutting edge technology at a discounted price to our dentists," said Jim Shade, Vice President of Network Operations and Service at United Concordia.

BCBSLA CEO Mike Reitz added that, "By introducing this feature into the Louisiana dental market, we're able to enhance the customer experience and make their need for convenience a priority. Using LocalMed's technology to connect patients with dentists

in a more convenient manner is revolutionary, and we're proud to offer this technology on our website."

"As a Louisiana-based company, we're excited to work with Blue Cross and Blue Shield of Louisiana—the premier health insurer in Louisiana—and United Concordia to offer this cutting-edge technology to Blue Cross customers," said LocalMed CEO Keith English. "We're proud, too, that this software is filling a void in the dental community that is not currently available," he added.

The service costs dentists \$49.95 a month. United Concordia dentists get a 20 percent discount. English said LocalMed is working on similar arrangements with several other insurers.

LocalMed has big plans for the next year, and online scheduling is just the first step.

They have identified what they call the "appointment process," which includes all steps taken by the patient and provider prior to an appointment. LocalMed wants assist in everything from filling out forms to verifying insurance in order to simplify the entire appointment process for everyone.

Early adopters of LocalMed continue to see positive results after they began offering online scheduling to patients.

"Great LocalMed experience," raves Baton Rouge dentist, Dr. Robert Delarosa. "I had a patient call on a Friday afternoon,

after we had closed for the day, and our answering machine directed her to our website to schedule online. She was easily able to book an appointment for her son after hours. Nice!”

”Dr. Sally Daly of Baton Rouge describes herself as “a huge fan” of LocalMed. “It’s convenient, it’s easy for patients and it’s the sort of solution that fits how the younger

generation searches for providers,” she said.

Additionally, Daly’s office manager, Shannon Hand, said the service helped bring in 10 new patients at a cost far below that of external marketing.

Ultimately, LocalMed’s future plans include an expansion into other medical specialties, but right now their sole focus remains

in dentistry.

LocalMed has expanded rapidly since the software’s launch in May and currently has providers in 25 states and counting.

The Louisiana Mission of Mercy (LaMOM) is sponsored by your LDA Foundation and will be held in Baton Rouge at the Armed Forces Reserve Center, 8110 Innovation Park Dr., Feb. 27-28, 2015. Setup will take place on Thursday, Feb. 26. We need YOUR help, as well as the assistance of your staff, friends and spouse!

Mission Statement: We seek to deliver quality dental care to the underserved population of Louisiana by partnering with dental team members and lay volunteers in a free temporary dental clinic setting.

Volunteering for a Mission of Mercy is an incredible experience you will likely never forget! To accomplish our goals, we plan to do the following at LaMOM:

- Provide free access to dental care and prevention of dental disease while placing a high priority on patients suffering from dental infections or pain.
- Raise public awareness of the difficulty low-income adults and children face in accessing critical dental care.
- Create dental health care advocates via the hundreds of lay volunteers participating in our event.



Preliminary goals for serving our community:

- 1,500 patients, 750 each day, to be seen on a first-come, first-served basis, at no cost to them.
- 200 volunteer dentists to provide diagnosis, treatment and education.
- Up to 1,200 volunteers such as dental team members, spouses, office staff, hygienists, chairside assistants, lab technicians, physicians, nurses, pharmacists, dental students, hygiene students, pre-dental students, dental supply reps, church groups, college service groups, community services groups (Kiwanis, Rotary, Lions Club, St. Vincent DePaul, etc.). Basically, any individual over 18 years of age.
- Financial- and in-kind donations to assist with the purchase of needed dental supplies, food for volunteers and patients, signs, printed materials and much more.

Our budget is approximately \$130,000, but we will be able to provide over \$500,000 worth of dental care because of the donation of time from the Louisiana dentists and other volunteers who will be participating at no cost.

Volunteers, including dentists, are also able to attend from other states. Out-of-state dentists will be approved by the LA State Board of Dentistry for temporary licensure. They may also be eligible for up to 3 CE hours for their participation. ALL VOLUNTEERS WILL REGISTER ONLINE SO THAT WE MAY PREPARE FOOD AND SHIRTS (as well as licensure and liability coverage for doctors and hygienists). WE WILL NOT BE ABLE TO ACCEPT VOLUNTEERS AS WALK-INS. The website will be updated as info is available and the volunteer registration portion will be available in the Fall of 2014.
