## **NODA's 2012 Honor Dentist**

The New Orleans Dental Association will present the 2012 Honor Dentist Award to Dr. Jamie M. Manders during the New Orleans

Dental Association's General Membership Meeting on February 20, 2013 at Five Happiness Restaurant. This award is normally presented at the President's Installation Banquet, but regretfully the honoree will be unable to attend.

Dr. Manders most important contribution to the dental profession has been her work as Chairman of the Dentist Well-Being Advisory Committee. Early in her career, she discovered that dentists in our community are not immune from the disease of chemical dependency. At a continuing education seminar at DePaul Hospital in the mid-1980's titled "The Impaired Professional," she joined forces with four dental school professors who were in the process of creating what would become Louisiana's first Impaired

Dentists Committee (later renamed the Dentists Well-Being Advisory Committee). Dr. Manders soon became the NODA Committee Chairperson and also functioned for approximately two decades as Chairperson of the corresponding LDA Committee. Her work on both Committees was often grueling frightening) (sometimes required a commitment to tracking the rehabilitation of individual dentists over many years. maintains, though, that she has been more than adequately rewarded by

Darrell P. Bourg, Jr., D.D.S. is the 94<sup>th</sup> president of the New Orleans Dental Association. He is a 1990 graduate of Archbishop Shaw High School and a 1996 graduate from the University of New Orleans, with Bachelor degrees in both Chemistry and Biology. He

graduated on the Dean's List in 2001 from LSU Dental School.

With mentorship from Dr. Aubrey Baudean, Dr. Bourg opened his family dental practice in Marrero, now named Exceptional Dental, immediately upon graduation. He currently has a second office in Kenner.

Dr. Bourg concentrates his professional interest in the realm of implant dentistry, where he holds advanced memberships in the ICOI, AAID, and IADI. He is a 2007 graduate of the Medical College of Georgia Maxi Course in Implant Dentistry. He also lectures and provides hands-on courses for general dentists with a desire to

learn more about implants and CBCT imaging technology.

He is married to Ashley Cunningham Bourg from Grand Bay, Alabama. They have two children together: Hadley (5) and Connor (2). They are expecting their third child in May. Dr. Bourg has two older children: Larry (24) and Tori (21). He and his family are members of the First Baptist Church of New Orleans.

Dr. Bourg is part of a research group at UNO, headed by Dr. Elliot Beaton, studying the effects of stress on children with 22q11.2 Deletion Syndrome. His son, Connor, was diagnosed with the syndrome in 2012.

the satisfaction of being able to help many previously highly functional dentists whose professional and personal lives had crashed or were spiraling out of control. This most commonly entailed intervening to require that affected professionals professional obtain addiction therapy, helping them find ways to pay for this therapy, and finding colleagues willing to help them keep their practices from closing during such time intervals. For many years she also worked to increase awareness of the dangers chemical dependency contributing articles about her committees' activities to NODA and LDA publications and by arranging for dentists whose practices (and lives) have been saved to speak to LSU dental students about the dangers of chemical dependency. For this work, she was elected to the Pierre Fauchard Academy. In 2011 Dr. Manders' work earned the LDA an American Dental Association Golden Apple Award Excellence in Dentist Well-Being Activities. Most recently, Dr. Manders spearheaded an initiative in the Louisiana Legislature to transition most of the work of her committee (the activities of which have become far too complex and time-consuming to be performed by busy dental professionals) to a professional mental health organization which will provide services under contract to the LA State Board of Dentistry. This will be her most important legacy to dentistry in Louisiana.

Dr. Manders was a 1963 graduate of St. Mary's Dominican High School in New Orleans, and a 1967 graduate of Louisiana State University in Baton Rouge. receiving her undergraduate degree in foreign languages. After making a decision to pursue a career in health care she returned university in order to earn the necessary science credit hours to apply to dental school for three years as a part-time student (University of New Orleans, beginning in 1972). In 1975 she entered the LSU School of Dentistry (the oldest member of her class) and was graduated in 1979 having earned the distinction of appointment to the C. Edmund Kells Honor society.

Dr. Manders became certified in General and Hospital

Dentistry by completing a two-year residency at Charity Hospital of Louisiana. She did not neglect her continuing dental education, later becoming a Fellow of the Academy of General Dentistry.

Dr. Manders entered private dental practice in Marrero in 1981. She later worked in various West Bank practices before opening a solo practice in Algiers Point in 1989. In 2004 she merged her practice with that of Dr. David Colburn, and continued working with him until retiring in December, 2011.

Dr. Manders has been a member of the New Orleans Dental Association, the Louisiana Dental Association, and the American Dental Association since 1979. Throughout her career she served in all levels of the tri-partite. She was a member of the New Orleans Dental Association Board of



In the waning days December while we were all waiting on the Mayan calendar to run out, three

Tulane Fellows conducted an interview at the NODA office. They consisted of Dr. Talant Abdyldaev, an oral surgeon and Executive Director of the Dental Association of the Kyrgyz Republic, Dr. Maissaa Naji, an endodontist and Director Education Development Center from Syria and Dr. Cinthia Lociks de Araujo, Specialist in Public Policies of Ministry of Health from Brazil.

These fellows are enrolled in the 1 year Hubert H Humphrey Fellowship Program, a Fulbright exchange activity, which brings accomplished professionals from different countries around the world to the United States at a mid-point in their careers for a year for study and related practical professional experience. Fellows from nine countries. The fellows who visited NODA office were interested in wide spectrum of questions such as:

It is hard to believe that we left New Orleans almost 13 years ago. I miss the contact with my NODA friends and particularly my association with the New Orleans Dental Conference. However, retirement is great. We chose to relocate to Hilton Head Island in part because there is a Volunteers in Medicine (VIM) clinic, and also partly because we found a home where we could have a boat at the bottom of the garden (a sailor's dream). VIM is a free clinic and patients qualify for treatment on the basis of financial need and whether they live or work on the Island.

I wasn't ready to give up dentistry entirely so the VIM clinic was a perfect match for me. This particular clinic was the first VIM in the country and the model for many others that have followed. I had to obtain a Volunteer Dental License unless I wanted to take the South

Carolina Board (which I didn't!). This involved going to Charleston and cutting and restoring a couple of plastic teeth and taking a jurisprudence exam. Guess what — the physician volunteers don't have to do anything to get a volunteer license except the jurisprudence test. Today, South Carolina participates in licensure by credentials for dentistry - which would have been much easier.

When I started working at the clinic we had two operatories. Later another small room was added for our pediatric hygienist. Most of the work is restorative and extractions. There is no crown and bridge but we make some dentures. We do limited endodontics because, unfortunately, our patients usually cannot afford to get a crown and we end up extracting posterior teeth later anyway.

About two years ago the local Rotary Club invited us to apply for some significant funds to enlarge our dental department. We were fortunate enough to be selected to receive the Rotary grant. Some other good friends of the dental department gave and raised the rest of the money needed to build our new dental clinic. We now have an eight operatory clinic in an adjacent building to the main medical clinic. We have about 18 volunteer dentists and many volunteer assistants. Paid staff includes two hygienists, two assistants and part-time administrator. I have become the Dental Director by virtue of my longevity. The photograph, taken in state-of-the-art our sterilization

center, shows me with Lois Schuhrke our administrator and our South Carolina governor Nikki Haley when she paid us a visit.

Since we have lived in South Carolina we have become grandparents of 10 grandchildren (5 boys and 5 girls). They all live in Austin, Texas along with our four children and their spouses. We are debating whether we should relocate to Texas ourselves but currently we visit two or three times a year. As well as working one day a week at the clinic, I am enjoying our life in our community of Wexford. I try to play golf and my husband and I play bridge together. We are very involved in the social activities at Wexford and are enjoying a happy retirement
