Topic (AM) – "Capsulitis, Trismus or Non-Reducing Disc Displacement? Diagnosis and Treatment of Temporomandibular Disorders Common to the General Dental Practice"

Craniofacial pain and TMJ disorders are often confusing and difficult to accurately diagnose and treat. The diagnosis and treatment of obstructive sleep apnea and snoring has exploded! Dentists are uniquely placed as primary care clinicians to be instrumental in the screening, referral and treatment of patients with sleep apnea and snoring problems as part of a medical/dental team. Oral appliance therapy has become a first line therapy for many patients, and is often the only viable hope for patients who have given up on CPAP. This lecture will give the attendee the background and tools they need to literally save the lives of patients with obstructive sleep apnea.

- The basics of normal sleep and sleep disordered breathing.
- To screen their patients for possible sleep disorders.
- To work as part of the medical/dental team in the treatment of patients with obstructive sleep apnea and snoring.

New Orleans Dentist Receives LDA Distinguished Service Award

Dr. Donald R. Toso, of New Orleans, LA, was named this year's recipient of the Distinguished Service Award

that was presented during the 133rd House of Delegates of the Louisiana Dental Association (LDA) on March 9, 2013, at the Shreveport Convention Center.

The Distinguished Service Award is the highest honor bestowed by the LDA and is presented annually to individual members who exemplify the highest standards of professional conduct in dentistry and make extraordinary contributions in organized dentistry and their community.

Dr. Toso has been a member of the LDA, the American Dental Association (ADA) and the New Orleans Dental Association (NODA) for over 46 years. He has served in numerous capacities in the local, state and national arenas, including his position as LDA president from 1986-1987. He was also chairman of the Council on Dental Health in 1973 and LDA's secretary treasurer from 1983-1985.

Dr. Toso served in many leadership positions within NODA, including serving as the president in 1978. Dr. Toso also served as 2008 chairman of the New Orleans Dental Conference and LDA Annual Session. His involvement at the ADA level included membership in the House of

NODA Bylaws Change Proposal

BACKGROUND

B e c a u s e President-Elect Dr. Claudia C a v a l l i n o resigned due to her appointment

on the Louisiana State Board of Dentistry and 1st Vice President Dr. Raymond Unland, Jr. automatically moves up to President-elect, under the current Bylaws the President temporarily appoints the new 1st VP unless the Board of Governors orders an election. This person automatically moves up to President Elect in 2014 and President in 2015. As a result, unless the Board of Governors orders an election

(optional) NODA will have an unelected President in 2015. This should not happen.

Additional questions arise about the term "temporarily." It is not clear in the current Bylaws as to how the temporary appointment is resolved.

PROPOSED BYLAWS CHANGE

Therefore I propose the following language change by addition of new Section 11 in Article XIV. This proposal passed the NODA Board of Governors on March 6 and is presented to the general membership for approval. The vote on this proposal will be at the May 15 general membership meeting:

The election to fill the temporary position(s) for the vacancy(s) will be held as follows: (i) President convenes nomination committee to receive nominations immediately upon the receiving the resignation; (ii) the nomination committee will then officially ask for nominations via standard mail, or NODA News if NODA News is circulated within 2 weeks of the vacancy); (iii) special election will be held within one month following the initial call for a special election previously sent via e-mail, standard mail, or NODA News; (iv) the election will proceed as the described in Articles VI, XIII, and XIV.






