# NODA MEMBER HELPS SAVE A LIFE AT **DENTAL CONFERENCE**

of our members. Dr. Frank Martello, is hero. Friday, April 15, 2011, while attending

lecture at the New Orleans Dental Conference, he noticed a fellow attendee's head had fallen back from his chair. As people began to clear space around the unconscious man, Dr. Martello quickly assessed that the victim had no pulse and was not breathing. He quickly began CPR, aided by Dr. Louis Malcmacher, the speaker of the

presentation. As the man began to turn blue, Dr. Martello, trained in Advanced Cardiac Life Support, began to give chest compressions. Someone called 911 and the EMS arrived with the Automatic External Defibrillator. The AED delivered two shocks before normal cardiac rhythm was established. Martello stated that "he could have done CPR forever, but the victim wouldn't have come without the AED, and the support of the EMS, paramedics and cardiologist. Being prepared and running routine drills in basic CPR essential to handling are

emergency whether in the office or other surroundings."

Minutes later, Dr. Martello gave a moving invocation at the Pierre Fauchard Academy luncheon stating that we should all appreciate the value of life, for tomorrow is promised to no one.

A grateful doctor is alive today and back at his dental practice, because of the expert response of Dr. Frank Martello.

# **Support the Flexible Spending Account Amendment in the Senate**

Senator Hutchison (R-Texas) has introduced The Patients' Freedom to Choose Act as an amendment to the Economic Development Act (S. 782) currently being considered by the Senate. Sen. Hutchison's amendment repeal would limitations Flexible put on Spending Accounts (FSAs) in the Patient Protection Affordable Care Act (PPACA). A vote is expected early next week. In the interest of time, we need you to contact your Senators as soon as possible and urge them to vote for amendment # 468. Patients' Freedom to Choose Act when it comes to the floor.

Without this amendment the PPACA will restrict FSAs to a

Bailey \$2,500 limit beginning in 2013. The PPACA also would prohibit people from using FSA funds to purchase over-the-counter medication Act (S. without a doctor's prescription. Sen. Hutchison's amendment repeals the arbitrary \$2,500 cap on FSAs and repeal the prescription requirement for over-the-counter medication.


"These are major companies," said Hender. "It was a compliment to the dental school that so many agreed to participate in this first-time event."

# **American Academy of Pediatrics Changes**

There are two big and exciting changes at the American Academy of Pediatrics (AAP) related to oral health. First, in May, the AAP Board of Directors approved the name change of the AAP Section on **Pediatric** Dentistry and Oral Health. From this point forward, the Section will be named the Section on Oral Health with the acronym SOOH. This name change was proposed to better mirror the AAP's overall efforts to improve children's oral health. The AAP continues to welcome pediatric dentists as Associate Members ofAcademy and as our close allies in this work, but hopes that this name will further the outreach to pediatricians to get involved in oral health.

Second, the AAP has launched a new Children's Oral Health Weh Site www.aap.org/oralhealth. We hope that this site will continue to offer many of the resources existing previously, but in a more streamlined and easy to navigate format. We will continue to improve the Web site as we complete new oral health practice tools and other helpful resources. The new site is located at the same URL as the old site www.aap.org/oralhealth. A couple of things to note about the new site:

1.) The AAP has endorsed the Society for Teachers of Family Medicine Smiles for Life National Oral Health Curriculum. The child-focused modules of this curriculum will replace the former AAP Oral Health Risk Assessment 1-Hour Training that many of you may have taken as required training for Medicaid payment for caries prevention services or other reasons. A decision was made to remove that learning opportunity from the site and to recommend to all of you that Smiles for Life be used for this purpose. Smiles for Life will be able to produce certificates with the necessary information for completion for training requirements. It may be necessary to inform Medicaid in some states of this change. Pediatricians can self-report continuing medical education credits earned from Smiles for Life For information, visit the Web page http://aap.org/oralhealth/SmilesFo rLife.html.

2.) The more comprehensive, Protecting All Children's Teeth Curriculum http://www.aap.org/ORALHEAL TH/pact/index.cfm was updated and is still available on the Web site. It offers an online training for physicians. well as as presentations for download to be used for medical school and residency training. Continuing medical education credit is still available and certificates are issued by the AAP.

3.) If you had links on your Web site to the previous Oral Health Initiative Site, please check them to make sure they still work and correct if needed. For assistance, contact Lauren Baron.

# Former New Orleans Dentist Receives LDA Distinguished Service Award

the 131st Annual Session of the Louisiana Dental Association (LDA) on April 16, 2011, at the New Orleans Morial Convention Center.

The Distinguished Service Award is the highest honor bestowed by the LDA and is presented annually to individual members who have exemplified the highest standards of professional conduct in dentistry and have made extraordinary contributions in organized dentistry and their community.

Dr. Reeder grew up in Luverne, AL, and was valedictorian of his 1964 graduating class. Dr. Reeder graduated summa cum laude from Auburn University in 1968 and with honors from the University of Alabama at Birmingham School of Dentistry in 1971. Dr. Reeder earned his certificate in Endodontics from the Medical College of Georgia in 1976. He served as a general dentist in the U.S. Air Force from 1971-1973.

Dr. Reeder has been a member of the LDA, the American Dental Association (ADA) and the New Orleans Dental Association (NODA) for over 39 years. He has served the LDA in many capacities, including at-large member of the

Executive Council, director to the Political Action Committee (PAC) and chair of the Council on Membership. While a member of NODA, Dr. Reeder served on and chaired most committees including the Honors and Awards, Council on Membership and Dental Practice, Executive Office. Long-Range Relations, Planning, Public Nominating United and Way committees, and held most offices culminating in serving as president in 1989-90. Dr. Reeder served as director to the LDA Board of Directors for six years. He was also active in the New Orleans Dental Conference in various capacities during his years as a member of NODA

In addition to his services to the LDA. NODA and New Orleans Dental Conference, Dr. Reeder also served the ADA in the Membership Recruitment & Retention Field Services Program, and as a member Local Arrangements the Committee and the House of Delegates Reference Committee on Dental Benefits, Practice and Health. He was a delegate to the ADA House of Delegates for six vears.

Dr. Reeder has been a member of the American Association of Endodontists since 1974, during which time he served on the Committee on Governmental Affairs. He also is a member of the New Orleans Endodontic Study Group, Louisiana Association of Endodontists (LAE), the Southern Endodontic Study Club, and the Southwest Society of Endodontists.

Among other services to the dental profession, Dr. Reeder was assistant professor and clinical associate professor of Endodontics and co-founder and coordinator of endodontic specialty postgraduate program at Louisiana State University School of Dentistry. After retirement from the practice of endodontics, Dr. Reeder became the executive director of the American Society of Dentist Anesthesiologists.

In addition to this award, Dr. Reeder is also a fellow of the American College of Dentists, a fellow of the International College of Dentists and was the Honor Dentist of the New Orleans Dental Association in 2002.

Dr. Reeder and his wife Mary now live on Beaver Lake in the Ozarks, outside of Eureka Springs, AR.

## **Update on Botox/Filler use by DDS/DMD**

the Louisiana State Board of Dentistry's recent Notice of Intent (NOI) on the use Botox®

(botulinum neurotoxin) and dermal fillers can be found online in the Louisiana Register, Vol. 37, No. 02. In essence, the NOI says that dentists who want to use Botox or dermal fillers should receive training, either in CODA-approved educational institution or through an approved CE entity. This training must include classroom and live patient hands-on components, and cover the following; patient assessment esthetic and/or therapeutic indications and treatment.

Details of contraindications for use, safety and risk issues, proper preparation and delivery techniques, and knowledge and management of possible complications. Botox and dermal fillers will only be administered in dental offices, using universal precautions, and dental auxiliaries are prohibited from administration of these substances.

> The greatest opposition to our use of Botox and dermal fillers comes from our medical colleagues, who assert that we are not trained or competent enough to inject these materials in the head and neck area, nor are we capable of handling any complications that may arise. The Board has addressed these issues in two meetings with members of the LA Board of Medical Examiners and the local dermatological society

- these groups seek to prohibit the use of Botox and dermal fillers by dentists for esthetic purposes. In my opinion, and that of many of my colleagues, we know more medicine than our physician friends know dentistry. Our training and daily experience in head and neck anatomy, injection techniques, and dealing with potential complications puts us in a unique position to offer Botox and dermal fillers for our patients' benefit.




