Sabey Joins Endodontics Faculty



Kent A. Sabey, D.D.S., been has appointed assistant professor in the Department Endodontics at

LSUSD. He will serve as program director for the advanced education program, supervising the nine residents in the program. His appointment was announced by Dr. Himel, chairman of the department.

Sabey received his Bachelor of Science degree in 1979 from the University of Arizona in Tucson. Three years later, he was

awarded a DDS degree from the University of the Pacific School of Dentistry in San Francisco. He had a private dental practice in Tucson, Arizona, from 1982 to 1990, after which he began serving in the US Air Force (USAF). In 1999, he completed a two-year advanced education in general dentistry residency at Wilford Hall Medical Center located at Lackland Air Force Base in San Antonio.

2006. Sabey completed a second residency at Wilford Hall. this time endodontics. He was then appointed assistant professor of endodontics at USAF Postgraduate Dental School, where he taught for over four years,

overseeing 20 residents.

Dr. Sabey has received board certification by the Federal Services **Board** of General Dentistry, the American Board of General Dentistry and the American Board of Endodontics.

During his 21-year military career, he also practiced at MacDill USAF Base and Hurlburt Field, both in Florida, as well as Kadena Air Base in Okinawa, Japan. Since 2007, he has worked with the American Board of General Dentistry in creating and teaching the endodontic portion of its annual review course.

Louisiana House Bill 628 was passed and signed into law on June 23, 2011. The bill authorizes the LSU Board of Supervisors to increase tuition and fee amounts for the LSU Health Sciences Center - New Orleans Schools of Medicine and Dentistry and the LSU Health Sciences Center - Shreveport School of Medicine It was filed originally by Representative Walt Leger.

The efforts of the dental community, both individuals and groups, assisted in helping to pass this important bill. I am grateful as its impact on the dental school is significant. The additional funds will help to offset some of our recent budget reductions and further enhance mission of education. our research and patient care.

2011 SCHOLARSHIP RECIPIENTS NAMED

Funds to be used by Louisiana students entering medical school across state

For the eleventh consecutive year, four in-state students will continue their higher education in the medical field; thanks to recent merit awards from the Louisiana Medical Mutual Insurance Company.



I want to take this opportunity to ask you to consider joining the 300+ volunteer dentists in Louisiana who participate in Donated Dental Services (DDS), a project of Dental Lifeline Network.

The program is so easy to do.

- You see patients in your own office, on your own schedule where you are most efficient.
- You review the patient profile in advance and decide who you want to see. You are free to accept or decline any patient
- There is no paperwork to complete
- The program is designed to treat the patient to completion: initial exam to final phase 2 treatment. You determine your own treatment plan.
- There are no lab fees lab work is provided.
- Specialists participate in the program so there is no need to treat beyond what you feel comfortable in doing.
- Patients are reliable, and very grateful for what you do.

The Donated Dental Services (DDS) program helps patients like Mr. H, a 50 year old Jefferson Parish resident who is blind, developmentally delayed. Almost two years ago, Mr. H was stabbed in his right eye during a robbery. Although the thief was caught, the accident left Mr. H almost completely blind. He must live with his mother who helps care for him. He recently began attending the lighthouse for the Blind and is able to do simple chores around the house with supervision. Mr. H has neglected dental issues, but could not afford the expensive treatment he needed. He and his mother survive on her retirement benefit, his Social Security Insurance and food stamps, all of which just cover their monthly bills. Two generous DDS volunteers came to his aid. A general dentist extracted four teeth, restored two other teeth and donated a lower partial denture. A volunteer lab fabricated the denture at no charge. This kind team provided \$2487 in care to restore Mr. H's smile. He wrote a note to express his true appreciation for this gift:

"You will never imagine how much this meant to me. The gift of being able to chew and digest my food is like a new life. I also appreciate the gift to smile. LA Donated Dental Services is a blessing to citizens who cannot afford dental care. This is a much needed service in Louisiana. Thanks again for the wonderful group of people who provided me with the excellent professional care."

Thank you for your consideration in this humanitarian effort. Your participation makes a huge difference in the lives of our clients, and is something we can point to with pride. I've found this project to be very rewarding and I think you will also. And if you ever have any questions about the program, please call me personally.
