### 2010 Give Kids A Smile Day

Greetings to all NODA Members, On Friday, February 5, 2010, the annual Give Kids A Smile

(GKAS) event was held at LSU Dental School in the pediatric dentistry department. NODA member and LSU pediatric dentistry professor, Dr. Janice A. Townsend, along with community groups New Orleans Catholic Charities and Common Ground helped to coordinate this event. LSU dental students, pediatric dental residents, and NODA dentists volunteered to perform exams, cleanings, oral hygiene instruction, x-rays and treatment plans. Our goal is to provide these children with a

permanent dental home in the office of a NODA dentist.

We screened 20 children ages 4 to 17. All of these children were uninsured and it was the first dental visit for 60% of them. 75% of the children had untreated decay with 25% having decay severe enough to need a root canal or extraction of a permanent tooth. Each child received an examination, prophy, fluoride, and appropriate x-rays. Using current Medicaid fees these services would cost \$143.76 per child. This is a total of \$2,875 in donated care and this does not take into consideration the services that may be donated by NODA dentists in treatment.

As mentioned previously,

all of the children screened had no dental insurance and did not qualify for Medicaid. It was an eye opening experience to see these children and their unique obstacles to care that extend beyond financial limitations. They usually are not seen until problems reach a crisis and can have serious repercussions.


The President's Banquet is



### **Bylaws Change Notice**

As per Article VIII of the New Orleans Dental Association Bylaws, this is the official notification to the membership of several Bylaw changes which was introduced at the February 24<sup>th</sup> General Membership meeting and will be voted on at the March 24<sup>th</sup> General Membership meeting. The Board of Governors has approved this change to the Bylaws.

### ARTICLE XVI (Dues and Assessments) - Section 1

The annual dues of the active members of the New Orleans Dental Association shall be one hundred fifty dollars (\$150) in addition to the dues of the Louisiana Dental Association and the American Dental Association.

#### "Be is resolved that the wording of Section 1 of Article XVI be deleted, and replace it with the following wording."

The annual dues of the active members of the New Orleans Dental Association shall be two hundred dollars (\$200) in addition to the dues of the Louisiana Dental Association and the American Dental Association.

### ARTICLE XVI (Dues and Assessments) - Section 5a

Effective with the 2005 dues billing and thereafter, dentists who become members of this Association shall be exempt from payment of New Orleans Dental Association dues for the year of their graduation from dental school or completion of advanced training as specified in

ARTICLE IX, Section 5a, as well as for the first full calendar year following the vear in which the dental degree was received, or advanced training was completed. In 2005 only, the new member shall pay twenty-five percent (25%) of active member dues in the second year, seventy-five percent (75%) in the third vear, and one hundred percent (100%) in the fourth year and thereafter in accordance with Section 1 of this ARTICLE. In 2006 only, the new member shall pay twenty-five percent (25%) of active member dues in the second year, fifty percent (50%) in the third year, and one hundred percent (100%) in the fourth and thereafter vear in accordance with Section 1 of this ARTICLE. In 2007 and thereafter, the new member shall pay twenty-five percent (25%) of active member dues in the second year, fifty percent (50%) in the third year, seventy-five percent (75%) in the fourth year, and one hundred percent (100%) in the fifth year and thereafter in accordance with Section 1 of this ARTICLE. These exemptions of dues may be granted to an individual member only once and shall not apply to any dues or assessments required by the Louisiana Dental Association and the American Dental Association. Those members, other than recent graduates selected to Active Membership in this

Association after July first, except for those where membership has lapsed for failure to pay the current year's dues, shall pay one half ( $\frac{1}{2}$ ) of the current year's dues, and those selected after October first shall pay one quarter ( $\frac{1}{4}$ ) of the current year's dues.

#### "Be is resolved that the wording of Section 5a of Article XVI be deleted, and replace it with the following wording."

Dentists who become members of this Association shall be exempt from payment of New Orleans Dental Association dues for the year of their graduation from dental school or completion of advanced training as specified in ARTICLE IX, Section 5a, as well as for the first full calendar year following the year in which the dental degree was received, or advanced training was completed. The new member shall pay active member dues in the second year of twenty-five percent (25%), in the third year fifty percent (50%), in the fourth year seventy-five percent (75%) and in the 5<sup>th</sup> year one hundred percent (100%) and thereafter in accordance with Section 1 of this ARTICLE. These exemptions of dues may be granted to an individual member only once and shall not apply to any dues or assessments required by the

Louisiana Dental Association and the American Dental Those Association. other members, than recent graduates selected to Active Membership in this Association after July first, except for those where membership has lapsed for failure to pay the current year's dues, shall pay one half  $(\frac{1}{2})$  of the current year's dues, and those selected after October first shall pay one quarter  $(\frac{1}{4})$  of the current year's dues.

### ARTICLE XVI (Dues and Assessments) - Section 13

The Fiscal Year of this Association shall be April 1 through March 31.

"Be is resolved that the wording of Section 13 of Article XVI be deleted, and replace it with the following wording."

The Fiscal Year of this Association shall be July 1 through June 30.

Van T. Himel, D.D.S., is Professor and Chair of the Department of Endodontics at the LSU School of Dentistry. He

is a native of Louisiana having been born in Port Allen and lived in Lafayette from fifth grade through graduation from LSU. He received his dental degree from Louisiana State University, School of Dentistry in 1973.

After two years in the Air Force and five years of private dentistry practice general in Lafayette he returned to LSU for graduate training in Endodontics. Upon completion of his graduate training he joined the faculty of LSU where he served as head of the Endodontic graduate program. He then served in various capacities including department chair of Biologic and Diagnostic Sciences at the University of Tennessee Health Science Center for 20 years. Dr. Richard W. Ballard is a returning member to NODA. He came to practice in Metairie in 1996 when he assumed the

orthodontic practice of the late Dr. David Hoffman. He was an active NODA member until 2005 when Katrina destroyed his Metairie orthodontic office and he moved his full time practice to Mandeville where he lives with his wife of 24 years and their nine year old son. He grew up in a rural area between Baton Rouge and Hammond where he developed his strong love of LSU sports.

After graduating from Southeastern Louisiana University, he taught high school for a short time before attending dental school. He graduated from LSUSD in 1992 where he received numerous honors such as membership into OKU, Kells Honor Society, and the Chancellor's Award. He was accepted into the Orthodontic residency program at LSU which he completed in 1994. One of his most honored achievements came in 2005 when he became a Diplomate of the American Board of Orthodontics.

### Dr. Charles McCabe Elected President of LSBD



C h a r l e s McCabe, D.M.D., has been elected president of the Louisiana State Board of Dentistry, the licensing board

for the 2,493 dentists and 2,016 dental hygienists practicing in Louisiana. This will be his second term as president of the board. This year marks his 14<sup>th</sup> year of service on the board during which he was active in formulating legislation to regulate oral conscious sedation.

Dr. McCabe is an associate professor in the Department of Periodontics at the LSU School of Dentistry. He has been affiliated with the school since 1982. He received his DMD from the University of Pittsburgh in 1976 and completed specialty training in periodontics at the Boston University School of Graduate Dentistry in 1980.

In 1995, he became a diplomate of the American Board of Periodontology. He is also a member of the Pierre Fauchard Academy. He maintains a private practice limited to periodontics in suburban New Orleans. The state board is a division of the Louisiana Department of Health and Hospitals. Its main responsibilities are to ascertain the fitness and ability of dentists and hygienists to practice, help write legislation to serve the public through dentistry and prosecute violations of the Dental Practices Act

### "In Memoriam"

#### Anthony J. Lala, D.D.S.

Dr. Anthony J. (Tony) Lala, age 79 and resident of Metairie, passed away on Wednesday, February 10, 2010. Beloved husband of Nathalie LoCoco Lala. Loving father of Anthony J. Lala, Jr. and Jenifer O'Quinn (Timothy), Timothy Grandfather of Ρ. O'Quinn, Jr., and brother-in-law of Vincent T. LoCoco. Dr. Lala was a parishioner of St. Angela Merici Church.

#### Alvin W. Nolan, D.D.S.

Dr. Alvin W. Nolan. an orthodontist who treated thousands of New Orleans area high school students over a 40-year career, died surrounded by family at his home on Sunday. He was 89. Reared in the 1920s and 1930s in a boisterous Irish Catholic family in Algiers Point. Al Nolan reflected his neighborhood origins all his life. He was deeply faithful to family, as well as strong-willed, gregarious and funny. He also nourished a deep personal faith. A man of forceful convictions. whether political, social or sports-related, he was nonetheless quietly generous, with a special affection for children and the elderly.

From the 1940s to the 1980s, Dr. Nolan practiced orthodontics in New Orleans and Algiers. But friends understood his heart was rooted at a lake house in Lakeshore, MS. Destroyed three times by hurricanes and rebuilt each time - twice by Dr. Nolan himself the Nolan lake house for five decades was a place of open and continuing hospitality for a large circle of friends and family. Nearer home, Dr. Nolan was a founding member of St. Andrew the Apostle Parish in the early 1950s and that community's helped set foundations. For that and other work. awarded he was the Archdiocese of New Orleans' Order of St. Louis.

In his youth, Al played second base and was one of the last members surviving of the Shamrocks, an Algiers-based team. attended Loyola Later he University, became an honors graduate of that university's dental school and received his orthodontic training at the University of Michigan. Dr. Nolan served as a dentist in the Navy in World War II. Operating under strict wartime secrecy not lifted for decades, while in England he helped identify remains of American and English sailors and soldiers killed by German E-boats in Exercise Tiger, a rehearsal before the D-Day invasion.

He has been a member of the LSUSD faculty since 1981 and promoted to Associate was Professor in 1986. From 1989 to 1995, he was director of the General Dentistry Residency program. From 1995 to 2006, he was chairman of the Department of General Dentistry. Since 2006, Dr. Ritchie has been Director of Diversity and Minority Affairs.

In the aftermath of Hurricane Katrina, he played a vital role in developing a network of community dentists to provide clinical training for fourth-year students.

For the last 26 years, he has had a private practice in the LSUHSC School of Dentistry Faculty Dental Practice.

To do this, our message must reach parents of all Medicaid-eligible children concerning the ready availability of treatment within a dental home.

The Jefferson Parish school board has disseminated oral health information to the parents and guardians of all 44,000 Jefferson Parish public school children (JP school officials estimate that 90% of their students have Medicaid or are Medicaid-eligible). This information includes:

1.) An LDA brochure advocating the importance of oral health while strongly encouraging parents to schedule a dental appointment.

2.) A letter to parents explaining what services the dental Medicaid program covers and how to determine if their child is Medicaid-eligible.

3.) A list of dental Medicaid providers for East and West Bank.

4.) A Dental Health Record (exam form) to be completed by the dentist.

In the upcoming weeks and months Medicaid providers can expect parents to call your office for an appointment. JP school officials have asked parents to have their child's dental exam completed before May 7, 2010, so that all paperwork can be completed before the school year ends. When a patient presents to your office, we ask that once you have completed his/her dental exam, fill out the brief Dental Health Record form and fax it back to the child's school.

Your participation and cooperation is vitally important to the success of our program. Once successful in Jefferson Parish, our goal is to implement the LDA's program statewide.

### **IS FIRST DATA RIGHT FOR YOU?**

The NODA membership will learn more about this topic and other personal electronic security issues at the seminar on "Identity Thief and Cyber Crimes."

### Tell me about the new technology coming.

The new technology is the Touch less Payment using the Radio Frequency Chip. This RF Chip is implanted in your credit card. While you are a small distance away from a Touch less Payment receiver you simply tap your credit card and the transaction payment process is initiated. If you visit one of your local drug stores like Walgreen's or CVS, the payment terminals have been updated to accept this new technology. Some NODA members who have signed on recently currently have this technology. Although this technology is slowly arriving in the United States, consumers in Europe and Japan are using their cell phones with this technology. You simply tap the cell phone and the transaction is initiated.

Besides the innovative technologies, what are the benefits to the NODA Members in using First Data services?

The first benefit and the most important is the attractive low processing rate structure. Another benefit, comparing your current processor with First Data processing rate is made easy. My process is simple. By installing a pin pad, the savings generated in processing fees can cover the cost of the new terminal technology. This alone is a good reason to change over to the First Data credit card processing program!

I have personally installed and train the staff on the correct usage of the equipment and the verbiage associated with asking for payment using the debit card. The verbiage goes like this, "will that be cash or would you like to use your debit card?" This statement alone will generate savings when the patient uses his or her debit card.
