Dr. Guy Ribando is NODA's Honor Dentist for 2007

At the President's Banquet in March, Dr. Guy Ribando has been selected to receive the 2007 NODA Honor Dentist Award. Dr. Ribando has been a member of NODA, LDA, and ADA since he graduated from Loyola University's Dental School in 1965 where he was a member of Xi Psi Phi Dental Fraternity. He began his private practice of dentistry in Marrero, LA that same year. He has been a member of the NODA Board of Directors, culminating with his Presidency in 1999. He has served on the LADPAC committee for the LDA. He is also a member of the International College of Dentists and the Pierre Fauchard Academy Society.

Outside of dentistry, Dr. Ribando has served as a past president, deputy district governor, secretary, and board member of the Marrero Lions club in Marrero. He has also been a member of the Knights of Columbus, the Order of Alhambra, the Barrataria Blvd. Civic Association, Board of Trustees of Saint Pius X Catholic Church, and Padua Community Services. He serves as a Lector and Eucharistic Minister for the visitation of Our Lady Church in Marrero and St. Anthony Catholic

Dr. Ribando also served as a missionary dentist from 1989-1997 in Saltillo, Mexico. As president of NODA, he established the NODA missionary dentistry committee.

Dr. Ribando has been married to Diane Aycock since 1960 and together have 5 children: Maria Burmaster, DDS; Valerie Hemphill, DDS; Andrea Ribando, DJP; Thomas Ribando, BA; and Guy Ribando, III, DDS.

THE CAP IS BACK

On February 2, the Supreme Court of Louisiana vacated the Third Circuit Court of Appeals judgement that the medical/dental malpractice cap was unconstitutional. However, it was only overturned on a technicality. They didn't say that the adequate remedy argument to reach a decision since the plaintiffs hadn't included it in their motions.

Ward Blackwell, Executive Director of the LDA, feels that there will still be a consensus medical/dental malpractice bill filed in the upcoming legislative session, which begins on April 30. He also feels that it is just a matter of time before someone else files a suit in the Third Circuit based on the adequate remedy argument unless there is a statutory change. This is the "fiscal only" session of the Louisiana Legislature. Each legislator is only allowed to file 5 non fiscal bills.
