# Bylaws Change

As per Article VIII of the New Orleans Dental Association Bylaws, this is the official notification to the membership of a Bylaws change that has been introduced at the February General Membership meeting and will be voted on at the May General Membership meeting.

The Board of Governors has approved this change to the Bylaws. *The intent of the change would allow the members of the LDA who serve on the New Orleans Dental Conference committee the right to vote on issues*

*that are only Conference related.*

## ARTICLE NINE Section 9A

All voting powers, privilege of holding office, and property rights of this Association shall be vested in active, life, and retired members, to the complete exclusion of all other classes and/or types of membership in this Association.

***"Be it resolved that the wording of this Section 9A of Article Nine of the***

***C&B be deleted, and replace it with the following wording."***

## Section 9A

**Voting powers, privileges of holding office, and property rights of this Association shall be vested in active, life, and retired members. By a majority vote of the NODA Board of Governors, limited and specific voting powers within a committee of NODA can be given to ADA members.**
