BHS Disciplinary Report

Visit www.michigan.gov/lara to access the latest disciplinary reports for dentists, registered dental hygienists, and registered dental assistants. You may also check any licensee for disciplinary actions at the same web address.

Self-Reporting of Criminal Convictions and Disciplinary Licensing Actions

Section 16222(3) of Michigan's Public Health Code requires any licensee or registrant to self-report to the Department of Community Health a criminal conviction or a disciplinary licensing or registration action taken by the state of Michigan or by another state against the licensee or registrant. The report must be made within 30 days after the date of the conviction or action. Convictions and/or disciplinary actions that have been stayed pending appeal must still be reported.

Should the licensee or registrant fail to report, and the Department becomes aware of the conviction or action, an allegation will be filed against the licensee or registrant. Sanctions for failing to report can include reprimand, probation, suspension, restitution, community service, denial or fine. In recognition of Mental Health Awareness Month, the MDA will present "QPR: Protocol for Inspiring Hope to Individuals Experiencing Suicidal Crises," a live webinar taking place Wednesday. May

15 from 7 until 8:30 p.m. Eastern time. The speaker will be Juliette Daniels, EdD, with 1.5 hours of CE credit.

QPR stands for *Question, Persuade,* and *Refer* — three steps anyone can learn to help save a life from suicide. Just as people trained in CPR and the Heimlich Maneuver help save thousands of lives each year, people trained in QPR learn how to recognize the warning signs of a suicide crisis and how to question, persuade, and refer someone to help.

The speaker is the assistant dean of student services and enrollment management at the University of Detroit Mercy School of Dentistry. She is a trained suicide prevention protocol trainer and a Deputy Title IX Coordinator.

As Daniels says, "QPR Training reinforces that quality education empowers all people, regardless of their background, to make a positive difference in the life of someone they know."

At the end of the course, attendees will be able to identify:

- the warning signs of suicide.
- risk and protective factors for suicide.
- how to help someone in a mental health crisis.

MDHHS Announces Water Fluoridation Quality Recipients

The Michigan Department of Health and Human Services Oral Health Program on Jan. 23 announced the Water Fluoridation Quality Award recipients from the U.S. Centers for Disease Control and Prevention. The award recognizes communities that achieved excellence in community water fluoridation by maintaining a consistent level of fluoride in drinking water.

"Fluoride is a mineral that prevents tooth decay and supports healthy bones," said Dr. Natasha Bagdasarian, chief medical executive. "These awards demonstrate the commitment to quality by these community water systems. Water fluoridation benefits all residents and it has demonstrated its effectiveness in preventing tooth decay throughout an individual's lifetime."

"Water fluoridation is one of the best investments that a community can make in maintaining the oral health of its citizens. It is equally as effective in preventing cavities in children and adults," said Gina Thornton-Evans, DDS, MPH, acting director, CDC Division of Oral Health. "Fluoridation is also highly cost-effective. Studies continue to show that for every \$1 a community invests in water fluoridation, \$20 are saved in dental treatment costs."

Community water fluoridation has been recognized by the CDC as one of 10 great public health achievements of the 20th century. The CDC recommends water fluoridation as one of the most practical, cost-effective, equitable, and safe measures a community can take to prevent tooth decay and improve oral health.

In 2022, a total of 1,209 public water systems in 27 states received these awards, including 75 systems in Michigan. Fenton, Frenchtown Township, Gladstone Water Dept., Grand Ledge, Grand Rapids, Gratiot Area Water Authority, Harbor Springs, Hillsdale, Holland board of Public Works, Howell, Huron Shore Regional Utility Authority, Ionia, Jackson, Jonesville, K.I. Sawyer, Kalamazoo, Lake Odessa, Lansing Board of Water and Light, Linden, Lowell, Ludington, Manistique, MHOG Sewer and Water Authority, Marquette, Marshall, Marysville, Mason, Menominee Water Dept., Midland, Milford, Monroe, Munising, Muskegon, Negaunee-Ishpeming Authority, New Buffalo, Northwest Ottawa County Water System, Otsego, Ravenna, Saginaw, Sault Ste. Marie, Schoolcraft, South Lyon, Sparta, St. Clair Water and Sewer Authority, St. Ignace, St. Joseph, Standish, Sturgis, Summit Township, Tecumseh, Union City, Wakefield, Wayland, West Branch, and Wyoming.

Livingston Dentists' Gold for Food Program Raises \$46,793

The Livingston County Gold for Food Program, in which money is raised from donated extracted teeth and given to the Gleaners Food Bank of Livingston County, during the past year collected \$23,396, a total matched by Ford Motor Company for a total donation of \$46,793.

Since its inception the Gold for Food Program has raised an impressive \$573,504 to benefit the hungry of Livingston County.

Patients are asked if they would like to donate any extracted teeth that contain precious metals such as gold, silver, platinum, or palladium. These teeth are collected by participating dentists over a year and then sent to Atlantic Precious Metals, a refinery located in Pennsylvania. The proceeds are then donated to the Gleaners. The program was founded by Dr. Fred Bonine in 1996.

Dental Medicaid Updates Announced

The MDA has received the following updates to the Michigan Medicaid program:

- Effective March 1, 2024, full-mouth debridement may be performed the same day as a comprehensive or periodic oral evaluation when all the required components of the evaluation have been accomplished and documented in the beneficiary's record. It is covered for beneficiaries age 14 and over once every 365 days. It is not a covered benefit when performed on the same date of service as a comprehensive periodontal evaluation (D0180) or prophylaxis.
- The Blue Cross Blue Shield EDI Clearinghouse is no longer responsible for issuing 835 remittance advices. All providers who were previously utilizing BCBCM EDI will need to designate a new billing agent to receive their electronic remittance advices. If no designation is made, the Michigan Department of Health and Human Services will not send an electronic remittance advice for that Tax ID number, and the provider will have to utilize the paper RA or CHAMPS remittance advice screens.
- Children's Special Health Care Services has been expanded to cover eligible young adults until age 26.

New ADA Guideline Recommends NSAIDs to Manage Dental Pain

A new clinical practice guideline from the American Dental Association recommends nonsteroidal anti-inflammatory drugs taken with or without acetaminophen as first-line treatments for managing acute dental pain in adults and adolescents 12 and older.

According to the guideline, when used as directed, NSAIDs, such as ibuprofen and naproxen, on their own or in combination with acetaminophen can effectively manage pain after a tooth extraction or during a toothache when dental care is not immediately available. The guideline was the cover story of the February issue of JADA. You can access it at JADA.ADA.org.

ADA Academy Accepting Applications

In support of dental educators, the ADA Council on Dental Education and Licensure is accepting applications to attend the Academy for Advancing Leadership's Institute for Teaching and Learning program.

Three scholarships are available to candidates who are full- or part-time educators or general dentist private practitioners interested in pursuing a career in dental education. The Institute for Teaching and Learning is a four-day, on-site program that provides participants with the opportunity to refine their teaching skills and enhance the quality of their interactions with students in the classroom and the clinic.
