ADA News

ADA policy requires all volunteer travelers, traveling on ADA-funded business, to make their airline reservations through the ADA Travel Desk, International Travel Service (I.T.S.)

This gives the ADA the opportunity to control the cost of airline tickets by consolidating air travel expenditures. The ADA is also able to negotiate and file for group and meeting discounted airfares on a national level.

The program functions as follows:

- The ADA meeting coordinator notifies all volunteers of the upcoming meeting.
- The volunteers contact I.T.S. at (800) 225-1532 and identify themselves as ADA volunteers, providing the dates, name and location of the meeting they are attending.
- The ADA travel advisor will locate the volunteer's name on an authorized list and will process the reservation as required.
- All ADA volunteers should have a travel profile on file with I.T.S. This will expedite the reservation process and will ensure that personal travel preferences are adhered to whenever possible.
- All airfares over \$1,000.00 must be approved by the ADA prior to ticket issuance.
- Tickets will automatically be charged to the ADA, thus eliminating ticket reimbursement. Tickets will be held until boarding passes can be issued (normally 30-35 days prior to departure).

Born in Tampa, Florida, Tom Adams moved as a high schooler with his parents to New Orleans and enrolled in East Jefferson HS. His prowess as a pitcher in prep baseball as well as American Legion and All-American leagues attracted the attention of Tulane baseball coach Ben Abadie.

The result was a four-year baseball scholarship at Tulane where he played for four years, graduating with a BS in chemistry in 1965.

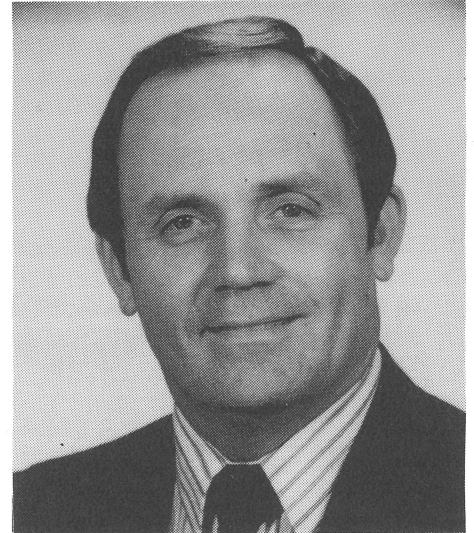
His next educational step was only a few yards away. He enrolled in the Loyola Dental School next door where he earned his DDS in 1969. Then came three years as an oral surgery resident at Charity Hospital.

Dr. Adams then accepted the position of staff oral surgeon at Eisenhower Hospital in Augusta, Georgia. After two years it was back to New Orleans where Dr. Adams set up his office first at 3901 Houma Blvd., and then at 4224 Houma Blvd. He also has an office in Mandeville.

A Diplomate of the American Board of Oral and Maxillofacial Surgery, and a Fellow of the American College of Oral Surgeons, Dr. Adams is on the staff of East Jefferson Hospital where he is chairman of the department of dentistry.

He remembers his days at the Loyola Dental School, especially his friendship with Dr. Dave Ellis, who was in charge of oral surgery at Charity.

His practice keeps Dr. Adams pretty busy. When he gets a chance he likes to play golf at Metairie Country Club.



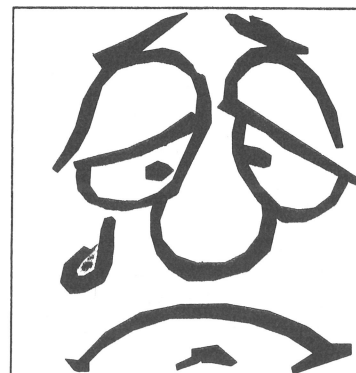

He and his wife, the former Deandra Blache of New Orleans, are the proud parents of three children: Robin, 28, a schoolteacher; Christine, 24, a graduate of Tulane University and currently in nursing school, and Todd, 20, a student in Louisiana State University's school of landscape architecture.

As to changes in his profession over the years, Dr. Adams mentioned one that is not clinical but administrative: managed care. "It's a problem for dentists and a problem for patients, the latter because they're often unaware of the cost of treatment," he said.

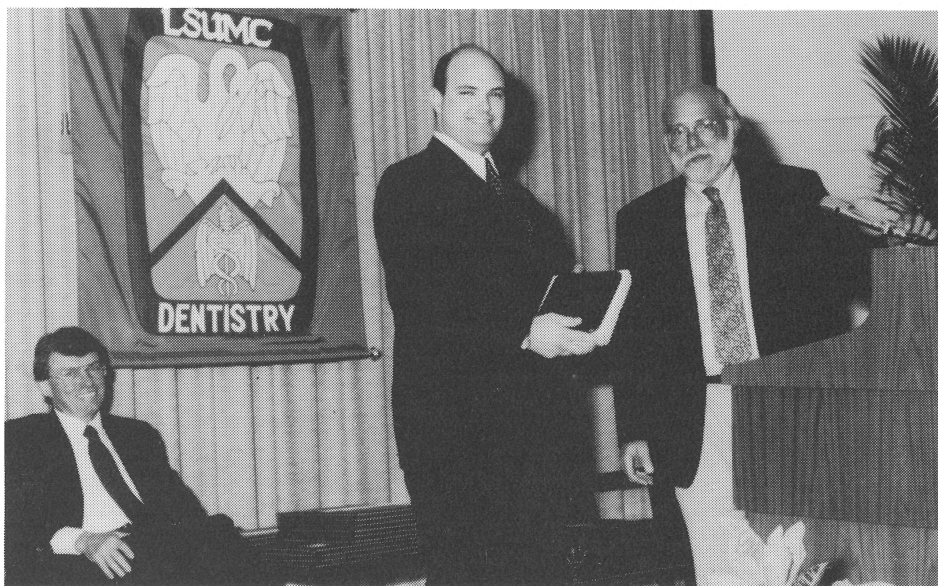

Some bottled waters are low on fluoride

Some public health officials are concerned about the increased reliance on bottled water and the potential impact this might have on dental caries, especially in young children, says Warren LeMay, D.D.S., in the April 1998 *WDA Journal*.

Parents, dentists, and other health care providers should consider the consequences of children drinking water with inadequate fluoride levels, LeMay says.

According to LeMay, unlike many community water systems, most types of bottled water lack sufficient fluoride. Says LeMay, "It seems clear that unless an individual uses enough of other sources of fluoride, there is an increased risk of dental caries. Appropriate levels of fluo-

ride in the drinking water can reduce dental caries by up to 30 percent."

LeMay suggests that dentists and physicians evaluate the fluoride intake of children and discuss with parents the need for dietary fluoride supplements, fluoride mouthrinses or more intense professional supervision.

Dentists should inquire whether a home is equipped with a water filtration system. Two of the most common water filtration systems are carbon filtration and reverse osmosis. Carbon filtration systems do not remove fluoride, but reverse osmosis systems can remove about 95 percent of fluoride from the water.

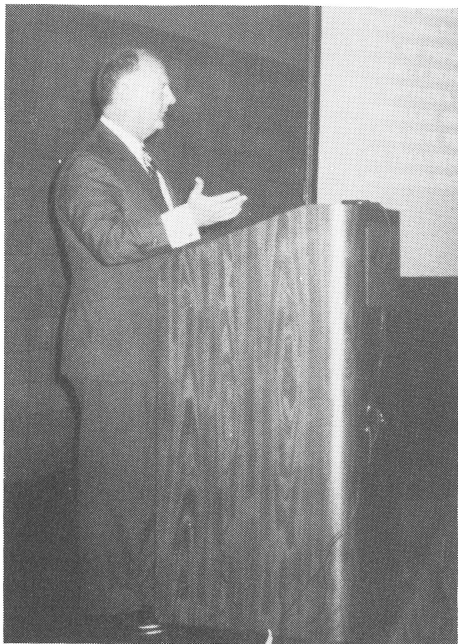

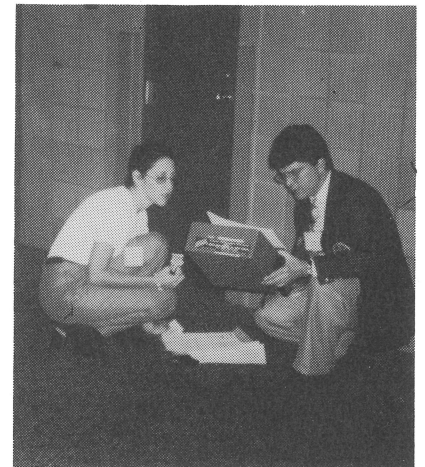
