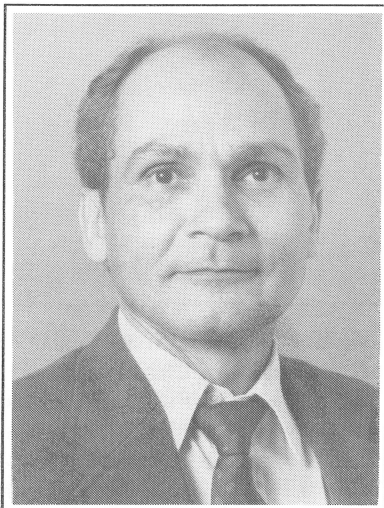

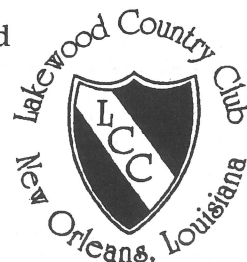

Gum disease more serious threat than previously thought

According to the American Academy of Periodontology (AAP), a new analysis of recent research has revealed gum disease may represent a far more serious threat to the health of millions of Americans than previously realized.

These studies found that periodontal infection may contribute to the development of heart disease, the nation's number one cause of death, increase the risk of premature, underweight births, and pose a serious threat to people whose

health is already compromised due to diabetes and respiratory diseases.

To help people learn more about this health concern, the AAP is launching a national public education campaign which will include a toll-free consumer information number, interactive web site where questions about oral health and gum disease will be answered by an Academy periodontist, and educational materials on the link between gum disease and the serious medical conditions mentioned above.

State board announces new rules for mobile clinics

Comprehensive new rules promulgated by the Louisiana State Board of Dentistry to regulate mobile dental clinics in Louisiana became effective as of August 20, 1998.

Among other things, the new rules stipulate that applicants for a mobile clinic permit are required to:

- post an emergency follow-up care agreement with an area dental facility.
- maintain an official business with a physical address.
- have the proper equipment for communication, sterilization, etc.

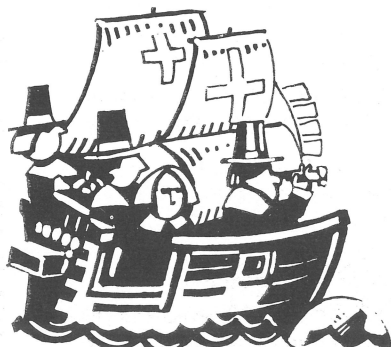

CONFRONTING A PROBLEM

Chemical dependency often goes undetected

The Dentists' Well-Being Advisory Committee functions both on a state and a local level. Its purpose is to identify and assist dentists who have fallen victim to the disease of chemical dependency, and occasionally other disorders.

Chemical dependency affects approximately 10 to 20 per cent of the dental profession. It often goes undetected by the community because dentists are often very isolated in their dental offices. In contrast, physicians, who are affected in numbers similar to their dental colleagues, often work in hospitals, and the aberrant behavior often associated with addiction to drugs can more easily be observed by their peers.

Although chemical dependency is often not noticed by the community at large, it rarely goes undetected by the dentist's immediate family and his or her office staff. The Well-Being Committee's charge is made more difficult by the tendency of the dental family and staff to deny the condition and to cover up the dentist's

unusual behavior.

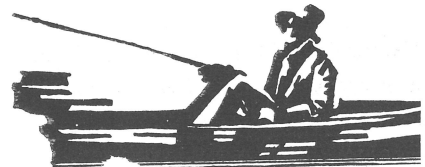
This occurs because the family and staff of the dentist is dependent on that person for his or her livelihood. The fear of discovery of the dentist's problem directly affects the security of the family or staff member. However, in actuality, this denial is contrary to the dependent's best interest. If addiction proceeds unchecked, it always leads to disability or premature death.

When the affected dentist is brought to the attention of the Well-Being committee, a thorough investigation is conducted, and the dentist is intervened upon. This usually results in the dentist receiving therapy for his or her addictions, and the return to a more productive and rewarding life as well as dental practice. The Committee scrupulously protects the dentist's privacy, and acts as the dentist's advocate should his or her chemical dependency ever be brought to the attention of the State Board of Dentistry.

The Committee functions primarily as an ad hoc committee, and is composed of many individuals throughout the state. Many of the dentists who have volunteered for the Well-Being Committee are themselves recovering from

chemical dependency and therefore bring a unique insight into the plight of the dentist being intervened upon.

The Well-Being Committee is also trying to accumulate the money to establish a loan fund for the purpose of paying for treatment for this disease. Very often, a dentist who has a chemical dependency problem has used most of his or her financial resources to support the habit. For about a year, the Committee has been trying to assemble a cookbook to be sold in order to raise money for our loan fund. Although we have a wonderful network of dentists available for interventions, we suffer from a chronic lack of volunteers to work on our cookbook. I would very much like to solicit someone who would volunteer to assemble a subcommittee to take on this project. If you would like to volunteer, please call me at 361-0550. Thank you.

Busy, and he loves it

Dimetry Cossich is a man who likes to work. Dentistry? "I love it," says Dr. Cossich. "If I won the lottery tomorrow, I'd stay right here." He adds with a smile: "I might take a little longer fishing trips in a little bigger boat."

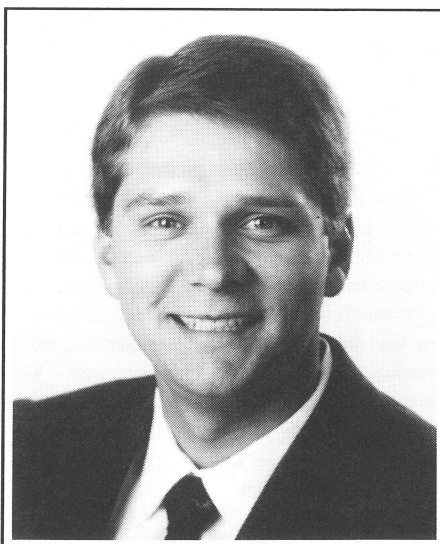
And it's quite a practice. A solo practitioner, Dr. Cossich employs six operators in a formerly burnt-out building he bought and renovated in 1995. His staff includes a hygienist, office manager, financial coordinator, receptionist, and three chairside assistants.

Dr. Cossich's work habits began early. The son of schoolteachers, he graduated from Buras High School in 1978 as valedictorian, winning an academic scholarship to Tulane. There he earned two degrees, a BS in biology and a BA in psychology.

Then came LSU Dental School where he earned his DDS in 1987. He spent two years in the Charity Hospital general dentistry residency program and in 1989 opened up his practice in Buras.

What lured him to dentistry? "It's not hard to say," Dr. Cossich said. "My parents gave me three choices – doctor, lawyer, or dentist – and I've always loved working with my hands. I remember going to our dentist, Dr. Elmer Grundmeyer. Maybe it was because it was such a positive experience being the only one in my family who never had a cavity."

Throughout his Tulane days, Dr. Cossich worked in the summers as a commercial fisherman from May to July. "I made good money, sometimes as much as \$15,000 in a month. Of course, I fished longer and harder than most, seeing as I was only working 45 days a year."

Dr. Cossich has occasionally had associates in the office to assist him. Once a month an orthodontist, Dr. Larry Foster, comes down from Baton Rouge. "I think it's the fishing that attracts him," says Dr. Cossich. "He'll work one day and fish two."

The Buras practitioner is married to the former Emme David of New Orleans. They are the proud parents of three children: Dimetry, Jr., age 10, Elizabeth-Lee, 9, and Joseph, the one-year-old. The family resides in Belle Chasse.
