Dr. Lemon is head of the department of


endodontics at LSU School of Dentistry. He is a graduate of the University of Kentucky, and a Diplomate of the American Board of Endodontics.

ADA lawsuit challenges new patient refund reporting rule

The American Dental Association has filed a lawsuit to challenge the reportability of patient refunds by dentists to the National Practitioners Data Bank, as required by the U.S. Health Resources and Services Administration.

The suit, filed in U.S. District Court for the District of Columbia, seeks a declaratory judgment from the court that HRSA's requirement that refunds be reported to the Data Bank by individual dentists is unlawful under the Health Care Quality Improvement Act of 1986.

The Health Care Act created the Data Bank to collect and share information on the professional competence and conduct of dentists, physicians and other health care providers.

A key purpose of the Data Bank was to strengthen the peer review process of local dental and medical societies, and to restrict the ability of incompetent practitioners to move from state to state without being discovered.

Information in the Data Bank is confidential and, along with other data, is to be used in granting clinical privileges or in determining employment, affiliations and licensures. The Data Bank went into operation on September 1, 1990.

The ADA's lawsuit is based on the U.S. Department of Health and Human Services' recent interpretation of the stature and regulaBecause of the reporting requirement, many dentists have already indicated they no longer will participate in peer review mediation, and a number of dental societies have ended their peer review programs, the suit states.

Dr. Eugene J. Truono, ADA president, said the reporting requirement threatens the peer review process and relations between dentists and their patients.

"Without this lawsuit," Dr. Truono said, "there very likely would be an increase in litigation, an increase in professional fees to cover increases in liability insurance, dissatisfied patients and a serious impairment of peer review as it is known today."

Dr. Truono added that the Association's lawsuit represented a significant benefit of membership in the ADA.

Peer review is a long-established, informal mediation process for the resolution of disputes between patients and dentists. Typically, qualified dentists and lay people are on peer review panels. The results of peer review may include reassurance to a patient on the appropriateness of a service provided, having a dentist redo a service provided to a patient, having another dentist provide service to a patient, waiving all or part of a dentist's uncollected fee or refunding a fee.

Peer review is simple, inexpensive and

tions to require refunds made by practitioners in response to written claims for payment to be reported to the Data Bank. A failure to report could result in a fine up to \$10,000.

As a result of the reporting requirement, according to the lawsuit, dentists will forego the routine refunding of fees to patients, either under the peer review mediation process or on their own, in order to avoid being reported to the Data Bank.

The alternative is for dentists to report themselves to the Data Bank as having made a medical malpractice payment, thereby damaging their professional reputations. efficient in that it avoids protracted and costly litigation, and it usually results in amicable resolution of a dispute.

Joining the ADA as plaintiffs in the lawsuit are four dentists and seven state dental organizations: the California Dental Association, the Illinois State Dental Society, the Dental Society of the State of New York, the Pennsylvania Dental Association, the Texas Dental Association, the Utah Dental Association and the Washington State Dental Association.

The ADA is represented in the lawsuit by Mel Garbow, with the law firm of Arnold & Porter, of Washington, D.C.

CREDIT CARD USE INCREASING

The use of credit cards in health care, including dentistry, is gaining popularity.

In a study conducted for Visa USA, 70 percent of the consumers surveyed said physicians and dentists should accept credit cards. About 38 percent of all dentists currently accept credit cards.

More than \$3 billion in personal health care expenses was charged to credit cards in 1989, according to *ADA News*.

CIGARETTES COST \$4.25 IN CANADA

Canada banned all tobacco ads in January 1989, and since then tobacco sales have plunged, dropping 7 percent last year and another 10 percent in the first four months of this year. A pack of cigarettes costs about twice as much in Canada as in the U.S. – up to \$5 Canadian (about \$4.25 U.S.).

DENTAL IMPLANTS GAIN IN USE

An increasing number of people are expected to receive dental implants over the next several years, according to Dr. R. G. Christensen, a professor at the Brigham Young University and the University of Utah.

"Placement of a dental implant is usually not a painful or debilitating procedure, and most patients compare it to routine tooth extraction in regard to discomfort," said Dr. Christensen. He says improvements in implants from previous techniques have resulted in a high level of clinical success, with 90 percent or more retention of implants for more than 20 years.

One improvement is the use of metal and other substances that "bond" or "integrate" with bone, creating rigid bone or implant relationships.

Another improvement is better techniques for cylinder and screw implants, providing a precision fit to the bone.

Despite the expected increase in the use of implants, said Dr. Christensen, dentists need more knowledge about the long-term upkeep and repair of implant prostheses.

For instance, he says, more study is needed on when and where various types of screws fatigue and break, and the influence on opposing teeth of porcelain restorations placed on rigid implant heads.

Other important considerations to the success of implants include the incidence of periodontal breakdown around implants and potential gum recession around single tooth implants.

"Any of these potential problems or many others will require upkeep and repair procedures that currently are unknown," he said. "Dentists should recall patients faithfully every few months for prevention of disease and for examinations."

The ADA has accepted one dental implant and provisionally accepted several others that have demonstrated success and safety through long-term clinical studies.

FEE DISCUSSIONS ARE INCREASING

Nearly one-half of American dental patients discuss fees with their dentists prior to treatment, according to results from a recent Gallup survey.

The survey consisted of telephone interviews with 1,000 Americans. Those most likely to discuss fees with their dentists before initiating treatment were 35-54 years of age (57 percent),

DENTACHEQUES AID HANDICAPPED

The National Foundation of Dentistry for the Handicapped (NFDH) has introduced DentaCheques, a unique coupon book with 98 coupons from 44 dental product manufacturing and distributing companies.

DentaCheques is filled with over \$4,500 worth of values on dental supplies. The NFDH is selling the book to dentists for only \$55.

The DentaCheque dental product coupon book, which can be ordered now, has two sections: one for discounts from dental supply companies and the other for discounts from manufacturers of dental equipment and materials.

Fourteen dental supply companies will honor the three DentaCheque coupons which provide a 5% discount on merchandise orders between \$100 and \$200. One mail-order supply company has included four coupons, each good for a 15% discount on orders of \$200 or more.

Most dentists should be able to use some of the coupons to recoup the cost of the book and much more. Further, by buying DentaCheques, dentists help support the NFDH, a charitable non-profit organization affiliated with the American Dental Association.

The Foundation develops and operates programs which provide needed dental care for disabled, aged, and medically-impaired persons. Over 5,000 dentists participate.

The development of DentaCheques was sponsored on behalf of the NFDH by the American Dental Trade Association. Further, the Colgate-Palmolive Company provided a grant to underwrite the production of the first 10,000 DentaCheque books.






