

THE AIDS CONTROVERSY

ADA challenges risk estimates

Atlanta-The American Dental Association urged the Centers for Disease Control (CDC) to avoid issuing guidelines that would mandate health care workers to be tested for the virus that causes AIDS.

ADA policy calls on HIV-infected dentists to stop performing invasive procedures or disclose their HIV status.

"This policy is not to be construed as a call for mandatory testing of health care workers, nor is it to be used as a justification for health care providers to demand to know the HIV status of their patients or to refuse treatment to several surveys of dentists on needlestick and sharp injuries. These surveys indicate that such injuries sustained by dentists are substantially fewer than CDC estimates.

The ADA also said there are important differences between dentistry and surgical procedures in medicine. The percent of injuries in which the sharp object is likely to recontact the patient is much less for dentistry.

"The risk for the patient of being infected with HIV in a dental practice, according to our calculations, is lower than any on CDC's list of selected risks in health care settings," said Dr.

HIV-infected patients," said Enid Neidle, Ph.D., ADA scientific affairs director.

The Association testified at a CDC conference on guidelines for health care workers infected with the human immunodeficiency (HIV) or hepatitis viruses.

The CDE recently reported possible HIV transmission from an infected dentist to three patients but did not say how the virus may have been transmitted. This is the only reported case of doctor-to-patient transmission in the 10 years of experience with AIDS.

Responding to preliminary CDC estimates of the risk to patients contracting HIV through a dental office, the ADA challenged CDC's calculations of 10 to 100 patients potentially infected in the past ten years as being too high. Instead, the ADA estimates the number ranges from one to seven patients potentially infected.

ADA calculations are based on data from

Neidle.

The risks of contracting hepatitis or dying from anesthesia or an adverse penicillin reaction are significantly greater in health care than the risk of HIV infection.

The ADA also said the CDC estimate of risks to patients from HIV-infected dentists assumes there are more invasive procedures performed by dentists than actually occur.

"Dentistry is by no means universally invasive," the Association said in related testimony by Dr. Michael Perich, assistant executive director for dental practice. "Some procedures are completely non-invasive and some invasive procedures, defined by the CDC as those that predictably result in patient bleeding, are only marginally invasive," Dr. Perich said.

The Association plans to convene a workshop soon to classify dental procedures in terms of whether they are invasive and to what extent.



ANTIBIOTICS AND CONTRACEPTIVES

An estimated 10 million women in the United States and about 60 million in the world are currently taking oral contraceptives.

If a dentist prescribes a certain antibiotic and the patient takes it while continuing to take the oral contraceptive, conception and pregnancy could be the result.

pregnancies, writes Fred F. Cowan, PhD, in the January issue of Impact, Academy of General Dentistry.

Antibiotics prescribed by the dentists allegedly interfered with the action of oral contraceptives regularly taken by the patients.

Cowan writes that most current drug interaction indices state that this interaction may occur for griseofulvin, an antifungal antibiotic rarely used in general dentistry.

WASTE STUDY MAY HELP DENTISTRY

Dentists may benefit from technology developed in response to the federal medical waste tracking experiment, said the Environmental Protection Agency in a report to Congress.

The 1988 Medical Waste Tracking Act encouraged development of innovative waste treatment and destruction technologies and most of the newer treatment methods are for disposal of sharps.

The EPA report suggests the agency may recommend extending parts of the program but seek exemptions for dentists and other small generators.

The ADA continues to meet with EPA officials to urge exemption for dentists or minimal regulation. EPA sends a final, report to Congress in September.

Almost all (98 percent) of 2,684 dentists covered by the twoyear experiment generate less than 50 pounds of medical waste a month. Some 95 percent of physicians and veterinarians are also "small quantity generators."

The vast majority of medical waste is produced by hospitals, which are less than 4 percent of regulated facilities, while nearly 80 percent of the waste generators in the experimental program (dentists and other small quantity groups) produce only 3 percent of the waste.

However, also listed are the penicillins such as ampicillin, amoxicillin, oxacillin and penicillin V that are commonly used in dentistry.

Cowan states it may be wise to warn female patients of childbearing age before an antibiotic is prescribed that there may be a possibility that the effectiveness of the oral contraceptive may be reduced. Be sure to place the warning on the patient's chart.
