Dr. Glaser Speaks December 18

The Hygiene-Driven Practice

"The Hygiene-Driven Practice" is the title of the scientific program at the NODA general membership meeting Wednesday, December 18 at 7 p.m. at the LSU Dental School.

Dr. Peter Glaser, a veteran practitioner, past president of NODA and past chairman of the New Orleans Dental Conference, will be the speaker.

Peter Glaser is known as one of NODA's most creative and imaginative members. In virtually every association post he has held, he has come up with new and different ideas. He has been a frequent speaker on NODA and Conference programs.

Regarding "The Hygiene-Driven Practice," he points out: "Attempting to keep busy, productive and profitable in dentistry is getting more difficult than ever. One needs not only to be on the front edge of the technical and knowledge aspect of dentistry, but also in the management area."

"From a practice management point of view, a practice that has a busy hygiene department will always be a busy practice. Alternatively a slow practice normally has a poor hygiene area," he added.

Dr. Glaser will cover presentation and gaining a high acceptance rate with hygiene patients, retaining a maximum number of patients in the recall program, getting more

Loyola University, through its Executive Education Program in the College of Business, will start a certificate program in medical/dental practice management in January, 1992. It is designed to provide opportunities for participants to gain knowledge in key technical and management areas.

For entrance into the program, participants are required to have a high school diploma and either a five years experience in practical management or at least two years (60 hours) of college credit.

To receive certification, participants must successfully complete ten required courses and two electives in the practice management curriculum in one year.

Participants who successfully complete the program will be awarded a "Certificate of Completion" demonstrating endorsement of their knowledge and accomplishments by the university's Executive Education Programs.

The cost of the certificate program will be \$2,400. Payment may be made in full at the time of registration or will be billed quarterly.

HOW PEOPLE CHOOSE DENTISTS

University of Iowa researchers randomly surveyed 300 Iowans and found that the most important characteristics of a dental practice are sensitivity to pain or fear, the ability to see the same dentist at each visit, the attitude of the staff and the appearance of the dental office.

In an item in October *Dental Economics*, Marsha Cunningham, associate professor of preventive and community dentistry, says the study shows that people make trade-offs among the attributes of a dental practice the same way they do among features of a consumer product.

"For example," she said, "you might be willing to see a dentist in an inconvenient location if he or she is more sensitive to your fears about dental treatment."

Other characteristics patients consider significant when choosing a dentist are: ease of using dental insurance, fees, waiting time, range of care offered, location, explanation of treatment options, helpfulness of staff, preventive care offered, recommendation from a friend and waiting time to schedule appointments.

Factors found to be of less importance were: hours of operation, parking, appointment reminders, ease of rescheduling appointments, payment plans, number of dentists, dentists' years of experience and the use of advertising.

PROGRESS ON AN AIDS VACCINE

A combination of two experimental AIDS vaccines given months apart to a small group of uninfected volunteers provoked a better immune response than any substance tested so far, reports *In Health* magazine.

Researchers at five universities conducted the tests sponsored by the National Institutes of Health.

The researchers say they cannot yet predict whether the boost in immunity would be strong enough to protect against an actual infection, but the approach of using vaccines in tandem looks promising. Both vaccines were manmade versions of protein components of the virus's outer coat. The first, called gpl60, was embedded in live vaccinia virus, the organism once used to vaccinate against smallpox. The booster shot, given 11 to 27 months after the first, consisted of multiple copies of the purified protein known as gpl20.

In other preliminary vaccine trials, Robert Redfield and coworkers at Walter Reed Army Institute of Research gave a different version of gpl60 to 30 volunteers who were already in the early stages of HIV infection. An improved immune response was shown in 19 of the volunteers.

STUDY REVEALS KIDS' PREFERENCES

Children showed "no significant differences in taste preference between the regular and children's flavored dentifrice," according to a study done at West Virginia University School of Dentistry.

Researchers Carol Sherrill Spear, BSDH, MS, and Laura Anne Savisky, BSDH, did find, however, significant differences existed in visual preference. They report that children preferred the modern, child-oriented dentifrices and containers.

Spear and Savisky conducted the study of dentifrice choices with 435 fourth grade children in Monongalia and Preston counties in West Virginia.

Their results indicated that children preferred a gel to paste, and blue sparkle gel to a plain blue gel. The pump container was preferred to the tube and the fliptop lid preferred to the twist-off lid.
