## State Secretaries Management Conference to Hear Bill McGrath on Exhibit **Problems**

Bill McGrath, Chairman of the ADTA Marketing Committee, will address the State Secretaries Management Conference on June 4 under the title, "Dental Trade Problems at the State Level". Bill's paper points out the areas in which state meetings might be improved to the advantage of both the exhibitor and the society. Some of the points Bill will make are historically controversial, such as regional meetings vs. a plethora of small meetings in a given area, scheduling to avoid conflicts, booth assignment policies, to mention a few. We'll report the reaction in our next issue.

## Exhibit Assignments for ADA Meeting To Be Mailed by June 10

Applicants for exhibit space at the Annual Session of the ADA in Miami Beach will get their assignment notices by June 10. We're tardy in getting assignments made because of a foul-up in the mailing of the invitations. All were dropped in the mails in Chicago on April 27 as originally announced but many firms on the mailing list reported not receiving the prospectus until ten days Some said they didn't get the prospectus mailed them at all. Next year we're going to experiment with some other (and we hope better) method of mailing.

Because of an anticipated attendance of over 2,000 Latin American dentists at the ADA meeting, you may want to consider having a Spanish language interpreter in your booth. If you do, drop a note to Dr. Norman R.A. Alley, 216 Catalonia Avenue, Coral Gables, Florida. He can arrange for a Cuban refugee dentist for you for the modest sum of \$25 a day. Dr. Alley heads a dental society committee to assist Cuban refugee dentists in the Miami area.

## \$20,000 in Grants for Latin American Participants in the ADA Meeting

The ADA and the National Institute of Health have each made grants of \$10,000 available to bring Latin American dentists to the Miami Beach meeting to present scientific lectures and clinics. The total sum of \$20,000 will be administered by the Council on Scientific Session. These grants underscore the importance ADA and the federal government attach to the meeting as a vehicle for improving dental health in the Americas. Parenthetically, the interest generated by this and other efforts in the same area should help to make profitable Latin American contacts for exhibitors interested in this dental market of growing importance.
