

More Dental Departments in Hospitals Seen

There is a great deal of interest in the expansion of the number of dental departments in hospitals throughout the country and the Council on Hospital Dental Service of the ADA is going to help the state societies to accelerate the interest. At the Council meeting in Chicago, June 18 & 19, it was decided to distribute a printed guide for state societies' use. It will advise them on procedures in organizing and operating a hospital dental department. This could become an important factor in expanding equipment sales in the future.

Local Anesthetics Above 1:50,000 Deleted from Accepted Dental Remedies

The ADA's Council on Dental Therapeutics meeting in Chicago June 21-23 ordered local anesthetic solutions having anepinephine concentration in excess of 1:50,000 deleted from the Council's annual publication, Accepted Dental Remedies. It was the Council's judgement that concentrations above the indicated level are not necessary in dental practice.

The Council also has accepted an invitation to participate in a joint conference with representatives of the American Heart Association to coordinate and disseminate information on the treatment of dental patients with cardiac disorders.

And finally, the Council voted to continue classification of Procter & Gamble's Crest Toothpaste in Group B for another year.
