

Senior Student Manual Proposed

The ADA has been giving some thought to the development of a manual to be distributed without charge to all senior dental students about Oct. 1, 1963. The purpose of the manual would be to assist the senior student in making the transition from school to practice. Editorial treatment will be broad in scope. Initial chapters will deal with such subjects as state board meeting dates and examinations, data concerning the states, various methods of practice and location of practice. These subjects will engage the senior student's interest early in the academic year. Later chapters will cover announcing practice, personal and professional insurance, equipment, office layout, practice building, etc. In short, the manual will try to take the senior student figuratively by the hand at the outset of his last year in dental school and take him through the initial period of actual practice. Action on the proposal will be taken by the Association at its Miami Beach meeting later this month.

It may be that the manual will carry advertising. If it does, a rate of around \$250 a page will probably apply. More on the manual in our next issue.

One of the largest and most diversified exhibits in ADA history will greet the thousands of dentists who will attend the ADA meeting in Miami Beach from October 28 to November 1. All the space laid out for the meeting has been sold.

Prescription Writing by Dentists on Increase

Dentists are currently writing 11 million prescriptions a year according to an article in the October issue of Dental Abstracts, an ADA publication. The original article by Dr. Harold Hillenbrand, ADA Secretary, appeared in the January 1962 issue of the American Professional Pharmacist. Dr. Hillenbrand projected the 11 million figure to a total of 18 million prescriptions by 1970. The article reports that 89% of all dentists write some prescriptions: the average being three a week. The younger the dentist the more he is apt to be a prescription writer. Under 40 years of age, 95% of dentists write prescriptions, the article stated.
