# 'REGULAR SLATE' WINS ANNUAL ELECTION IN SOUTHERN CALIFORNIA

The Southern California State Dental Association elected the "regular slate" of candidates at its annual session in Los Angeles May 4-6. The slate had been opposed by a group nominated independently of the society's nominating committee and supported by the Council on Dental Information.

(See ADA News Letter, March 16, page 1 and 4). Elected at the annual session were: Drs. Hugo M. Kulstad, president-elect; C.W. Gilman, vicepresident; U. William Riedel, secretary, and Schuyler P. Strang, treasurer. Dr. Edward F. Wheelan, Sr., was installed as president for 1964-65. The election was preceded by an allout voting campaign in support of the regular slate by the Committee for Responsible Leadership in the Southern California State Dental Association headed by Dr. John B. Wilson, a member of the ADA Council on Legislation.

SCSDA also approved an amendment to its bylaws which provides for mail ballots in all future elections. Ballots will be sent to all SCSDA members in advance of the annual session. The winning officers will be installed during the session.

Breakdown of votes is as follows: for president-elect, Dr. Kulstad, 1,319, Dr. Earl Pound, 1,005; for vice-president, Dr. Gilman, 1,406, Dr. Ross C. Huntley, 914; for secretary, Dr. Riedel, 1,393, Dr. Charles M. Woodward, 924, and for treasurer, Dr. Strang, 1,407, Dr. Ross S. LeLansky, 906.

## **Relief Fund May Fall Short Of Goal**

For the first time in 11 years, the ADA Relief Fund campaign may fail to reach its goal, according to Dr. Thomas R. Abbott, Milwaukee, Wis., chairman of the Council on Relief. Total contributions as of April 30 were \$118,519.87, almost \$6,500 short of the \$125,000 goal. He urged every dentist who has not yet contributed to the campaign to do so immediately. Thus far, only 26,600 of the 100,000 members of the Association have contributed to the fund, he added. Dr. Abbott pointed out that the Fund campaign has reached or surpassed its goal each year since 1953. A supplement listing a breakdown by states is included with this News Letter.

### AFDE Makes \$50,000 Grant To Schools

The American Fund for Dental Education approved its second \$50,000 grant of \$1,000 to each of the nation's 50 dental schools. An additional grant of \$38,000 was authorized for support of the American Association of Dental Schools' Division of Educational Research; a \$12,070 grant was made to the American Dental Assistants Association for publication and distribution of a recruitment pamphlet; \$2,432 was given to the Pennsylvania State Dental Council and Examining Board for a Regional Conference of Dental Examiners and Dental School Faculty, and \$1,000 was awarded to the Northwestern University Dental School for its annual conference for teachers of dental materials.

In other actions, the Fund:

--Approved allocation of an additional \$48,569 to be used in the ADA-AFDE student loan program in 48 dental schools;

--Granted the \$6,000 American Dental Trade Association Teacher Training Fellowship to Dr. Samuel R. Wuslich, a first-year graduate student in orthodontics at the University of Pittsburgh School of Dentistry;

--Elected Dr. Raymond J. Nagle, dean, New York University College of Dentistry to his third term of office as president and re-elected Dr. Harry Lyons, dean, Medical College of Virginia School of Dentistry, as vice-president and Joseph E. Dickinson, Chicago, as secretarytreasurer.

# **Fluoridation Suit Filed In NYC**

Former City Water Commissioner Dominick F. Paduano and three other taxpayers have filed a suit seeking to prevent New York City from fluoridating its water supply. They contend the program is "mass medication," which might be dangerous to the health of some persons, and that it violates constitutional rights. City officials, however, said they expect fluoridation to begin as scheduled at the end of this year.

### Four Cities Approve Fluoridation

The Syracuse, N.Y., Common Council recently approved fluoridation for the city's water supply by a vote of 8 to 1. Anti-fluoridationists immediately stated that they planned to take the matter to the State Supreme Court. They will attempt to obtain an injunction preventing completion of the fluoridation installation until the court issues a ruling. An attempt will also be made to bring the matter to public referendum.

In other fluoridation actions, the Pittsfield, Me., Town Council recently authorized fluoridation. Durant, Miss., initiated the measure, bringing to 21 the number of towns in that state now having such programs. Trenton, N.J., also recently instituted fluoridation. Its city water supply also serves most of the townships of Ewing, Hamilton and Lawrence, covering about 200,000 persons. Opponents, however, are petitioning for a public referendum on the matter.

### **ADAA Offers 10 Scholarships**

The American Dental Assistants Association has offered 10 scholarships to students enrolled in schools conducting dental assisting programs approved by the ADA Council on Dental Education. Each scholarship carries a \$100 grant. Two are supported by donations from individuals and component and constituent societies of ADAA and eight are sponsored by the American Fund for Dental Education. # **\$1 Million In Closed Circuit TV**

Thirty-two dental schools have invested close to one million dollars in closed-circuit television equipment, according to Dr. Michael T. Romano, chairman of operative dentistry and coordinator of television at the University of Kentucky College of Dentistry. Dr. Romano is the first dentist to serve as chairman of the Council on Medical Television.

Miss Burriss also won the ADA top award at last year's Science Fair. Both winners will be guests of the Association at its 105th annual session in San Francisco Nov. 9-12. where they will also present their winning exhibits.

Certificates of Meritorious Achievement and \$50 for scientific equipment were awarded to Joseph G. Saide, 17, of Manchester, N.H., for his exhibit "Comparative Study of Effects of Fluoride on Teeth" and to Cynthia Matzke, 16, of Houston, Tex., for her exhibit "Skin Transplants."
