ADA BOARD OF TRUSTEES MEETS IN CHICAGO; ACTS ON REPORTS TO HOUSE

The ADA Board of Trustees met Sept. 1-4 in the Central Office and acted on more than 70 resolutions and reports to be submitted to the House of Delegates at the Las Vegas annual session in November. One of the actions taken by the Board was approval of the incorporation of the ADA Research and Educational Foundation. Under its present legal status, the Board said, the ADA is not eligible to receive grants or gifts for research and educational programs from foundations and similar agencies. The Board stated that it believed the "new agency will be extremely helpful in procuring financial support for research and educational activities from private sources, particularly for the expanded dental research program which is being developed in the laboratories of the new headquarters building." The officers and directors of the Foundation are the officers and trustees of the ADA.

The Board recommended that the House of Delegates approve a resolution relating to practices restricting entrance to ADA membership. The resolution, which was submitted by the Michigan State Dental Association and the Dental Society of The State of New York and which is supported by the Minnesota State Dental Association, urges that "resolute action be taken to enforce the actual intent of the 1962 resolution of the House of Delegates to prevent discrimination in membership entrance on the basis of race, creed or color by (1) advising all constituent and component societies that non-conformance with the spirit and the intent as well as the letter of the ADA Bylaws may lead to sanctions, including revocation of charter; (2) encouraging all members of the National Dental Association not

at present enrolled in the ADA to submit applications for membership; (3) discouraging any local subterfuge (such as inability to obtain sponsoring signatures) which would allow such discrimination."

The Board recommended approval of a resolution from Connecticut urging component societies to review their requirements for membership "both written and unwritten, understood and implied," and that periodic reports be made to the House of Delegates on progress, and "that those component and constituent societies in which discrimination as to membership previously has been apparent but is now being overcome be commended for the progress made...."

In another action, the Board recommended approval by the House of the bylaws and membership standards of the National Association of Dental Service Plans, which was incorporated last Jan. 7. The Board called attention to its advisory comment stating that the Board is in "full concurrence with the farsighted action of the 1964 House of Delegates in authorizing the establishment of the National Association of Dental Service Plans and with the statement of the Council on Dental Health that 'without such a national association purchasing groups seeking nation-wide coverage would be denied use of dental society-sponsored non-profit plans.'"

Dental Laboratory Relations Program

The American Association of Dental Examiners in cooperation with the ADA Council on Dental Trade and Laboratory Relations will present a program "Dentists and dental laboratory relations" at the Tropicana Hotel in Las Vegas Nov. 6, in conjunction with the ADA annual session. Dr. Gustave J. Perdigon, Tampa, Fla., will comment on the film "Report on Bootleg Dentistry" to be shown at the meeting, and the Virginia program for implementation of the work authorization law will be discussed by Dr. A. L. Martone, Norfolk. Mr. Alex Parks, Portland, Ore., will speak on the cooperation needed by a dental examiner for law enforcement, and Mr. L. M. Anderson, Boston, Mass., and Dr. Clement C. Alptert, Washington, D.C., will discuss dental laboratory relations from the viewpoint of the owner and the customer. Mr. Harvey Sarnier, Chicago, secretary of the ADA Council on Dental Trade and Laboratory Relations will speak on denturist legislation and law enforcement, and Dr. George H. Fitz, Pontiac, Ill., will report on programs for improving dental laboratory relations. All dentists interested in dental laboratory relations are invited to attend.

— Roentgenology Panel —

Latest technics in roentgenograms will be discussed at a panel Tuesday, Nov. 9, in Convention Center as part of the annual session scientific program. Dr. William J. Updegrave, Philadelphia, will discuss panoramic roentgenography and Dr. Jack D. Carr, Indianapolis, will report on intraoral roentgenography using the bisecting technic. Intraoral roentgenography using the paralleling technic will be described by Dr. Theodore S. Grant, San Francisco, and Dr. Henry M. Rosenberg, Chicago, will outline extraoral roentgenography.

Lee M. Lightner Named AF Brig. Gen.

Dr. Lee M. Lightner, deputy assistant surgeon general for dental services, U.S. Air Force, has been appointed to the rank of Brigadier General by President Johnson. By this action, the Air Force Dental Service was accorded two general officers for the first time in more than five years.

19 More Laboratories Accredited

Nineteen additional dental laboratories have been accredited by the Joint Commission on Accreditation of Dental Laboratories as of Sept. 1, according to Dr. J. Eugene Ziegler of Hollywood, Calif., commission chairman. He said that the accredited laboratories now total 112 in 34 states plus the District of Columbia. A list of the 19 newly accredited laboratories and their specific classification of accreditation is enclosed in this News Letter.

ADA To Publish Research Journal

Beginning next year, the ADA will become publisher of the Journal of Dental Research, the official publication of the International Association for Dental Research. Dr. Frank J. Orland, IADR editor, and Dr. Leland C. Hendershot, ADA editor, jointly announced the arrangement at the 43rd general meeting of the IADR. First issue of the bi-monthly publication to be published by the ADA will be the January-February 1966, issue.

Under the new arrangement, the ADA will handle for the IADR all business and production aspects of the publication while the IADR retains full editorial control. This will use to a fuller extent the established publication facilities of the ADA and free the IADR of many details involved in publishing. The ADA now publishes The Journal of the American Dental Association, Dental Abstracts and the Journal of Oral Surgery.

The Journal of Dental Research was founded in 1919 by Dr. William J. Gies, professor of biological chemistry at Columbia University, New York City, and a pioneer in dental research. Dr. Gies was also the first editor of the publication. Dr. Orland, director of the Zoller Memorial Dental Clinic, University of Chicago, has been editor of the Journal since 1959.

AFDE Awards \$5,000 To AADS

The American Fund for Dental Education has awarded \$5,000 to the American Association of Dental Schools for publication of a new dental school admission requirement booklet. Another award of \$2,000 was granted Northwestern University and Indiana University dental schools for support of the Annual Conference for Teachers of Dental Materials to be held Feb. 3-4, 1966.

Additionally, AFDE announced that ADA support of its student loan fund has made it possible for the 48 U.S. dental schools in the program to make 879 loans totaling \$217,651 since the program began in 1962. ADA-AFDE loan funds are distributed to dental schools on the basis of enrollment figures.

Prosthodontic Organizations Unite

Representatives of ten prosthodontic groups met recently in Chicago to form the Federation of Prosthodontic Organizations designed to "encourage and improve prosthodontic service rendered to the public and to serve as a liaison agency for member organizations." Dr. Carl O. Boucher, Columbus, Ohio, was elected chairman. Other officers are: Dr. Louis J. Boucher, Milwaukee, Wis., vice-chairman, and Dr. Alexander L. Martone, Norfolk, Va., secretary-treasurer. Other members of the executive committee are: Dr. Frank A. Farrell, Chicago, and Dr. George H. Moulton, Atlanta, Ga. The following organizations are represented in the Federation: Academy of Denture Prosthodontics, American Academy of Crown and Bridge Prosthodontics, American Academy of Maxillofacial Prosthodontics, American Academy of Restorative Dentistry, American Equilibration Society, American Prosthodontic Society, Greater New York Academy of Prosthodontics, Pacific Coast Society of Prosthodontics, Southeastern Academy of Prosthodontics and the Canadian Academy of Prosthodontics.

Military, PHS Dentists Get Pay Hike

Dental officers serving with the armed forces and the U.S. Public Health Service received a six per cent increase in basic pay on Sept. 1, the effective date of the newly enacted military pay bill. Retired officers also benefited from the pay measure, receiving a 4.5 per cent raise in their retirement compensation. As a result of the increase for active duty personnel, young dentists entering service at the rank of captain, or its Navy or PHS equivalent, receive monthly basic pay of \$565.20 and gross monthly compensation, including allowances for subsistence, quarters and incentive pay, of either \$818.08 or \$843.13. Those with dependents receive the higher amount. Prime supporter of the bill, which contained substantially higher increases than those recommended by the Administration, was Rep. L. Mendel Rivers (D.-S.C.), an honorary member of the ADA.

New Radio-TV Kits For NCDHW

Three kits of material for use on radio and television are being prepared by the ADA Bureau of Dental Health Education for use during 1966 National Children's Dental Health Week. Each kit will contain a different script and suitable props plus a suggested news release announcing the program. The three scripts are "How's Your Health?" showing dentistry's influence on total health; "A Look into the Future" describing some of the new work in dental research and "The Winning Smile" discussing the importance of dental health to appearance. The materials will provide an opportunity for members of local societies to participate in radio and television programs with professionally produced scripts and eye-catching props. This new radio-television service is being prepared with the cooperation of the Procter and Gamble Company in its continuing program of support for National Children's Dental Health Week. The kits will be available about Nov. 1 but state and local chairmen for Children's Dental Health Week should submit their orders now to the ADA Bureau of Dental Health Education.

Five Regional Dental Consultants Named

Dr. Donald J. Galagan of the U.S. Public Health Service Division of Dental Health has announced appointment of five new regional dental consultants. They are: Drs. Robert J. Lucas, Region I, with headquarters in Boston; Thomas L. Loudon, Region III, Charlottesville, Va.; Samuel J. Wycoff, Region V, Chicago; Sydney T. Pollard, Jr., Region VI, Kansas City, Mo., and Winston W. Frenzel, Region IX, San Francisco.

In other actions the Board:

-- Awarded a \$2,000 grant to the Louisiana Dental Association to assist the society in its legal efforts to prevent the Internal Revenue Service from assessing taxes on income derived from the sale of exhibit space at an annual session and journal advertising;

-- Received the first report from the Inter-Council Committee for Evaluation of Dental Devices consisting of representatives from the Councils on Dental Research and Dental Therapeutics. The Committee's purpose is to investigate and evaluate devices used in dental practice, dental technology and oral hygiene to determine their safety and effectiveness, and to promote research programs aimed at development and improvement of devices for use in dentistry;

-- Appointed Dr. Jerry J. Adelson general chairman of the General Committee on Local Arrangements for the 1969 session in New York City;

-- Received a report that as of Sept. 1, some 112 dental laboratories in 34 states have been accredited by the Joint Commission on Accreditation of Dental Laboratories;

-- Forwarded to the House without recommendation resolutions calling for a revision of the trustee districts and on increase in the number of districts from the current 13 to 15;

-- Recommended rejection of a resolution of the Indiana State Dental Association to limit the ADA's financial support of the National Association of Dental Service Plans to the \$25,000 granted by the House last November;

-- Congratulated the Connecticut State Dental Association for its efforts in obtaining state-wide fluoridation legislation and approved a resolution to distribute copies of Connecticut's Fluoridation Act to all constituent societies,

-- Appointed Dr. E. Jeff Justis, ADA treasurer, as a trustee of the ADA Pension and Retirement Program to succeed Dr. Paul H. Jeserich.
