FLUORIDATION TO BE SALUTED AT NATIONAL DENTAL HEALTH ASSEMBLY FEB. 6-8

The 21st anniversary of the start of controlled fluoridation will be saluted at the National Dental Health Assembly in Washington, D.C., Feb. 6-8. Sponsored jointly by the U.S. Public Health Service and the

American Dental Association, the conference will be attended by more than 500 national experts representing public affairs, engineering, social sciences, communications, law, public health, medicine and dentistry. Assembly will coincide with National Children's Dental Health Week Feb. Purpose of the conference is "to bring together experts from scientific and other professional fields with leaders of national civic organizations to consider the 21-year history of fluoridation and to plan for rapid adoption of the fluoridation of public water supplies," according to Dr. Viron L. Diefenbach, conference chairman and acting chief of the Division of Dental Health, USPHS. issues to be discussed will be the legal and political implications of state legislation making fluoridation mandatory and the need for more effective public education about the measure.

Dr. John W. Gardner, secretary of Health, Education and Welfare, Dr. William H. Stewart, USPHS surgeon general, ADA Sec. Harold Hillenbrand and ADA Pres. Maynard K. Hine will address the conference. Other speakers and their topics will include: Dr. Robert Felix, dean of the University of St. Louis School of Medicine, "A psychiatrist looks at extremism"; Dr. Leland Hendershot, ADA editor, "The status of fluoridation in the United States and the world"; Dr. John W. Knutson, professor of preventive dentistry and public

Tenants Move Into ADA Building

A number of tenants have occupied their quarters in the new ADA building at 211 E. Chicago Ave. Among dental organizations that have moved, or will move by the end of January, are the American Association of Dental Schools, American Fund for Dental Education, International Association for Dental Research, American Dental Hygienists' Association, Joint Commission on Accreditation of Dental Laboratories and the American Academy of Periodontology.

Additional new tenants include the chancery office of the Archdiocese of Chicago, which occupies the entire sixth floor; John Grenzebach & Associates, Inc., advertising firm; American Republic Insurance Co., and Rocky Mountain Dental Products Co. According to building coordinator, Robert W. Newport, approximately 50 per cent of leaseable space in the building is now rented and additional organizations will be moving in each month. Formal dedication ceremonies for the new building will be held Feb. 27.

ADA Membership At 104,364

Membership in the ADA reached a new high Dec. 31, 1965. Total members were 104,364. A breakdown of this figure shows: fully privileged members, 90,264; affiliate members, 467; associate members 82; honorary members, 81, and student members 13,470.

ADA Staff Changes Announced

A number of ADA staff changes and appointments have been announced by Sec. Harold Hillenbrand. Herbert Lassiter has been named executive director of the National Association of Dental Service Plans. NADSP became fully active as a coordinating agency for dental society prepayment plans in January. Mr. Lassiter, who has been secretary of the Councils on Relief, Federal Dental Services and Insurance, will continue as secretary of the Council on Relief. He has been with the Association since 1957 and is a graduate of Loyola University (Chicago) Harvey Sarner, curlaw school. rently secretary of the Council on Dental Trade and Laboratory Relations and Judicial Council, will also become secretary of the Council on Insurance. In addition, he will have responsibilities with the newly established ADA Research and Educational Foundation. He has been on the staff since 1961 and is the author of Dental Jurisprudence. Bernard Conway, ADA assistant secretary for legal affairs and secretary of the Council on Legislation, will temporarily assume the additional duties of secretary of the Council on Federal Dental Services.

In other changes, Thomas Ginley, director of the ADA Division of Educational Measurements since 1963, has been appointed assistant secretary of the Council on Dental Education. Mr. Ginley is currently pursuing Ph.D. studies in psychology at Loyola University. He will remain as director of the Division and Norbert Slowikowski will become assistant director. Prior to joining the ADA staff, Slowikowski was a research associate with the Chicago Committee on Urban Opportunity and was supervisor of research and development of the Chicago Police Department. Dr. John S. Oartel will retire as secretary of the Council on Scientific Session Feb. 1, to be succeeded by Daryl I. Miller, current director of the Bureau of Audiovisual Service. Miller, an employee since 1961, will continue as Bureau director. Edward Shaw, ADA managing editor, will leave the Association in April. He will be

Fluoridation Gains In 3 States

Three towns in Mississippi recently initiated fluoridation of their community water supplies. They are Laurel, population 27,889, Canton, 9,707, and Brookhaven, 8,885. City Council of Mt. Vernon, Ohio, recently approved fluoridation by a vote of 4-2. Because of later action by opponents, a referendum on the measure will be held in the spring. In Illinois, Galena, population 4,410, and Charleston, 10,505, began adding fluoride to their water, and the Rockford City Council reaffirmed a 1962 advisory vote by the public for fluoridation by voting for the measure 15-5. Rockford citizens can expect to begin receiving fluoridation's benefits in about three months.

Dr. Kulstad Named To State Post

Dr. Hugo M. Kulstad, Bakersfield, Calif., president of the Southern California State Dental Association, has been appointed by Gov. Edmund G. Brown to the Board of Public Health for the State of California. Dr. Kulstad will fill the authorized dental position on the Board which was vacated by Dr. Edward V. O'Gara of San Francisco, who resigned.

MAYOR DALEY HONORED BY USPHS FOR IMPROVING CHILDREN'S DENTAL HEALTH

Mayor Richard J. Daley of Chicago was honored last week by the U.S. Public Health Service "for his continued and invaluable efforts in advancing the dental health of children." In presenting the citation, Dr.

Viron L. Diefenbach, acting chief of the USPHS Division of Dental Health, said "your strong leadership in not only bringing, but keeping fluoridation in the face of considerable opposition has been a major contributing factor to the health of the children of Chicago. This award is especially significant as it also marks the tenth year of water fluoridation for this great city." Dr. William H. Stewart, USPHS surgeon general, sent a telegram praising Mayor Daley for his constructive efforts in the field of public health and particularly for "his interest in and support of dental health programs for children." Dr. Harold Hillenbrand, ADA secretary, praised Mayor Daley for his "outstanding record of improving Chicago's dental health and for his continuing support of realistic and effective dental programs such as fluoridation and oral cancer detection." He said that "Mayor Daley's action in initiating the fluoridation program for Chicago ten years ago was a far-seeing and even courageous action. thousands of other communities in this nation still waiting for such leadership."

Name Judges For ADA Writing Award



"National Health Test" On Television

The "National Health Test" will be presented on CBS television Jan. 18 and Jan. 25. The two-part test is similar to the previously successful national driving test and national citizenship test conducted by the same network. Part of the examination will deal with dental subjects. Program time will be 10-11 p.m., E.S.T. Other questions will cover general good health practices, heart, cancer, emphysema, mental health, pre-natal care, birth control, menopause, pediatric and geriatric medicine, vaccination and inoculation, the common cold, air pollution, narcotics, smoking and pep The ADA is among 20 national health organizations participating in the program with CBS and the Educational Testing Service.

Rhode Island Provides Care For Teamsters

The Rhode Island State Dental Service Corporation has announced a dental care program for employees and families of Teamsters Local 251. Dr. Hubert A. McGuirl, secretary of the corporation, estimates that the total number of participants in the program will be more than 15,000. the terms of the contract, participating dentists will provide basic dental services (fillings and extractions) to beneficiaries without any cost to the recipient. Other services will be provided under a table of allowances, which specifies the maximum amount which will be paid by the plan for the services rendered. service corporation will supervise all of the professional aspects of the plan. A dental director will be assigned to carry on the program's operations. The Teamsters plan to build a center which will house the dental director and staff. This center will act as a pre-diagnostic area for preliminary oral examinations, including radiographs. Actual treatment will be performed by the families' own dentists.
