ADA MOM event set for Sunday

Volunteers hope to provide care to 1,000 San Antonio residents

On Sunday, hundreds of volunteers attending ADA 2014 — America's Dental meeting will donate their time and skills to give back to the San Antonio community through the second ADA Mission of Mercy charitable dental clinic.

The free one-day dental clinic, hosted by the ADA in cooperation with the ADA Foundation, the Texas Dental Association and the San Antonio District Dental Society, will serve up to 1,000 patients in need with comprehensive dental care services, from cleanings and exams to surgical and restorative treatments.

Colgate is the lead sponsor of the event, providing financial and in-kind support.

Great-West Financial is providing corporate funding to mark the 80th anniversary of its business relationship with the ADA.

Funding is also provided in part by a grant from the ADA Foundation.

ADA MOM sponsors and donors cover the entire cost of the event, from transport and set-up of equipment; to materials, supplies and prescription medications; to meals and snacks for volunteers during the 12-hour clinic. No government funding is used for MOM events. A typical event costs nearly \$120,000 and organizing dental associations must raise the entire amount through donations and sponsorships in their communities.

At the inaugural ADA MOM event in New Orleans in 2013, volunteers provided more

than \$387,000 in free dental care to 755 patients in need. A total of 1,119 volunteers from 42 states were able to donate 2,835 procedures, including exams, X-rays, surgical procedures, restorations, cleanings, sealants, fluoride treatments, denture fabrication and repair, endodontic services and emergency care.

Dr. Carl Misch receives 2014 Distinguished Service Award, Association's highest honor

Dr. Carl E. Misch is a lot of things. For instance, he is a knight, having been deemed so by the King of Sweden. He's also a chevalier of La Confrérie des Chevaliers du Tastevin, an esteemed French wine society.

He could have been a number of other things. He might've been a professional baseball player, for example, having been drafted by the Detroit Tigers after pitching two no-hitters in the American Legion Baseball league.

Instead, he chose dentistry. The profession, according to his many admirers, is the richer for it.

To that end, the American Dental Association's Board of Trustees has bestowed Dr. Misch with its 2014 Distinguished Service Award.

"The Distinguished Service Award is the highest honor conferred by the American Dental Association's Board of Trustees," said ADA President Charles Norman. "For his long and distinguished dental career, I am pleased to nominate Dr. Carl E. Misch for the 2014 ADA Distinguished Service Award."

Dr. Misch has had plenty of options available in his life, and through his work as an internationally recognized expert on implant dentistry, he has returned the favor. Thanks to his many innovations, he is considered one of the leading forces moving implant dentistry into the 21st century. His scientific and clinical developments have benefited a range of people, from the everyday person to international royalty.

"Dr. Misch is remarkably adept at taking patient implant circumstances that didn't work out with the most satisfactory result and transforming the situation into really great masterpieces," said Dr. Joseph Hagenbruch, ADA 8th District trustee.

In nominating Dr. Misch for the Distinguished Service Award, his friend and business partner, Dr. Nolen Levine wrote, "As a clinician, his implant complication-based practice is the 'last chance' for patients with complicated and challenging cases, where he has made the impossible, possible."

In a career that kicked off in the early 1970s, when he earned his D.D.S. from the University of Detroit Mercy, the highlights continue to pile up. Two of his most seminal achievements have been the development of the Misch Bone Density Classification, which is considered an international standard, and

the Misch Key Implant Positions for diagnosis and treatment planning.

In 1984, he founded the Misch Implant Institute, which he directs, in Birmingham, Michigan. "As director, he has trained more than 4,500 doctors in a hands-on, yearly forum of education in implant dentistry," noted Dr. Norman.

The Misch Implant Institute has locations in Florida and Nevada, and offers a one-year continuum for implant education.

An inventor, Dr. Misch has been awarded 14 patents related to implant dentistry and is co-inventor of the BioHorizons Maestro Dental Implant System.

As a consequence of brain cancer surgery, Dr. Misch has retired from practice.

A prolific educator, he has held multiple academic positions at dental schools and in other science departments at universities. He was clinical professor in the Department of Periodontology and Oral Implantology and

director of Oral Implantology in the Temple University Kornberg School of Dentistry. He served on the board of trustees at the University of Detroit Mercy, where he is also an adjunct professor in the Department of Prosthodontics. He was an adjunct professor at the University of Michigan School of Dentistry in the Department of Periodontics/Geriatrics and an adjunct professor at the School of Engineering in the Department of Biomechanics at the University of Alabama at Birmingham.

He was the director of the Oral Implantology Residency Program at the University of Pittsburgh School of Dental Medicine from 1989-96.

Dr. Misch maintained a private practice restricted to implant surgery — bone grafting, implant placement and implant complications — and related prosthetics for more than 30 years. His office was located in Beverly Hills, Michigan, and, for the past three years, in Chicago. But he's a known jetsetter when it comes to treating patients, lecturing and demonstrating his techniques, teaching in dental schools and offering continuing education to practicing dentists.

Wrote Dr. W. Carter Brown, president of the Academy of General Dentistry, in his nomination letter: "As a practicing dentist, I have directly benefitted from the work of Dr. Misch over the years. His organization of fact-based, data-driven information focuses the ability to transfer knowledge in an outstanding manner. He has been a leader in education techniques and modalities and has changed the way much of continuing dental education is presented. ... Dr. Misch provides the expertise and information for dentists which will allow a broader array of services to be available to more patients."

"In my opinion, when considering the magnitude of the principles and contributions of Dr. Greene Vardiman Black for operative dentistry, over 100 years ago, which still hold valid application to present-day dentistry, Dr. Carl Misch arguably has contributed to and

achieved a parallel degree of advancement for the art and science of implant dentistry," said Dr. Hagenbruch, who has himself taken classes taught by Dr. Misch. "He has truly served as a pioneer in advancing implant dentistry and has helped raise it to a much more predictable, precise, esthetic and longevity-positive treatment option."

Dr. Misch is author of more than 250 scientific articles. He also has written six books, with the latest, "Dental Implant Prosthetics," released in August. A prior book, "Contemporary Implant Dentistry," has been translated into nine languages, said Dr. Levine, who practices in Chicago. Dr. Levine is contributing to a seventh book on preventing and treating implant complications with Dr. Misch, Dr. Randolph Resnik, surgical director of the Misch Implant Institute, and the Misch Institute faculty.

Drs. Linda and Bryan Edgar, who have a family practice in Federal Way, Washington, also wrote nomination letters. Said their letter, "Bryan and I have been fortunate to be involved in ADA governance at many levels and have served as delegates for many years. I do not believe I have ever felt so strongly about any other candidate that Dr. Carl Misch deserves this ADA service award."

"We all have our own calling, and Dr. Misch has listened and exceeded his calling by a thousandfold," said Dr. George R. Zehak, secretary of the Chicago Dental Society, in nominating Dr. Misch.

Dr. Hagenbruch's own letter resounded Dr. Zehak's sentiment: "It has been my experience that rarely does someone come along so motivated, gifted and dedicated that, year after year, they can sustain an eagerness and a willingness to commit themselves to their life's work so remarkably. I certainly know of no one that meets and advances the art and science of dentistry any more successfully and effectively than Dr. Carl Misch."

Adds Dr. Levine, "Although Dr. Misch has a vast list of accomplishments, he remains humble and accessible to patients, students and staff."

Dr. Misch continues to lecture, teach and write, but on an adjusted basis. On Aug. 23, Dr. Norman presented Dr. Misch with the Distinguished Service Award at the International Congress of Oral Implantologists Summer Implant Prosthetic Symposium. Ordinarily, the award is presented at the ADA annual meeting. In deference to Dr. Misch's health preventing his travel to San Antonio, the award was presented early.

Said Dr. Levine, who has known Dr. Misch for nearly 40 years, "Dr. Misch got up and said, 'You know, in many ways it's fitting that this award comes to me at this time. My first award from the American Dental Association came when I was a student. My research was recognized and I was selected to represent the United States by the American Dental Association at an international research competition in Europe.' He said, 'It's only fitting that my last award also comes from the ADA.'"

As he continues his trajectory of innovation and general excellence in implantology, Dr. Misch's nominators asked him to pause and reflect with them on his brilliant, fruitful — and distinguished — career.

Nominator Dr. Susan Bordenave-Bishop, a private practice dentist in Peoria, Illinois, and a past ADA delegate for the 8th District, sums it up well: "Now is an excellent opportunity to return the huge favor that he has so selflessly imparted to patients and dentists alike." ■

ADA honors Dr. Ray Damazo's work with the Maasai

2014 Humanitarian to be recognized tomorrow

For nearly 20 years, Dr. Raymond S. Damazo's favorite dental office wasn't an office at all. Driving a Land Rover with portable dental equipment and a massive amount of supplies in tow, Dr. Damazo and his wife Gail traveled to nearly two-dozen remote villages in Kenya and other parts of Africa twice a year, staying in tourist lodges and providing free dental care and education to thousands of people in need.

In recognition of his years as a volunteer dentist and the many significant humanitarian contributions he has made since, the ADA has chosen Dr. Damazo as the 2014 ADA Humanitarian Award recipient.

Dr. Charles Norman, ADA president, will present Dr. Damazo with the ADA Humanitarian Award during the Opening General Session and Distinguished Speaker Series event tomorrow, beginning at 9 a.m. at the Alamodome.

Dr. Damazo will receive a \$5,000 donation to the dental charity/project of his choice and a bronze statue.

A dynamo at age 84, Dr. Damazo still spends a significant amount of time providing dental care at a clinic he established in Kenya in 2009. When ADA President Charles H. Norman called Dr. Damazo in December 2013 to let him know he'd been named the Humanitarian Award recipient, he had to leave a message and wait for a call back.

"It took me a few days to contact him because he was busy traveling in Africa, doing humanitarian work," said Dr. Norman.

During his years as a mobile dentist, Dr. Damazo's portable office included a dental chair, compressors, lights and all the gear needed for a modern dental operator, but also featured proximity to the stunning coastline of the Indian Ocean, the majestic African wildlife at the Maasai Mara National Reserve and the Maasai people, whose way of life has remained largely unchanged for centuries.

"I chose Kenya because there is a great need for dental care, but also because it is such a beautiful place," Dr. Damazo said in an interview from his winter home in southern California. "And, if the truth be told, I'm a cheapskate. I like to get my money's worth. I want to be productive. I know I can be my most productive when I am comfortable, so no matter what sacrifices I made to provide free dentistry to the people of Africa, I was happy to know I had a comfortable place to sleep, a nice meal and a good glass of wine at the end of the day."

Although Dr. Damazo was winding down from his practice in Bellevue, Washington, when he began his African adventures in 1987, signs of his calling had been evident since he was a young child.

One of 10 children born to Portuguese parents who emigrated from the Azores, Dr. Damazo remembers keenly that his mother would introduce him to her friends as "my son Ray, the dentist" when he was a young boy.

"It never occurred to us children not to live up to our parents' aspirations for us," he said. "We were poor. We worked hard. Our parents picked our careers for us at a very young age. I have a brother who is a physician, another who is a minister. I think we have one of everything in our family, except for an undertaker!"

As a child, Dr. Damazo enjoyed the privilege of checking out books from the New Bedford, Massachusetts, public library. His favorites — not surprisingly — were books that recounted the adventures of Dr. David Livingstone, the physician, missionary and African explorer.

"The thing that fascinated me most about Dr. Livingstone was that he went to Africa and provided medical help to those in need while indulging his sense of adventure."

Before embarking on his career in dentistry, Dr. Damazo majored in zoology, and seriously considered a career as a veterinarian. "I always had a love for animals and it was hard to choose between dentistry and veterinary medicine."

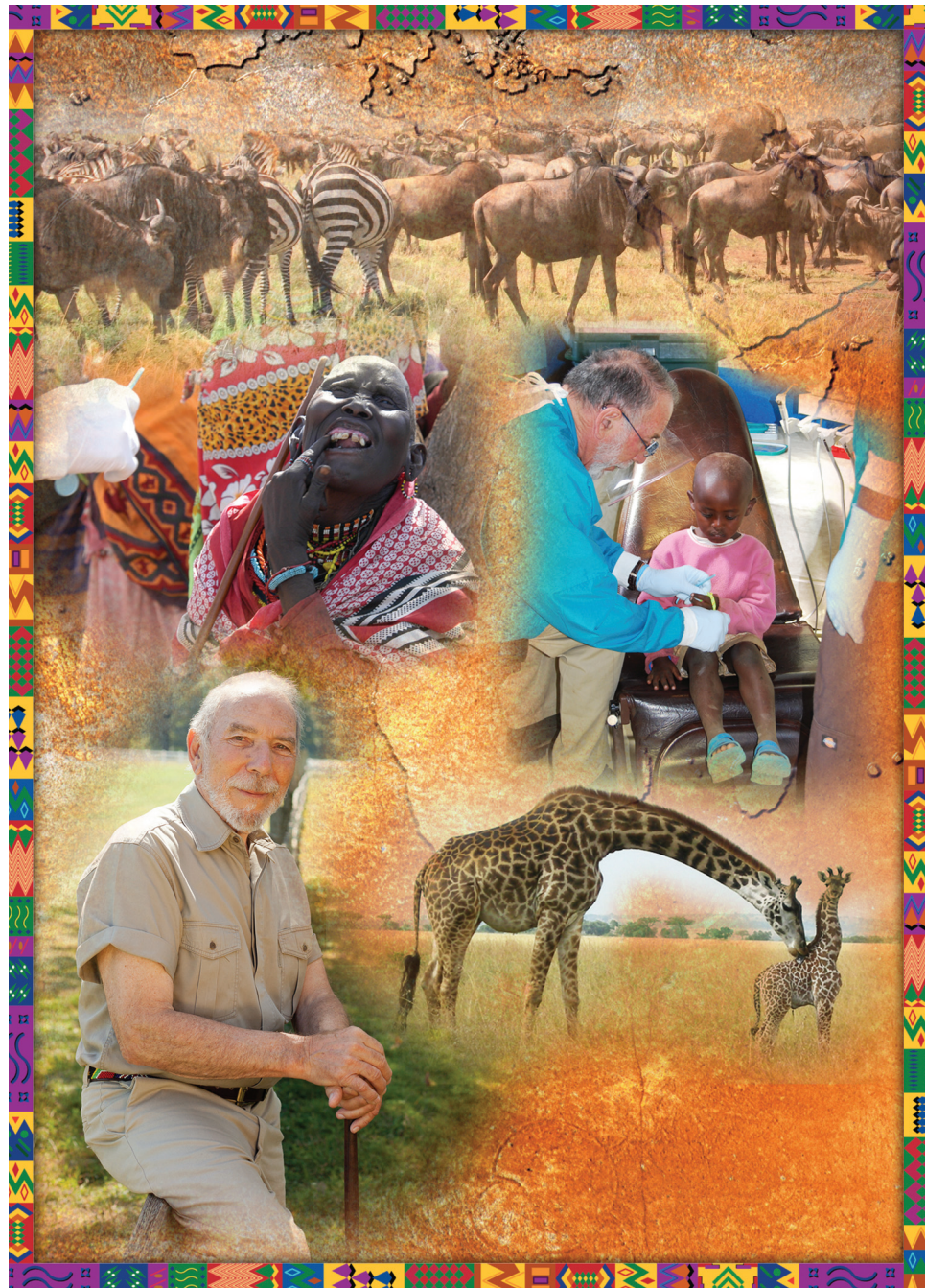
As a dentist, he had a thriving private practice in Frederick, Maryland, for 10 years and then in Bellevue from 1970-1995. He was active in organized dentistry, serving as president of the Frederick County Dental Society and in various offices for the King County Dental Society. He lectured on practice management for more than a decade.

In 1977, Dr. Damazo trained an American physician in emergency dental procedures in Brazil. The duo spent four months treating patients in remote areas of the Amazon.

About a decade later, his African adventure began. His experiences as a dentist and tourist in Kenya and beyond are detailed in his book, "Safari Dentist," which is available on Amazon.com.

"I wanted to write the book so an average person would enjoy and experience my patients, the dentistry, the animals and the travel," he said. "It's not specifically a story about dentistry or just for dentists. I wanted it to appeal to folks interested in adventure."

At the age of 78, after spending two decades serving as a mobile dentist, Dr. Damazo decided it was time to trade in the Land Rover for a brick-and-mortar clinic.

"I was getting older and I realized that the Maasai people near the Maasai Mara game reserve had a great need," said Dr. Damazo. "The area is 87 kilometers (about 54 miles) down a nightmarish dirt road from the nearest dentist. But it is also a beautiful spot. I wanted to do something permanent. And I wanted to choose a fantastic location to help recruit volunteer dentists."

He selected a site near the game reserve, where lions, leopards, cheetahs, elephants, rhinoceros and giraffes roam and more than 450 species of birds fill the skies. Here visitors can see zebra, Thomson's gazelle and wildebeest migrate to and from the Serengeti every year during the Great Migration.

The Maasai tribe leased a plot of land to Dr. Damazo's charity for \$1 a year for 33 years, and he and Gail funded and built the Maasai Dental Clinic at Siana Springs through their nonprofit charity, World Health Dental Organization.

The modern, three-chair dental clinic includes an apartment upstairs to house volunteer dentists and two en suite bedrooms to house auxiliaries. It opened in 2009.

"The Maasai lifestyle is still very unchanged. Dentists who volunteer here get a total immersion in Maasai culture — the real Africa," Dr. Damazo said.

For the first two years, Dr. Damazo ran the clinic and recruited more than 60 volunteer dentists to serve 2- or 4-week rotations with the five Maasai staff members.

"I built the clinic with the idea that I would gift it to a university with an interest in global health care," he said. And in 2010, he gifted the clinic, debt free, to Loma Linda University

School of Dentistry for use as a global teaching center that will serve an estimated 100,000 Maasai patients during the next three decades.

Dr. Damazo said he was surprised and happy to hear he had received the ADA Humanitarian Award. He also received a congratulatory call from the 2013 Humanitarian Award recipient and fellow Washington state dental colleague Dr. Sherwin Shinn.

Dr. Damazo said the inspiration for his humanitarian work is simple.

"I like to be active and productive. I like to help and do things that matter. I want my three daughters to know that the years between 60 and 80 can be your most productive years. You can do so much. My family genetics has programmed me this way. My mother always said, 'You retire when they close the lid.'"

Dr. Damazo also credits his accomplishments as a humanitarian to his wife Gail.

"We've been together for 20 years," he said. "She loves travel, she is very practical and she has been a tremendous helpmate for the whole thing. We have loved every minute of it."

The ADA Humanitarian Award was launched in 2007 and is the Association's highest humanitarian honor. This prestigious award recognizes dentist members who have distinguished themselves by outstanding, unselfish leadership and at least a 10-year commitment to their fellow human beings in the field of dentistry, through the dedication of extraordinary time and professional skills to improve the oral health of underserved populations in the United States and abroad.

New ADA standards committee courses highlight teledentistry, disaster victim identification

The ADA Standards Committee on Dental Informatics will offer two new courses on teledentistry and identifying disaster victims.

As part of the CE Live offerings, both courses will take place on the exhibit floor in the Interoperability Dicom, hall A/B, Booth 2327.

Exchanging Digital Images and EHR Data for Patient Treatment will demonstrate the transmission of a Health Insurance Portability and Accountability Act compliant email with an attached patient dental image through a third-party health information service provider, which will provide encryption and will meet all necessary HIPAA requirements. The

course is free and worth one hour of continuing education credit.

The course reflects the Standards Department's response to a House of Delegates request to standardize the secure exchange of patient data between parties.

"It's what the House of Delegates requested on behalf of practicing members that face this problem every day in their real-world practice," said Dr. Gregory Zeller, SCDI chair. "It's not theoretical. It's, 'How do I handle this problem right now that I have?' It's using products that people have in their offices right now, their imaging systems and their email and their electronic health re-

ords, real-world systems that people have."

There are several opportunities to attend, including:

- Thursday, 11:30 a.m.-12:30 p.m. (course 5360) and 3-4 p.m. (course 5361);
- Friday, 10:30-11:30 a.m. (course 6360) and 2-3 p.m. (course 6361);
- Saturday, 10:30-11:30 a.m. (course 7360).

Identifying Disaster Victims: Standards for Electronic Dental Patient Data also is a free course and is worth two hours of continuing education credit. A panel of leading experts will instruct participants on the collection and coding of forensic dental data for exchange between national and international agencies

and how standards help overcome the difficulty of exchanging this information.

The course is planned as follows:

- Thursday, 12:30-2:30 p.m. (course 5310) and 4-6 p.m. (course 5311);
- Friday, 11:30 a.m.-1:30 p.m. (course 6310) and 3-5 p.m. (course 6311);
- Saturday, 11:30 a.m.-1:30 p.m. (course 7310).

"We've spent a lot of time working with the National Institute of Standards and Technology as well as national and international law enforcement groups like the FBI and Interpol, governments and forensic identification professional associations," Dr. Zeller said. "So everybody's come together to develop a way to exchange dental information on disaster victims and missing persons that need identification in a way that we can do it electronically and in a way that can be analyzed electronically to try to get matches." ■

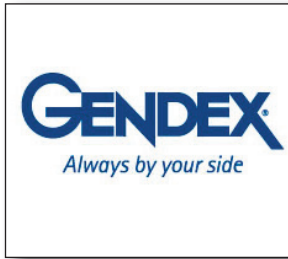

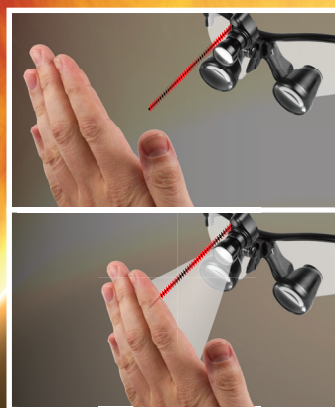
