

See the new ADA Benefit Plan Analyzer in the Member Center

The Benefit Plan Analyzer is available on the Association's Center for Professional Success website at Success.ADA.org/apps. Through an online system, dentists can run a series of "what if" scenarios that will show them the financial impact to their practice. The analyzer also assesses the office's capacity to



absorb a new stream of patients. After inputting information, the dentist receives a plan score from 1-100, with 100 being the best. The baseline is cash-paying patients, and the closer to 100 a plan is rated, the better financial incentive for the dentist.

Dentists can purchase the ADA Benefit Plan Analyzer for one month or as an

Dental corps officers showcase education, research, treatment at Fort Sam Houston

Bringing a spirit of cooperation to postgraduate dental education, treatment and research, officers from the U.S. Army, Navy and Air Force Dental Corps welcomed leaders from the ADA and the Canadian Dental Association to Fort Sam Houston yesterday for a tour of some of the fort's key dental operations.

ADA President Charles Norman and his wife Sharon, President-elect Maxine Feinberg and her husband John Wynne, Executive Director Kathleen O'Loughlin and her husband Stephen, and Dr. Marshall Gallant of the VA Medical Center in Orlando, Fla., joined several leaders from the Canadian Dental Association and the Canadian Forces Dental Services for the four-hour tour on the day before the opening of ADA 2014 — America's Dental Meeting.

Col. Arthur C. Scott, chief, Office of the Dental Corps, led the delegation welcoming the visitors at Brooke Army Medical Center. The group heard presentations by representatives of each branch's postgraduate education on the array of postgraduate dental education and continuing education programs they offer.

Then they proceeded to the BAMC Oral and Maxillofacial Surgery Dental Clinic, where staff led them through the reception and patient treatment areas that log some 19,000 patient visits a year. They also toured two fully equipped operating and recovery rooms that are used for about 500 general anesthesia cases a year. Nancy Hansen, a certified clinical anaplastologist, showed them examples of craniofacial prostheses the clinic fabricates for wounded warriors.

Army, Air Force and Navy officers showcased some of the innovative research underway at the Institute for Surgical Research. Visitors learned about the USAF Dental Evaluation and Consultation Service and its role in materials evaluation, equipment evaluation, facility standards and design and infection control and safety. Other projects highlighted included development of antimicrobial peptides for use in chewing gum to

control caries, and studies on biofilm, drug delivery and bone regeneration. Several research projects involve cooperative work among military branches.

The group then headed to the Center for the Intrepid, a state-of-the-art rehabilitation center that provides physical therapy, behavioral medicine and prosthetics for wounded warriors. The center also offers specialized services like a gait lab, computer assisted rehabilitation environment and firearms training simulator. The center includes a special ADL (activities of daily living) apartment to provide patients with a real world environment to practice everyday-life skills and other occupational therapy services.

At the conclusion of the tour, Col. Scott presented an Army Dental Corps Medallion to Dr. Norman and to Dr. Gary MacDonald, CDA president. ■

ADA Seal appeal

about how products get the Seal, and emphasize that the Seal is not for sale. It’s not something that manufacturers can buy, but instead, needs to be earned based on the science supporting a product’s safety and effectiveness.”

Begun in 1930, the ADA Seal of Acceptance program created a mark of distinction that signals to consumers that dental products — toothpastes, mouthwashes, toothbrushes, etc. — do what they claim to do. The Seal is assurance that an independent scientific body — the ADA Council on Scientific Affairs — has evaluated a product’s safety and effectiveness, according to objective criteria.





CDEL, CODA to hold hearings tomorrow

The ADA Council on Dental Education and Licensure is hosting a hearing to seek comments on a request submitted by the Academy of Operative Dentistry to recognize operative dentistry as an interest area in general dentistry and the Commission on Dental Accreditation's proposed Accreditation Standards for Dental Therapy Education Programs.

Separately, CODA is holding a hearing on proposed accreditation standards. Both hearings are tomorrow at the Marriott Rivercenter Grand Ballroom, Salon I, Level 3. CODA's hearing is from 10-11 a.m. and CDEL's hearing is from 11 a.m.-noon.

CDEL is seeking comments, due Oct. 20, on a request submitted by the AOD for ADA to recognize operative dentistry as an inter-

est area in general dentistry. Oral testimony and written comment must address the application's compliance with the ADA's Criteria for Recognition of Interest Areas in General Dentistry.

CDEL will consider AOD's application, the recommendation of its Recognition of Specialties and Interest Areas in General Dentistry Committee and all comments received at its April 30-May 1, 2015, meeting. The council will forward its recommendation to the 2015 ADA House of Delegates.

If approved, CODA is likely to consider a request from AOD to develop educational requirements and establish an accreditation program for advanced educational programs in operative dentistry.

Attendees are encouraged to print rel-

evant pages of the AOD application and the ADA Criteria and bring them to the open hearing.

No print documents will be provided. Documents are posted at ADA.org/en/education-careers/careers-in-dentistry/general-dentistry.

Those who do not provide comment at the open hearing regarding AOD's proposal, can submit comments to CDEL Director Karen Hart via email at hartk@ada.org or U.S. mail to the Council on Dental Education and Licensure, American Dental Association, 211 E. Chicago Ave., Chicago, IL 60611; or fax to 1-312-440-2915. All comments received will be posted on ADA.org.

The council, as the ADA agency with by-law responsibility to monitor accreditation

and education matters, is also seeking input from ADA members on CODA's proposed Accreditation Standards for Dental Therapy Education Programs. Comments provided to CDEL will be considered at its Nov. 6-7 meeting.

The council will then forward its recommendations to CODA by the Dec. 1 deadline.

CODA's separate hearing provides another opportunity for ADA members and other stakeholders to comment on the updated version of the proposed Accreditation Standards for Dental Therapy Education Programs, which have been under development since 2012. Written comments may also be submitted by Dec. 1 to CODA Director Sherin Tookss via email at tookss@ada.org or U.S. mail to the Commission on Dental Accreditation, American Dental Association, 211 E. Chicago Ave., Chicago, IL 60611.

The commission will again review the most recently revised standards for dental therapy and advanced dental education program and comments at its winter 2015 meeting.



Just such an opportunity is available Saturday from 8-9:30 a.m. in Room 214B in the Henry B. Gonzalez Convention Center. Five notable experts will present on the topic for the Introduce Scientific Advances Into Your Clinical Practice forum—which is also worth continuing education credits for attendees. A Q&A session will follow.

“We’re all different, from different trainings and different backgrounds,” said panelist John Gunsolley, D.D.S. “We’re obviously talking about the same subject, but from very different viewpoints.”

Dr. Gunsolley is director, Clinical Research Unit, Virginia Commonwealth University School of Dentistry. In debating the merits of genetic testing in oral medicine, he will join these colleagues:

- Scott Diehl, Ph.D., professor in oral biology and health informatics at Rutgers University.

- Thomas Hart, D.D.S., Ph.D., director of Craniofacial Population Sciences Research and a professor at the University of Illinois at Chicago in the Department of Periodontics. Dr. Hart is currently serving as vice chair of the ADA Council on Scientific Affairs, and will serve as chair in 2015.

- Ken Kornman, D.D.S., Ph.D., founder of Interleukin Genetics Inc.

- Peter Polverini, D.D.S., professor of oral and maxillofacial pathology in the Department of Periodontics and Oral Medicine, Division of Oral Pathology/Medicine/Radiology at the University of Michigan School of Dentistry.

Dr. Michael Glick, editor of The Journal of the American Dental Association, and Dr. Daniel Meyer, ADA senior vice president for Science and Professional Affairs, will host the forum. The pair seeks a compelling and useful discourse on the topic in light of concerns in medicine and dentistry about the role of genetic testing.

“The National Institutes of Health are put together cross-teams from all disciplines to look at genetic testing and its relevance,” Dr. Meyer said. “In the meantime, there have been some products that have been introduced into dentistry that are intended to

screen patients based on genetic testing.”

Added Dr. Glick, “In medicine, they call it personalized medicine. Here, we call it personalized dentistry or personalized dental care, meaning I can test you genetically and say, ‘You need a cleaning, not every six months but every 12 months or maybe every 24 months based on genetic testing.’ That’s what’s being done today, but we’re not too sure the science justifies those types of recommendations yet. That’s what this panel is all about.”

Though the assembled panelists are unlikely to see eye to eye on the topic, they will set out to provide a frame of reference for dentists to judge for themselves the current science and clinical applications for genetic testing in oral medicine.

Dr. Diehl suggested that the discussion is one not to miss. “The panel includes leading proponents of the alternative views of genetic testing, so we are very likely to witness a very stimulating and lively exchange,” he said.

The point Dr. Diehl himself hopes to make? “I believe there is great potential for genetic testing to be of substantial value for improving the diagnosis and treatment of oral and dental diseases,” he said. “However, with the exception of rare syndromes, we do not yet have sufficient data to support doing so at the present time. Studies of thousands or tens of thousands of patients assessed using standardized clinical diagnoses, as has been done for a number of major medical disorders such as cancers, heart disease and diabetes, are likely to be needed in order to adequately understand the complex and heterogeneous etiology of conditions such as

dental caries and periodontitis.”

Dr. Diehl also said that the implications for how genetic testing in oral medicine affects insurance will likely come up.

For his part, Dr. Polverini says that he is cautious about the use of these tests. He hopes the discussion’s value will be in “dispelling some myths about genetic testing and hopefully separate fact from fiction.”

“Given the participants, the discussion will be lively and informative,” Dr. Polverini said. “My personal view is there is a place for genetic testing, but one has to approach this new era of ‘personalized oral health care’ cautiously. There are clear examples where genetic testing has proven invaluable, i.e., predicting the onset of certain cancers and guiding targeted cancer therapy. However, with more complex diseases, including a number of common dental diseases, that involve multiple genes and gene interactions, the value of genetic testing is less obvious.

“Nonetheless, it is an exciting area that over time will prove to be part of the dental practitioner diagnostic and therapeutic tool box.”

Dr. Gunsolley agrees that there may prove to be applications related to oral cancers, but he’s not so certain about therapeutic applications for other dental diseases. “I think that the main applications are going to be in cancer-orientated areas,” he said. “For more chronic diseases, like periodontal disease and

caries, I don’t think there’s utility down the road. That’s my hypothesis.”

Dr. Kornman, whose company Interleukin has a genetic test for periodontal disease on the market, says the tests are indeed valuable to dentists. “Genetic information has several clear places in oral medicine,” he said. “It is still at an early phase of use, but it’s pretty clear as to where it’s going.

“It’s possible today with genetic information that’s available to identify patients who are at increased risk for severe periodontitis and use early preventive care to hopefully delay, slow down and ideally prevent completely those patients from getting severe periodontitis,” he said.

But Dr. Hart would like to see heartier science behind the use of genetic testing in oral medicine. “While the FDA has begun to regulate some of these tests, the vast majority are not in fact regulated for clinical validity or clinical utility,” he said. “It is important for clinicians and patients to understand the difference between different types of genetic tests so that they are aware of what tests can and cannot do. This discussion is overdue, but is complicated because most dentists receive relatively little formal education in human genetics in dental school and much of our understanding of how genetics contribute to common complex diseases and the single nucleotide polymorphism tests behind these new tests has been developed in the last few years, after most of the dentists now practicing graduated. So they have not been formally educated in this area of genetics. This has created a lot of confusion.

“This discussion is a start in having a dialogue in the dental community regarding genetic testing, particularly for common complex traits such as periodontitis, and realistically discussing the potential and current limitations of such tests,” add Dr. Hart.

The free discussion (tickets required), CE course 7365, is open to dentists, educators, researchers, industry representatives, dental hygienists and dental assistants, who earn 1.5 hours of CE credits for attending.

The open forum, Introduce Scientific Advances Into Your Clinical Practice, is sponsored by the ADA Council on Scientific Affairs and The Journal of the American Dental Association with grant support from The Task Force on Design and Analysis. ■

Dr. Robert Weyant earns inaugural ADA/AADR EBD Faculty Award

San Antonio—The ADA and American Association for Dental Research awarded the ADA/AADR Evidence-Based Dentistry Faculty Award, a new joint honor, to longtime evidence-based dentistry advocate Dr. Robert Weyant Wednesday at the AADR’s Fall Focused Symposium, which preceded ADA 2014.

“I am deeply honored to receive this award. To be recognized by my peers and colleagues is humbling,” Dr. Weyant said.

The award acknowledges a dental faculty member who has made significant contributions to implement and advance evidence-based dentistry. As the recipient, Dr. Weyant received a \$1,000 award.

Dr. Weyant is a professor and associate dean for Dental Public Health and Community Outreach at the University of Pittsburgh School of Dental Medicine. He also is a longtime lecturer at the ADA Evidence-Based Dentistry Champion Conference, held annually at ADA Headquarters.

The inaugural ADA/AADR Evidence-Based Dentistry Faculty Award is an important honor to introduce to EBD, Dr. Weyant said.

“This award brings attention to the area of evidence-based dentistry, an area that I am strongly committed to seeing expand in scope within dental schools and in clinical practice,” he said. “By acknowledging faculty who support the teaching and research associated

with EBD, I believe that it will add to the visibility and importance placed on EBD in the dental school curriculum. Teaching EBD in dental schools is key to ensuring that the profession remains evidence-based into the future.”

Timothy A. DeRouen, Ph.D., AADR president, also considers the award an important one in dentistry, especially for strengthening the relationship between the co-creators.

“It signifies a collaboration between the ADA and the AADR—between practice and research,” Dr. DeRouen said. “It helps to solidify ties between the organizations, the ADA, whose primary focus is on practice and practitioners, and AADR, whose primary focus is on research in dentistry.”

Dr. DeRouen was part of the selection committee that selected Dr. Weyant as the award’s first recipient. “It’s clear that he’s been a leader in this area for some time,” Dr. DeRouen said. “He’s been involved in teaching others about principles of evidence-based research and evidence-based dentistry for some time, and has been a leader in the science of evidence-based dentistry as far as understanding what kind of evidence needs to be developed and understanding what kind of information is needed to convince practitioners that they need to rely on this evidence to change their practice, if that’s what’s called for.” ■
