

STUDY REVEALS ONLY ONE-THIRD OF DENTISTS ARE SMOKERS

One out of every three dentists has never smoked cigarettes in his life, one out of three has quit smoking and every third dentist still smokes, a national survey has revealed. These data were released by a Public Health

Service official who reported on a national survey to study the smoking behavior of dentists. Many recent studies have revealed a significant link between oral cancer and smoking. Several investigations have shown that the oral cancer death rate is about four times higher for cigarette smokers than non-smokers.

Dr. Daniel Horn of Bethesda, Md., director of the National Clearinghouse for Smoking and Health, said the survey showed that 34 per cent of the dentists never smoked cigarettes, 32 per cent are former cigarette smokers who quit smoking and 34 per cent still smoke. "This is a much better record than that for the general public. What is particularly encouraging is the high rate of giving up smoking among older dentists and the fact that so many of the young dentists have not taken up smoking. About one half of those under 30 years have never been cigarette smokers," he added. The survey was conducted last year by the National Opinion Research Center of the University of Illinois and covered a cross section of about 3,000 dentists throughout the nation. Polling was mostly by mail but telephone interviews were also conducted, Dr. Horn said.

Other findings of the survey revealed that:

-- 68 per cent of the dentists agreed that if patients want to stop smoking, it is the dentists' responsibility to help them accomplish this;

-- 68 per cent of the dentists declared that it is the dentists' responsibility to set a good example by not smoking cigarettes;

-- 56 per cent felt that it is the dentists' responsibility to attempt to convince his patients to stop smoking;

Miss Janna Olson Dies

Miss Janna Olson, official reporter for the ADA Board of Trustees and House of Delegates for 23 years until her retirement in 1962, died Dec. 10 in Napa, Calif. Miss Olson was 76 years old. A contribution to the American Fund for Dental Education has been made in Miss Olson's memory on behalf of the ADA officers, trustees and past presidents. Miss Olson is survived by a brother, David E., of Lincoln, Neb., and a sister, Mrs. Isabel C. Jack of Napa, Calif.

Council Comments On Medicaid Charges

The ADA Council on Dental Care Programs has expressed concern that dentists in California and Massachusetts have been unfairly stigmatized by the press which reported allegations that state Title XIX programs were abused by "profiteering" health professionals. Meeting Dec. 5-6 at ADA Headquarters, the Council noted that in California only one case was cited to support the charge of "submitting false claims." This case concerned a dentist who used a wrong procedure number and was overpaid \$60. In Massachusetts public charges of Medicaid abuses were directed against dentists without state agency officials allowing the Massachusetts Dental Association to investigate the allegations of "overpayments" to dentists. The Council said that in both states constituent societies offered to cooperate with state officials in the development of Title XIX programs but such offers were The Council emphasized declined. that were states to utilize dental service corporations for the administration of dental care phases of Medicaid, it was unlikely that there would be charges of "overservicing."

New Dental School At U. Of Illinois

The University of Illinois will begin construction of a new dental school building in Chicago in early spring. The new facility will permit doubling of the University's current dental enrollment and raising the number of freshmen to 130 when construction is completed in 1971. Total enrollment is expected to exceed 1,000 students by the 1980's when two subsequent building phases are completed, according to Dean Seymour H. Yale. Current enrollment in the College of Dentistry is 362. Total cost of the building project is estimated at \$10.4 million.

AFDE Seeks Lab Scholarship Funds

The American Fund for Dental Education expects to increase substantially the number of its dental laboratory technology scholarships, Bernard J. Beazley, chairman of the scholarship awards committee, said this month. One \$650 and 17 \$500 scholarships were awarded for the 1968-69 school year. Contributions to the Fund from the dental laboratory industry are being used to create new scholarships.

Applicants must be high school graduates. Scholarships may be for either the first or second year of study in dental laboratory technology. Dr. Mitchell was a past president of the National Dental Association and was a faculty member of Howard. Representing the ADA at the affair was Dr. Jerome J. Hiniker, ADA second vice-president.

Dr. Daniel Collins, of the University of California dental school in San Francisco, has been named by President Lyndon Johnson to the combined membership of the National Health Resources Advisory Committee and the National Advisory Committee on the Selection of Physicians, Dentists and Allied Specialists.

Apple Association Supporting NCDHW



90% Of Dentists In General Practice

Approximately 90 per cent of the 118,482 dentists in the United States are general practitioners according to the American Dental Association Directory. In addition to the 107,136 general practitioners there are 4,037 orthodontists, 2,209 oral surgeons, 1,038 pedodontists, 864 periodontists, 578 prosthodontists, 399 endodontists, 65 public health specialists and 50 oral pathologists. Some 1,176 other dentists are full-time dental school faculty members, 315 are engaged in state public dental health programs, 24 are dental association administrators, 39 are engaged in other professions or occupations and 910 are retired.

CDA Unit Urges Prepayment Plans Support

The Dental Service Committee of the Canadian Dental Association has urged the profession to take a "major initiative" in providing professionsponsored non-profit dental prepay-"These plans serve the ment plans. public interest by setting high standards of dental care which competing (commercial insurance and other) plans must match," the Committee declared. The existence of dental service corporations in all provinces would also facilitate the development of a framework for multi-province prepayment plans, the Committee stated. The Dental Services Committee will ask the CDA Board of Governors to approve the principle of prepayment for dental services and support the participation of profession-sponsored non-profit plans, with or without funding privileges, in the field of dental prepayment.

-- 53 per cent of the dentists polled stated dentists should be more active than they have been in speaking before lay groups about the hazards of cigarette smoking.

Only 10 per cent of the dentists polled voiced "no opinion" on the above four questions while the rest disagreed. Comparing these findings with results of a similar survey of physicians, it was found that both dentists and physicians feel strongly about setting a good example by not smoking, Dr. Horn said.
