

# 25.000 TO 35.000 EXPECTED TO ATTEND ADA-FDI SESSION IN NEW YORK

The Federation Dentaire Internationale will join with the American Dental Association in a joint annual session in New York in October. Estimates of attendance ranging from 25,000 to 35,000 indicate that the ses-

sion will be one of the largest international dental meetings ever held. Central theme will be "Dentistry International: Converging Path to Better Health" and a special logo has been prepared for the joint session. Headquarters hotel for the 57th an-



nual session of the FDI, to be held Oct. 11-17, will be the Park-Sheraton Hotel, and for the 110th ADA annual session, Oct. 12-16, will be the Waldorf-Astoria Hotel. The scientific program will be presented in the New York Coliseum.

In conjunction with the joint session, a number of international conferences have been scheduled. International Conference on Dental Plaque will be held Oct. 8 and will be supported by a grant from the Warner-Lambert Pharmaceutical Com-The tentative program calls for a number of international speakers

#### Cite ADA Retirement Plan Growth

The ADA Members Retirement (Keogh) Plan ranked 20th in net contributions for 1968 (its first year of operation) out of 1,823 group annuity contract holders of the Equitable Life Assurance Society, according to the ADA Council on Insurance. Equitable, underwriter and administrator of the ADA Keogh Program and second in pension reserves of all insurance companies, reported that participating dentists made the new ADA Plan one of the largest such plans in existence. Contributions received in 1968 exceeded \$3 million and they now total more than \$4.6 million.

### **AFDE Month Returns Break Records**

Dentist, hygienist and assistant contributions to the annual campaign conducted by the American Fund for Dental Education were surpassing all previous efforts during May, the opening month of the campaign, according to Dr. Gerald D. Timmons, AFDE Month He announced that as of chairman. May 27, a total of \$48,503 had been Dentists' contributions received. totaled \$44,731, a five per cent increase over the same period last year; dental hygienists' contributions totaled \$2,801, a 30 per cent increase, and dental assistants' contributions totaled \$971, a seven per cent increase.

#### Firm Refuses To Renew Malpractice Insurance

The Medical Protective Company of Fort Wayne, Ind., has announced to California dentists who hold the malpractice insurance policy issued by that company, that the company "is discontinuing the writing or renewing of policies in California," according to the ADA Council on Insurance. Last year, Medical Protective Company discontinued writing malpractice insurance for Florida dentists. When an insurance company discontinues writing coverage in any given state, all the insured persons in that state without regard to their own claims experience, then must seek another insurance company, the Council This is not always easy as not all insurance companies are willing to provide malpractice insurance, the Council stated. The Medical Protective Company is undoubtedly the insurance company providing the greatest number of dental malpractice insurance policies in the United States although the company does not do business in all states, the Council added.

### **Actions By ADA Judicial Council**

The ADA Judicial Council at its recent meeting adopted the following two official advisory opinions as interpretations of the <u>Principles of Ethics</u>: Official advisory opinion as an interpretation of Section 2 -- "A dentist who commits a deliberate 'irregularity' in billing in a third party reinbursement plan is in violation of Section 2."

Official advisory opinion as an interpretation of Section 12 -- "A dentist who includes on his cards, letterheads, bills, signs, etc., that he uses anesthesia, x-rays or does oral diagnosis is advertising in violation of Section 12."

The Judicial Council will submit a resolution to the 1969 ADA House of Delegates to add a new section to the Principles of Ethics as follows: "Professional corporations -- A dentist or group of dentists may practice as a professional corporation or professional association if permitted by state law, if they do not adopt a corporate name which is misleading or implies superiority. use of names of participating dentists as the name of corporations is preferable to other corporate designations. A dentist may not use "Professional Corporation, " "Professional Association," "P.C.," "P.A.," "Inc.," or similar corporate designations as a part of the name of a practice on cards, letterheads, office door signs and announcements, unless required by state law."

## **HOPE Seeks Bilingual Dental Personnel**

Project HOPE needs bilingual dental personnel for its 1969-70 mission to Tunis and for its expanding landbased programs in Nicaragua, Colombia and Ecuador. Openings will be available for a French speaking dental laboratory technician, dental hygienist and dental assistant to serve for 10 months in Tunis. Specialists in prosthodontics, oral diagnosis, periodontics, endodontics and pedodontics, who can speak French or Spanish and who can serve for two months as a rotator or for one year as coordinator, are being sought for Tunis and Latin America. Interested persons are asked to contact the Council on International Relations at ADA Headquarters.

#### **ADA Council Classifies Water Pik Device**

The ADA has announced recognition of the Water Pik Oral Irrigating Device manufactured by Aqua Tec Corporation as an "effective aid to the toothbrush in a program of good oral hygiene." In a statement published in the June issue of The ADA Journal, the ADA Council on Dental Materials and Devices classified the Water Pik as acceptable. The Council has authorized use of the following statement by the company: "The Water Pik Oral Irrigating Device is Acceptable for use as an effective aid to the toothbrush in a program of good oral hygiene to supplement the regular professional care required for good oral health." It was the initial Association evaluation of an oral irrigating device in the ADA Council on Dental Materials and Devices' expanding program.

The Council's evaluation program provides for classification of devices as acceptable, provisionally acceptable or as unacceptable. The Water Pik appliance being classified as acceptable will be listed in the <u>Guide to Dental Materials and Devices published biennial</u> by the Council. Products which have been evaluated by the Council are reconsidered periodically, and decisions are subject to change at any time that a substantial amount of new evidence becomes available.

In commenting on the classification of the Water Pik appliance, the Council stated that the irrigating device is listed by Underwriters Laboratories, Inc. "Evidence of the cleansing effectiveness and the operating safety of the Water Pik Irrigating Device under conditions of supervised and unsupervised use has been provided to the Council through published reports and additional information from unpublished clinical investigations."

### **MacDonald Gets WDS Executive Post**

Robert G. MacDonald has been appointed executive vice president of Washington Dental Service succeeding Robert E. Paulsen, Sr., who resigned to become affiliated with New York Blue Cross. Mr. MacDonald was former director of operations of WDS.
